RESOLVED That the Design Commission, having considered designs for the reconstruction of a portion of Playground 89, adjacent to Public School 166, West 89th Street between Amsterdam Avenue and Columbus Avenue, Manhattan, submitted by the Department of Parks & Recreation, represented by exhibits 469-K, L, M & N of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that the Parks Department will continue to study the design of the three curved benches.

The Commission thanks the community for its commitment to the future of this public space, M. Paul Friedberg for donating his time and expertise, and the Parks Department for working collaboratively with the original designer to develop a proposal that respects the current design while addressing the program and accessibility needs.

Preliminary approval is conditioned upon submission of this project for final review and approval before September 15, 2016.
