Your undersigned petitioners, residents along the line of Sedgwick avenue, respectfully request your Honorable Body for the passage of an ordinance directing the Commissioner of Public Works to cause gas-mains to be laid and lamp-posts erected, and street-lamps lighted on Sedgwick avenue, from the termination of the present line of gas lights at High Bridge to the termination of Sedgwick avenue in the Twenty-fourth Ward, as now laid out and graded by authority of the Department of Public Parks. We respectfully call your Honorable Body's attention to the present dangerous condition of said avenue and the surrounding property, by reason of its being unlighted. On a dark night it is dangerous for vehicles, as in several places there are high embankments at the side. The

avenue is also used as an approach to the station of the New York Central and Hudson River Railroad, and as such has become an important thoroughfare to those residing in the vicinity, and the safety of persons attending the night trains will be greatly enhanced by having this avenue lighted. If lighted, the police will also be assisted in their rounds in the arrest of vagrants and prevention of depredations. Within the past two or three years tramps have resorted to the line of the railroad and adjoining avenue, as its unlighted condition makes its vicinity a safe refuge from police interference for that class of persons. for that class of persons.

The Special Committee appointed at the meeting of July 23, 1878, "to confer with the counsel employed by this Board, as to the legal expenses incurred in the case of Recorder Hackett against the Board of Aldermen," respectfully

REPORT:

That they have obeyed the instructions contained in the resolution under which they were appointed, and the conference has resulted in arriving at conclusions which it is hoped will be acceptable to your Honorable Body and the people of the city.

The case of the People vs. W. R. Roberts and others, is still fresh in the recollection of our citizens. The peculiar circumstances under which the proceedings in the case were instituted; the vindictiveness that characterized the Recorder's charge to the Grand Jury which led to the indictment of the members of this Board; the vituperation to which the defendants were subjected from certain quarters, and the persistent, not to say unfair, attempts to prejudice the people of this city against them by parties interested in their conviction, are not yet forgotten. They were certainly such as to admonish the indicted members of the Board of the necessity of employing the most eminent counsel for their defense. The refusal of the Counsel to the Corporation, for reasons which he deemed valid, to appear for the accused, left them no alternative but to provide their own counsel.

The magnitude of the interests involved, although they did not appear to be understood or fully comprehended by the prosecution, or the aiders and abettors of the Recorder, were never lost sight of by the defendants. Two-thirds of the members of the Common Council were under indictment for an alleged petty offence, which, from the interpretation of the law given by the Recorder, if followed by conviction, would disqualify them from holding their offices. The law providing for filling vacancies in the Board of Aldermen vests that power in a majority of the Board. The vacancies, therefore, could not have been legally filled, as a majority would not remain after the conviction of those indicted. There would then be no city government. The taxes for this year could not be acceptanted, or provided; no election for State or municipal officers could be held, as there would be no means for canvassing the vot

representatives of the people of this city, in the city government, would reflect upon the constituencies of the indicted members, and as representatives of all parties in the Board—Tammany, Anti-Tammany, and Republican—were indicted, the Board, in choosing counsel to defend its members, felt that in so doing they were taking measures to defend the character of themselves and their constituents from unmerited reproach.

In view, therefore, of the gravity of the case and the magnitude of the interests involved, it was clearly the imperative duty of the indicted members of the Board, in order to prevent the consummation of the attempt made to degrade them and their constituents, and to prevent the evils certain to follow their conviction, to obtain the legal services of men of recognized ability. Messrs. David Dudley Field, John D. Townsend, A. J. Dittenhoefer, and Elihu Root were retained in the case, with the results known. The Hon. W. C. Barrett, before whom the case was tried, on a motion to quash the indictments, after an exhaustive review of the question at issue, in an able and logical decision, granted the motion, afformed, the legality of the acts of the Common Council for which two thirds of its members were affirmed the legality of the acts of the Common Council for which two-thirds of its members were indicted, and thereby saved the members of the city government and those whom they represented

indicted, and thereby saved the members of the city government and those whom they represented from the disgrace attempted to be put upon them.

The question of compensation of counsel has been duly considered by your Committee. The value of services such as were rendered by the gentlemen engaged for the defense cannot well be estimated; they can be measured only by the extent of the interests involved, which in this case were more important in their results, probably, than any case of a like character ever tried in the courts of this city. After a conference with counsel as to the amount of their respective claims, it was agreed to compensate them as follows:
