Resolved, That permission be and is hereby granted the Metropolitan Telephone and Telegraph Company, for terminating two guy wires on the roof of the building No. 9 Oak street (Fourth Precinct Station-house), provided that said company will take entire charge of said roof, and keep it in good repair, and will be also responsible for any claim for damage caused by such wires to the property of the Department, or that of any other person or persons. The said fixtures to remain thereon during the pleasure of the Board.

On reading and filing copy of resolution adopted by the Board of Estimate and Apportionment, September 2, 1892, it was

Resolved, That the Board of Police hereby consents to the transfer by the Board of Estimate and Apportionment of the sum of ten thousand dollars from the appropriation made to the Bureau of Elections for the year 1891, entitled "Election Expenses—Rent of Polling Places, etc.," which is in excess of the amount required for the purposes and objects thereof, to the appropriation made to the Health Department for the year 1892, under the head of "Hospital Fund, etc.," which is insufficient, to fit up and furnish the floating hospital of St. John's Guild as a hospital for cholera patients, and to pay the salaries of such Physicians, Nurses, Attendants and other employees as may be required in connection therewith, and for the Ambulance Service for said hospital.

#### Bureau of Elections.

On reading and filing report of the Chief Clerk, it was  
Resolved, That the contract for supplying the Police Department with stationery and printing for election purposes, in accordance with the specifications therefor, be and is hereby awarded to Martin B. Brown, for the sum and price of eight thousand and forty-seven dollars and twenty-five cents, he being the lowest bidder. And that the President be and is hereby authorized to execute the said contract for and in behalf of the Board of Police on the approval of sureties by the Comptroller.

Resolved, That the proposal and estimate of Terrell & Vroom to furnish polling-booths in such number as may be required, and in accordance with plan attached to such proposal, for the sum of one hundred and twenty-three dollars each, be and is hereby accepted, and that the President be and is hereby authorized to execute the contract therefor in behalf of the Board of Police; the said buildings to be placed as the Board of Police may direct, and to be removed by Terrell & Vroom within forty-eight hours after election day; it being further understood that, if required by the Board of Police, the said Terrell & Vroom will store such booths and replace as many of the same as may be required for the purposes of the election in the year 1893, for the sum of one hundred dollars each; the Counsel to the Corporation to be requested to prepare the form of such contract.

Resolved, That the proposal of C. F. Hodsdon, to furnish the Board of Police with two thousand to ding ballot-booths for the sum of six dollars and twenty-five cents each, be and is hereby accepted, the said booths to be made with North Carolina pine frames and canvas panels, and in all respects equal in material and workmanship to those heretofore furnished to the Police Department by the said C. F. Hodsdon, in the year 1890; the said C. F. Hodsdon to give a bond in the sum of five thousand dollars, with two sureties, for the faithful performance of the work and to keep said booths in repair for one year, provided they shall be properly handled and stored; the said C. F. Hodsdon not to be liable for any loss by fire to such booths after their delivery to the Police Department; the Counsel to the Corporation to be requested to prepare the contract and form of bond, and that the President be and is hereby authorized to execute such contract for and in behalf of the Board of Police.

Resolved, That the opinion of the Counsel to the Corporation be and is hereby respectfully requested upon the following:

- 1st. The power of the Board of Police to fill vacancies occurring in the office of Inspector of Election, Poll Clerk and Ballot Clerk.
  - 2d. The form of official ballots for candidates for office, and the order in which the same shall be printed.
  - 3d. The form of ballots for constitutional amendments.
  - 4th. Shall the fac-simile of the signature of the President of the Board of Police be printed with the indorsement on the back of each ballot, or that of the Chief Clerk?
  - 5th. The whole number of ballot-boxes, which will be required for receiving ballots and stubs in each polling place.

Resolved, That, under the power conferred by law upon the Health Department, the following additional amendment of the Sanitary Code for the security of life and health be and the same is hereby adopted, and declared to form a portion of the Sanitary Code:

Resolved, That section 141 of the Sanitary Code be and is hereby amended so as to read as follows:

Sec. 141. That no master, charterer, owner, part owner or consignee of any vessel, or any other person, shall bring to any dock, pier, wharf or building within one thousand feet thereof, in said city, or unload at any dock, building or pier therein, or have on storage in the built-up portions of said city any skins, hides, rags, or similar articles or materials, having been brought from any foreign country, or any infected place, or from any points south of Norfolk, Virginia, without or otherwise than according to written permit so to do from this Department; and no person shall sell, exchange, remove or in any way make exposure of any straw, bedding, or other articles used by immigrants upon any vessel bringing immigrants to this port, until it has been adequately and properly cleansed or disinfected; and all straw, bedding or other articles that have been exposed on any vessel to contagion or infection of any contagious disease, or have been or are liable to communicate such disease, shall be destroyed by fire on said vessel.

#### TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property who shall also be the owners of a majority of the property in frontage on the line of the proposed improvement.

The Commissioner of Public Works desires to give the following explanation of the operation of this act:

When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
