## Population Demographics Report

FY21 Q4 (April 1 – June 30, 2021)

Pursuant to Local Law 88 of 2015, the Department is required to submit a report each quarter containing information related to the population of incarcerated individuals in city jails for the preceding quarter. Such quarterly report shall include information based on the number of admissions during the reporting period, the average daily population, and the percentage of the average daily population for each category.
