




I. Population Change: DOC Population by Custody Status

Total DOC Population by Custody Status, 4/17/2021 - 4/23/2021










Number and Percent of Patients with Confirmed COVID-19 April 17 – April 23, 2021


Number of Currently Incarcerated Patients with Confirmed COVID-19 March 17, 2020 - April 23, 2021



■ Likely Exposed but Asymptomatic Housing ■ Confirmed COVID-19 or Symptomatic Housing














