#### BOARD OF ELECTRICAL CONTROL.

Minutes of a meeting of the Board of Electrical Control, held at the office of the Mayor, in the City of New York, on Tuesday, July 18, 1893, at 10½ o'clock A.M.

Present—Mayor Thomas F. Gilroy, President; Commissioners Jacob Hess and Theodore Moss.

The minutes of the last meeting were read and approved.

The Engineer reported as follows:

NEW YORK, July 18, 1893.

To the Honorable the Commissioners of the Board of Electrical Control:

GENTLEMEN—I have to report the completion of subways during this season, as ordered by the Board, and suggest that the usual ninety days' notice be sent to companies owning poles and wires for the removal of said poles and wires along the lines of subways:

For Electric Light and Power Service.

Forty-second street, from Eighth avenue to North River.

Avenue B, from Houston to Seventh street.

State street, east side, from southeast corner of Bowling Green to southeast corner of Pearl street.

In removing the above the Inspectors have attended to 153 complaints and the various companies have attended to 307 complaints of the 704 complaints reported.

The Board considered various complaints against companies for violations of rules of the Board and, on motion of his Honor the Mayor, adopted the following resolutions:

Resolved, That the Board of Electrical Control remove, without further notice, wires and fixtures of the Thomson-Houston Electric Company of New York, as follows:

Wires strung from the Union Square Theatre to private lamp-posts in front (Complaint 5882).

Arc lamps erected in front of No. 666 Third avenue without a permit (Complaint 5883).

Circuit on Third avenue from Thirty-seventh to Thirty-eighth street connecting with lamp in front of No. 574 Third avenue (Complaint 5884); and

Arc lamp in front of No. 1108 Third avenue temporarily erected for election purposes, permit for which has expired by its own limitation (Complaint 6102).

Resolved, That a low and dangerous loop crossing Fulton street, also Nassau street, from the city lamp on the northeast corner of Fulton and Nassau streets to buildings on west side of Nassau street between John and Fulton streets, belonging to United Electric Light and Power Company

(Complaint 5940), be immediately removed.

Resolved, That useless loops opposite No. 237 West street and Nos. 16 and 18 Park place and dangerous loop in front of No. 305 West street (Complaint 6086), and overhead loops in Nassau

street between John and Fulton streets that are over the limit (Complaint 6095), belonging to the Brush Electric Illuminating Company, be immediately removed.

Resolved, That dangerous pole on east side of railroad crossing One Hundred and Thirty-eighth street, belonging to North River Electric-light Company (Complaint No. 6111), be immediately removed.

Resolved, That Complaint No. 5994, in reference to dangerous pole of the Metropolitan Telephone and Telegraph Company, on First avenue, between Thirty-ninth and Fortieth streets, be referred to that company.

be referred to that company.

Resolved, That Complaint No. 6110, in reference to loop of Harlem Lighting Company, strung over roofs from No. 334 East Seventy-ninth street to No. 1511 First avenue, be referred to

that company.

His Honor the Mayor stated that he understood the Secretary to report that a number of dead poles up in violation of the rules of the Board ought to be taken down, but inasmuch as the companies owning them, or claiming to own them, are involved in litigation by which they are enjoined from their removal, it seemed as if the City authorities would have to remove them.

Commissioner Moss stated that there were probably about 700 poles and that they were located between the Harlem river and Yonkers.

His Honor further stated that he thought the Board should take down the poles and moved

His Honor further stated that he thought the Board should take down the poles and moved the following resolution:

Resolved, That the Secretary of this Board be authorized to see that these poles are removed without expense to the City.

Which resolution was unanimously adopted.

The Mayor—I have a communication before me to the effect that the electric-light subway which was ordered to be built on First avenue some months ago, from Twenty-third to Twenty-fourth street, for the benefit of the then East River Company, now the Thomson-Houston Company has been completed; that the Thomson-Houston Company was notified on the 6th of this month of such completion and furnished with blue prints showing the measurements to manholes. They have also been requested to comply with the requirements of the Law of 1892, which compels them to furnish a bond to the Subway Company for rent; they have not made the first attempt to occupy the subway or even made application for permission to do so; they have not made application for the construction of a subsidiary subway which would extend to their power-house in Twenty-fourth street from First avenue.

The Board of Street Opening and Improvement met at the Mayor's office on Friday, July 21, 1893, at 11 o'clock A. M., pursuant to notice.

The Secretary presented and read the following report, relating to the closing of Hall place.

BOARD OF STREET OPENING AND IMPROVEMENT.

To the Board of Street Opening and Improvement of the City of New York:

SIRS—I have to report that on the 30th day of June, 1893, at the office of the Clerk of the Board of Aldermen, at the City Hall, in the City of New York, I have caused to be delivered to the Clerk of said Board and left with him copies of resolutions adopted by this Board on the 30th day of June, 1893, copies of said resolutions being hereto annexed. They provide for the altering of the map or plan of the City of New York by closing and discontinuing Hall place, between Sixth and Seventh streets, in the Seventeenth Ward of the City of New York.

I do also report that I caused to be published in the CITY RECORD the notice required by law, a copy of which, together with the proof of the publication thereof, is hereto annexed.

Whereas, At a meeting of the Board of Street Opening and Improvement of the City of New York, held on June 30, 1893, the following resolutions were adopted by said Board:

Resolved, That the Board of Street Opening and Improvement of the City of New York, deeming it for the public interest so to do, propose to alter the map or plan of the City of New York by closing and discontinuing Hall place, between Sixth and Seventh streets, in the Seventeenth Ward of the City of New York, more particularly bounded and described as follows:

Beginning at a point in the northerly line of Sixth street, distant 100 feet easterly from the easterly line of Third avenue; thence northerly and parallel with said avenue, distance 181.75 feet, to the southerly line of Seventh street; thence easterly along said line, distance 50 feet; thence southerly, distance 181.75 feet, to the northerly line of Sixth street; thence westerly along said line, distance 50 feet, to the point or place of beginning.

Resolved, That notice be given that such proposed closing as aforesaid will be considered by this Board at a meeting of this Board, to be held at the Mayor's office on the 21st day of July next,

at 11 o'clock A. M.

Resolved, That such proposed action of this Board be laid before the Board of Aldermen of the City of New York, and that full notice of the same be published for ten days in the CITY

Resolved, That the Secretary of this Board be and is hereby directed to transmit to the Board of Aldermen a copy of the foregoing resolutions and to cause to be published the notice required by law.

Resolved, That the Board of Street Opening and Improvement of the City of New York, deeming it for the public interest to alter the map or plan of the City of New York, by closing and discontinuing Hall place, between Sixth and Seventh streets, in the Seventeenth Ward of the City of New York, does hereby alter the map or plan of the City of New York, so as to close and discontinue said street as aforesaid, and does hereby close and discontinue the same, as follows:

Beginning at a point in the northerly line of Sixth street, distant 100 feet easterly from the easterly line of Third avenue; thence northerly and parallel with said avenue, distance 181.75 feet, to the southerly, distance 181.75 feet, to the northerly line of Sixth street; thence westerly along said line, distance 50 feet; thence southerly, distance 181.75 feet, to the northerly line of Sixth street; thence westerly along said line, distance 50 feet, to the point or place of beginning.

DEAR SIR—I desire to be heard in reference to the proposed map of the Twenty-third Ward, known as section 3, especially in regard to the property of the Estate of John J. Crane which I

represent:

The particular matter to which I wish to call the attention of the Board is not a very serious one, but is of vital importance to my client. I refer to the proposed extension of Willow avenue from One Hundred and Thirty-eighth street to the Southern Boulevard, and I beg to call the attention of the Commissioners to the map as it now stands, and see what a serious hardship is to be suffered by the Crane estate, if this change is effected. It will be noted that we have an extensive frontage on the Boulevard from One Hundred and Thirty-eighth street to One Hundred and Fortieth street on the west side, and it is now proposed to deprive us of all this property, amounting to twenty-four thousand five hundred square feet, or eleven city lots. It is well known to the Board that in cases where there are no buildings, the area of assessment is restricted to one-half the block on the line of the street, and that no compensation whatever can be given to us for this loss, and not only is it the loss of the land, but the actual deprivation of large and valuable frontage property, and seriously affecting the value of our interior lots. I assume, of course, that the Board will not inflict so great a hardship upon any individual unless a public exigency demands it, and I respectfully submit that the present is not such a case. Willow avenue is a mere local street, running through the Morris Improvement Company's property, and merely goes to the Kills, which is of no not inflict so great a hardship upon any individual unless a public exigency demands it, and I respectfully submit that the present is not such a case. Willow avenue is a mere local street, running through the Morris Improvement Company's property, and merely goes to the Kills, which is of no importance. It is not a thoroughfare in any proper sense of the term; it needs no such north and south outlet as would be required in the avenues referred to in my argument, leading into St. Mary's Park, and which it is now proposed to abolish. In short, it is a mere local street for the benefit of local property; it has its full outlet in the great and wide thoroughfare of One Hundred and Thirty eighth street, and where there is no possible reason or excuse why this frontage property of Crane's should be taken, as the access to the Southern Boulevard is complete by way of One Hundred and Thirty-eighth street. There is another and further reason why this change should not be made, in the fact that the proceedings for the opening of Willow avenue have just been completed, and the report of the Commissioners confirmed, and the sewers all arranged in view of the present plan. If this extension had been made when the proceedings were taken for the opening of Willow avenue, a fair and equitable assessment could have been laid upon the whole property, and the Cranes would not be compelled to suffer so serious a loss; and it is clear that legal proceedings would have to be instituted, and a great expense which we ourselves would bear in opening this little piece of roadway through our land, and in addition to receiving no compensation whatever for all the property taken. Willow avenue, as now laid out, is a completed thoroughfare and I understand the contracts are already let for regulating and grading it. There seems to be no special reason why this change should be made, and I am convinced that the Board, upon an examination, will not inflict upon Mr. Crane so serious a damage as is suggested by this proposed change, but will l

I submit herewith a lithograph copy of the map as established under the law of 1884 by the Park Department, which is now the existing map affecting that special plot. I desire to be heard in regard to the question, and I assume that my proper course as to addressing myself is to your Board rather than to Commissioner Haffen, to whom the matter may possibly be referred.

I would also desire to call attention to the proposed modification of the map embraced within the area of One Hundred and Thirty-eighth street and One Hundred and Forty-first street, St. Ann's avenue and the Southern Boulevard.

The following report from the Commissioner of Street Improvements of the Twenty-third and Twenty-fourth Wards, relating to a petition for the opening and widening of Franklin avenue, was presented and read.

Hon. THOMAS F. GILROY, Chairman, Board of Street Opening and Improvement:

DEAR SIR—In reference to the petition of Charles J. Allen and others, asking for the opening and widening of Franklin avenue, between One Hundred and Sixty-eight and One Hundred and Sixty-ninth streets, I beg to say that the Board of Street Opening and Improvement on January 13, 1893, passed a resolution directing the Counsel to the Corporation to begin proceedings to acquire title to lands required for the opening of Franklin avenue from Third avenue to Crotona Park, and which includes the particular block to which the petition relates.

I however see no beneficial purpose to be accomplished by having Franklin avenue, north of One Hundred and Sixty-ninth street, widened, and I therefore respectfully ask your Board to rescind the resolution above mentioned and adopt a similar resolution, limiting for the present the proceedings for the acquisition of title to that part of Franklin avenue south of One Hundred and Sixty-ninth street (where the same has not been heretofore acquired), understanding that the same can be done without embarrassment of any kind. The map, which I submit with sketches, will help show the propriety of this suggestion. The widening of Franklin avenue to One Hundred and Sixty-ninth street will not bring it to an abrupt termination at that point. One Hundred and Sixty-ninth street, east of Franklin avenue, has been widened and will make a connecting link with Boston road, which promises to be one of the most important thoroughfares in that section. It is pertinent in this matter to mention that the present sewer being built in Franklin avenue is close to the sidewalk on the west side of the avenue, the plan for it being made with a view to the proposed widening of the avenue.

Technically describing Franklin avenue, I beg to say that that avenue was laid out 80 feet wide by the Board of Parks on the maps of the Hunt's Point and West Farms districts, and the final maps and profiles of the Twenty-third and Twenty-fourth Wards retain the said avenue, from Third avenue to East One Hundred and Sixty-ninth street, 80 feet wide, but reduce its width from East One Hundred and Sixty-ninth street to Crotona Park to 60 feet, widening the existing 50-foot road to feet on the west side.

Taking off to feet of the west of Franklin avenue north of One Hundred and Sixty-ninth street would for the present be of no practical value, and would entail an unnecessary expense upon the property-owners. If it were settled that Franklin avenue should run all the way through Crotona

Park, there might be sufficient justification for the widening of this part, but, inasmuch as Franklin avenue, as a practical thoroughfare, stops at Crotona Park, the necessity now for proceeding to widen it is not apparent. Franklin avenue widened from Third avenue to One Hundred and Sixty-ninth street and connecting with Boston road will be both useful and ornamental.

I have the honor to submit the (2) resolutions, one, rescinding resolution of January 13, 1893, and another directing the Counsel to the Corporation to take the necessary proceedings to acquire title for the opening of Franklin avenue, from Third avenue to East One Hundred and Sixty-ninth street.

The property-owners petition herein referred to is herewith returned.

Prior to laying out East One Hundred and Sixty-third street on the Final Maps and Profiles, East One Hundred and Sixty-second street was laid out by the property-owners from Prospect avenue to the same junction of Stebbins avenue and Westchester avenue, on a width of fifty feet. The petittioners propose to extend East One Hundred and Sixty-third street as a straight continuation to Stebbins avenue, and from there to follow Stebbins avenue to Westchester avenue, in place of cutting diagonally through the lots. This line I approve of. It has the advantage over the adopted line of an easier gradient, six per centum against 7.6 per centum. It runs through unimproved land, and will answer the purpose as well.
