DEPARTMENT OF DOCKS AND FERRIES.

New York, July 10, 1906.

The following communication was received, action being taken thereon as noted, to wit:

From the Comptroller (68567)—Transmitting, in connection with question as to ownership of property required by this department for improvement of water front in the vicinity of Fordham road and Harlem river, copy of a grant dated March 3, 1888, which antedates the omnibus grant to The City of New York of premises at the above location, and asking whether, in view of same, it would be advisable to amend the resolution of the Sinking Fund Commission, adopted June 20, 1906, authorizing this Department to offer \$17,000 for the purchase of private property required. Notified that the opinion of the Corporation Counsel advises that the only property which is vested in private interests is the area embraced inshore of the pier and bulkhead line established in 1857, and that the remaining portion of the land under water between the line of 1857 and the lines of 1890 is vested in the City by the blanket grant of 1888; that the question as to the validity of the grant, copy of which was sent to this Department, as above mentioned, is one which must be passed upon by the Corporation Counsel; that the Department of Taxes and Assessments has given the assessed valuation (apportioned) of the property which the City is called upon to acquire, and that the resolution of the Sinking Fund Commission should be so amended as to authorize this Department to make an offer to the owners based upon the apportioned valuation of the property which is vested in private owners.

Consent was granted by the Commissioner for the substitution of the Title Guaranty and Surety Company as surety in the place of H. P. Osterhoudt and W. H. Trainer on the proposal of F. B. Smith Contracting Company for laying a new granite pavement on sand foundation on Thirteenth avenue, between West Twenty-second and West Twenty-third streets, and on part of West Twenty-second street, between Eleventh and Thirteenth avenues, in the Borough of Manhattan, under Contract No. 1006.

1 (68355). Stating that Commissioners of Estimate and Assessment were appointed by order of the Supreme Court, bearing date June 8, 1906, in the matter of acquiring property at Thirty-eighth and Thirty-ninth streets, Brooklyn, for ferry purposes, and that he will notify this Department immediately upon the filing of their oaths of office. Filed.

2 (68374). Approving form of lease to the Joy Steamship Company of Pier (new) 28, and the bulkhead between Piers (new) 27 and (new) 28, East river. Filed; lease delivered to company for execution.

From Municipal Civil Service Commission (68581)—Submitting list of eligibles for appointment to the position of Deckhand. Harry A. Oak and Thomas L. Casey appointed at \$60 per month, to take effect upon assignment to work.
