



RESOLVED That the Design Commission, having considered designs for the construction of Gateway Park and the installation of streetscape improvements, Phase I, Van Wyck service road, 94th Avenue, 95th Avenue, 150th Street, Queens, submitted by the Economic Development Corporation, the Department of Parks & Recreation and the Department of Transportation, represented by exhibits 5121-AP, AQ, AR, AS, AT & AU of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that (1) the park accent lighting, DPR maintenance shed, and interpretive/signage elements in the playground and seating area as well as the streetscape design and signage proposal for the Air Train structure will be submitted as Phase II in October 2010; and (2) the straddle beam and the elevated structure will be painted, and supergraphics will be painted on (rather than applied to) the elevated structure (not the straddle beam). Commissioner Nielsen recused herself.
