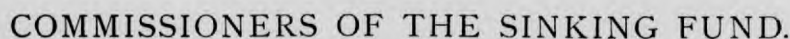

Street Cleaning.

Communication from the Pilot Commissioners, complaining that scows are not placed in the North and East rivers for the reception of ashes from steamers, and also that street cleaning material is dumped in the harbor on flood tide, was referred to the Committee on Street Cleaning.

Communication from the Common Council, being resolution requesting the cleaning of all crosswalks during inclement weather, was referred to the Committee on Street Cleaning.

Resolved, That the tugs "Wm. Parks" and "U. S. Grant," being of insufficient power for the use of the Bureau of Street Cleaning, be advertised for sale at public auction.

Commissioner MacLean offered the following:

Resolved, That all employees of the tug "U. S. Grant," except the Captain, be removed, their services being no longer required. Commissioner Voorhis moved to amend by including all the employees of the tug "U. S. Grant." Carried.

Resolved, That the appointments, removals, and assignment of the employees of the Street Cleaning Bureau, whose compensation is fixed at a per diem rate, be vested in the Chairman of the Street Cleaning Committee.

On recommendation of the Committee on Street Cleaning, it was
