# ARCHIVAL REVIEW BOARD REPORT JANUARY 2017 – JUNE 2018

New York City Municipal Archives

The Municipal Archives, a division of the Department of Records and Information Services (DORIS) acquires, preserves, and provides access to historical New York City government records. Established in 1952, the Archives holdings include more than 243,000 cubic feet(cf) and 185 terabytes (TB) of historical records, and responds to approximately 59,000 reference requests annually.

The Archival holdings begin with the New Amsterdam and Old Town records (circa 1645) and include Mayoral correspondence, City Agency records such as the Almshouse collection dating from 1759, more than 2 million photographs, and the World Trade Center September 11<sup>th</sup> collection. The Archives serves world-wide researchers in academic, non-profit, corporate, and government sectors, as well as individuals documenting family and community history.

Reports will be issued on a fiscal year basis. In order to move to that schedule, this transitional report covers 18 months.



The unit appraises and transfers records of historical value to the Municipal Archives from city government offices and, in rare instances, the public.



#### **Collections Survey**


Progress made since beginning the survey at Industry City in November 2017: 115,123 cubic feet out of an estimated 140,596 cubic feet.

#### Condition of Collections (assessments are based on level of organization, presence of acidic paper, mold, water or other environmental damage)



### ACCESSIONS AND APPRAISALS UNIT

### TRACKING AND REPORTING ON CORE FUNCTIONS RELATED TO ACQUIRING AND TRANSFERRING PHYSICAL AND LEGAL CUSTODY OF RECORDS



**Appraisal:** The process of identifying materials offered to an archives and the process of determining the length of time records should be retained, based on legal requirements and on their current and potential usefulness.

**Accession:** To take legal and physical custody of a group of records or other materials and to formally document their receipt.

**Reappraise:** The process of identifying materials that no longer merit preservation and that are candidates for deaccessioning.

**Deaccession:** A process by which an archives, museum, or library permanently removes accessioned materials from its holdings.

**Destruction:** A process by which an archives, museum, or library permanently removes accessioned materials from its holdings, by destroying them.



## **CONSERVATION & PRESERVATION**

The Municipal Archives Conservation Unit adheres to the American Institute for Conservation of Historic and Artistic Works Code of Ethics and Guidelines for Practice during all preservation and conservation activities. The goal of preservation is to establish and implement actions that anticipate, prevent, reduce, or halt the deterioration of library and archival materials.

The consistent implementation of preservation procedures and activities increases the life and usefulness of such records.



## CONSERVATION & PRESERVATION

## MUNICIPAL LIBRARY PRESERVATION PROJECT

**THE LIBRARY PRESERVATION PROJECT** is a collaborative effort to treat library materials that require preservation and/or conservation intervention. In the past eighteen months, 61 books, pamphlets, fold-outs, and brochures were treated with varying levels of intervention including humidification and flattening, spine repair, surface cleaning, mending, adhesive removal, binding, leather treatment, mold remediation, as well as re-housing and storage solutions.



### ARCHIVAL PRESERVATION AND PREVENTIVE CONSERVATION

- 48 items from the archival collections were treated, rehoused, and refiled.
- Historical vital records and liquor licenses are being repaired and stabilized to prepare for digitization.
- Objects in the Malcolm X District Attorney closed case file (*People vs. Hagan, Butler, and Johnson*) rehoused. •
- Various Mayoral photograph series are undergoing mold remediation and rehousing.

### ENVIRONMENTAL MONITORING AND MAINTENANCE

- Established and implemented a pest management documentation program. ٠
- Conducted a comprehensive stacks maintenance and cleaning program for collections at 31 Chambers St. ٠
- Presented DCAS with a proposal to overhaul the HVAC system for the basement level of 31 Chambers St. identifying sustainable preservation storage practices and fire suppression solutions.
- Responded to minor and mid-level disasters including water overflows, major dust, red rot, and mold.



THE COLLECTIONS MANAGEMENT UNIT implements the core stewardship standards for maintaining a records depository. The archivists are responsible for describing accessioned collections according to archival standards. In addition, they focus on increasing access to the collections through modern archival systems like ArchivesSpace, which will allow researches to search across collections. The following pages provide highlights of the projects and accomplishments from January 2017– June 2018.


#### 1. Map Survey

From December 2017 to June 2018, two archivists conducted a survey to establish intellectual control over cartographic holdings. The survey was conducted at 31 Chambers Street in Manhattan, as well as the agency's off-site facility in Industry City, Brooklyn. The review at Industry City was conducted with funding from the Local Government Records Management Improvement Fund (LGRMIF).

Over six months, 36,767 maps, blueprints, architectural plans, drawings, tracings, and photostats were identified, with details of their creators, subject, location, extent, and condition noted on spreadsheets. Where possible they were rehoused in flat files or boxes. Scope and content notes were created for each major collection, as well as for those items that could not be linked to specific accessions (see the Guide to Collections for more information). An inventory was created for items on shelves that could not be connected to an accession or were moved from their original locations. Grids were created to easily identify the locations of these collections, including those belonging to both known and unknown accessions.



2. Health Commissioner Correspondence Processing


The National Endowment for the Humanities awarded the Municipal Archives \$107,000 to process and catalog 830 cf of Health Commissioner records dating from 1929-1991. The project started in October 2017 and will extend through February 2019.

As of June, 2018, 460 cubic ft. have been processed and cataloged. In addition, three blog posts highlighting the collections have been published on www.archives.nyc.

#### 3. New York Police Department Intelligence Records, 1931-1987

The Bureau of Special Services and Investigations (later known as Special Intelligence Services and also as the Special Services Division) was a unit within the New York City Police Department's Intelligence Division. It operated from the 1950s to the mid-1980s. The unit grew out of the Red Squad which was charged with documenting and monitoring Communist activities. Around 1955 the unit became a bureau and expanded its investigations to include other groups considered to be potential security threats. In addition to local investigations, the Bureau collaborated with state and federal agencies in high-level investigations and provided security details for dignitaries and diplomats.

This collection consists of records created from 1931-1973 related to investigations of certain individuals and groups. Included in the collection are police officer reports, logs, rosters, intra and interagency correspondence, index cards summarizing known affiliations, photographs, and some audiovisual material. The collection includes personal effects such as address books, journals, photographs as well as flyers, posters, brochures, and a small amount of ephemera. As of June 2018, 72 cubic ft. were processed out of approximately 520 cf.



#### 4. Brooklyn Bridge Drawings

In 1969, Francis P. Valentine, an engineer with the Department of Transportation, identified more than 8,000 original drawings of the Brooklyn Bridge in a carpentry shop beneath the Williamsburg Bridge. The Whitney Museum of Art conserved and displayed 65 of the most striking drawings, and in 1976 the drawings were transferred to the Municipal Archives.

The collection contains original plans and drawings. It documents additions and alterations to the Brooklyn Bridge and its immediate surroundings, including the land and roads to access the structure. The collection reflects John Roebling's hope that the bridge would be part of a bigger plan for the cities of Brooklyn and New York.

In the past 18 months, a comprehensive catalog and finding aid were created for 8,206 drawings.





### PROCESSING PROJECTS

5. WNYC Film and Video

This collection consists of two sets of original media: film produced by WNYC, the city's municipal broadcasting system, from 1949 to 1981, and video dating from 1981 to 1996. The collection also includes B-roll, unedited footage, and materials duplicated from original magnetic, optical, and digital formats. Over the past two decades, grant funding led to the creation of and reformatting of some records. Most recently, archivists have worked to identify authority databases and normalized data according to industry standards. Work on this project is on-going. The team is working with Digital Programs to digitize the at-risk collections for preservation and access.


ArchivesSpace (AS) is an integral part of the Municipal Archives' digital platform. It is a webbased archives information management system that supports core functions in archival administration. It will serve as a search tool for public access to collection guides. A public launch is planned for the Spring of 2019.

After the initial implementation is complete, the archivists will:

- Manage new acquisitions including reliable data on the extent, formats, and history of the collections.
- Describe collections according to international industry standards, thereby broadening access.
- Report on and plan for on-going preservation needs.



The Unit is working to migrate legacy acquisition (accession) records to AS. This will provide a comprehensive database of the Archives' holdings. The archivists made progress in editing and transferring records dating from 1947-1967.






Municipal Building from 411 Pearl Street, rear elevation Park Row and Duane Streets, Eugene de Salignac, December 14, 1911.

SUBJECTS indicate the topical content or format characteristics of an item or group of materials being described. The subject record is designed to support simple or compound, hierarchical subjects. It can be applied at any level of description for accessions, resources, and digital objects.



AGENTS identify persons, families, or corporate bodies, and NYC government structures, that have a specified relationship to an archival resource or to an event. The agent record is also for managing relationships among names, and associates.





Finding aids are tools that facilitate discovery of information within a collection of records. Archivists have been working to standardize collection inventories from the agency's past 30 years of in-house classification systems. 

THE DIGITAL PROGRAMS UNIT manages the digital infrastructure and implements the policies and workflows for digitized and born digital materials. The unit consists of a team with advanced knowledge in digitization, digital archives, and digital forensics ensuring industry standards in the management, security, preservation, and accessibility of digital assets. The team also processes reproduction requests for archival and library material.


## DIGITAL PLATFORM

The DORIS Digital Platform will upgrade the agency's archival and information management standards and build capacity for the digital age. It will fulfill the agency's longterm strategic goals to increase agency oversight, accountability, and transparency for all operations; to expand outreach and access to all collections to a diverse range of customers, stakeholders and patrons; to modernize current operations and facilities; and to improve physical and intellectual control of records. Recommendations for an open-source environment and software were approved in FY18.








WNYC Transmitting Plant, Municipal Archives Collection, undated

### MEASURES AND METRICS

This year, the agency adopted elements of the Association of College and Research Libraries' (ACRL) Standardized Statistical Measures and Metrics for Public Services in Archival Repositories and Special Collection Libraries. 

The Archives tracks Subjects in order to monitor levels and patterns of collection use. The information will help prioritize preservation, conservation, processing and digitization initiatives.


