## **National PrepareAthon! Day**

- · keep an emergency kit based on each family member's needs
- have a non-perishable food supply on hand to last at least 3 days, including one gallon of water per person per day

Its most prestigious award, the National Dam Rehabilitation Project of the Year, recognizes unique projects that advance state-of-the-art designs in the field of dam safety and embody the professional engineering and construction standards that dam safety requires. It is presented annually to an organization's project that is judged to best represent those qualities. The reconstruction of Gilboa Dam is a tremendous example of the type of work that can be accomplished by the talented DEP staff in both the Bureau of Engineering, Design Construction (BEDC), and the operating bureaus. Despite a nine-month setback in the wake of Hurricane Irene, which inflicted historic damage upon the Catskills, staff completed the project in 2014, two years ahead of schedule. Work included the addition of approximately 234 million pounds of concrete, molded and dyed to resemble the original bluestone face of the dam, along with more than 500 massive spillway slabs and upgrades to the abutment walls that support the dam.

Several new features were added to the dam during its rehabilitation, including an inspection gallery inside the dam that runs its entire length. The gallery-which also includes instruments to constantly measure stress on the dam-



will allow engineers to visually inspect the inside and outside of the dam on a regular basis. The dam was also designed with 3-, 6- and 12-foot steps that dissipate the energy of water as it spills from the reservoir. The east and west abutment walls that support Gilboa Dam were also strengthened through the installation of 40 post-tensioned anchors, or steel cables that pull them tight to the bedrock.

While work on Gilboa Dam is complete, construction at the site will continue until approximately 2020. The rehabilitation is part of a \$400 million program to build and improve other facilities near Schoharie Reservoir. This includes a permanent release tunnel that will replace the temporary siphons, giving DEP the ability to release water from the Reservoir and into Schoharie Creek below. Work on the release works began this year. The remaining projects also include site restoration and rehabilitation work on the Shandaken Tunnel Intake Chamber. ## Ashokan Center Staff Training



On Monday, September 21, staff members from the Ashokan Center, a 374-acre Catskill Watershed educational retreat, spent a full day learning from DEP experts about the New York City water supply system. Organized by DEP's Office of Education as a way to enhance lessons and activities for visiting students and teachers, Ashokan Center educators, the Executive Director, and Ashokan Foundation officials, were treated to presentations by **David Warne**. BWS Assistant Commissioner, Watershed Protection Programs, and Adam Bosch, Director of Public Affairs for watershed communities. Topics included an overview of the water supply system, water quality monitoring, watershed protection, stream management, community partnerships, and ongoing Delaware Aqueduct repairs. Participants enjoyed an afternoon tour of the Ashokan Reservoir and presentations by Diane Galusha from the Catskill Watershed Corporation about the history of the water supply system, and Brent Gotsch from the Ashokan Watershed Stream Management Program. DEP has had a long relationship with Ashokan Center, including supporting school programs and assistance to relocate the campus to higher ground to protect the Esopus Creek floodplain.
