By the President—

Petition of the Central Tax-payers' Association of the City of New York, asking that a hearing be granted them before the Board in respect to the Provisional Estimates for the year 1879.

Which was, on motion of Alderman Sauer, referred to the Board of Estimate and Apportionment.

By Alderman Perley—

Petition of Charles Dunlap and others, asking that the permission given John Birmingham to erect a platform scale at the foot of Twenty-third street, East river, be repealed.

Whereupon he offered the following:
Resolved, That the resolution, approved October 14, 1876, giving permission to John Birmingham to place a platform scale at the foot of Twenty-third street, East river, be and it is hereby annulled, rescinded, and repealed, and the permission thereby given is hereby revoked.

Resolved, That all the highways in the City of New York north of One Hundred and Thirtieth street, known as boulevards or public drives, be and they are hereby exempted from the provisions of the ordinance entitled "An ordinance to amend sections 1 and 2 of chapter XXIX. of the Revised Ordinances of 1866, entitled 'Of driving horses in the city,'" passed June 2, 1876, and all other ordinances or parts of ordinances restricting or limiting the speed of horses; the above exception shall also apply to St. Nicholas avenue, north of One Hundred and Tenth street.

Alderman Pinckney moved to strike out all that portion of the resolution after the words "the speed of horses."

The President put the question whether the Board would agree with said motion.

Which was decided in the negative, on a division called by Alderman Reilly, viz.:

By Alderman Reilly—

Resolved, That his Honor the Mayor be and he is hereby respectfully requested to return to this Board a resolution adopted November 19, 1878, requesting information from the Department of Public Parks to report relative to the occupation of the Battery Park by the New York Elevated Railroad Company.

The President put the question whether the Board would agree with said resolution.

By Alderman Carroll—

Resolved, That permission be and the same is hereby given to M. H. Resolved, That the Commissioners of the Sinking Fund be and they are hereby authorized and empowered to grant permission to any person, or company, or association to lay mains and pipes, with all necessary connections, within the limits of any street, avenue or public place in the City of New York, for the purpose of furnishing steam to said city or any of its inhabitants, for heating, cooking, and all other purposes for which steam may be used; but before any such mains or pipes shall be laid, under any permission granted as aforesaid, the party receiving such permission shall agree with the said Commissioners of the Sinking Fund to pay over to the city, for the benefit of said Sinking Fund, such consideration as may be deemed just and equitable for such permission, together with such other stipulation as may be deemed necessary for the protection of the city.

The President put the question whether the Board would agree with said resolution.

Which was decided in the affirmative, on a division called by Alderman Foster, viz.:

Affirmative—The President, Aldermen Bennett, Carroll, Foster, Guntzer, Hall, Keenan, Lewis, Reilly, Sauer, Sheils, and Slevin—12.

Negative—Aldermen Biglin, Ehrhart, Gedney, Jacobus, Kiernan, Morris, Perley, and Pinckney—8.

By Alderman Jacobus—

Resolved, That his Honor the Mayor be and he is hereby respectfully requested to inform this Board what proceedings, if any, have been taken to compel the several railroad companies that are delinquent in the payment of licenses to run their cars to pay the same, as provided in the ordinances of the city.

The President put the question whether the Board would agree with said resolution.

Which was decided in the affirmative.

By the same—

AN ORDINANCE in relation to ashes and garbage and receptacles therefor.

Section 1. The owner or owners of any building occupied as a dwelling-house, situate upon any street or avenue in the City of New York, shall cause to be constructed in front of said building or buildings, below the grade of the sidewalk, and adjoining the curb or gutter, next to the roadway, a metal ashes and garbage receptacle, which shall consist of separate and distinct compartments for ashes and garbage, and be so constructed as to readily effect the dumping or removal of the respective materials, and enable compliance with all the requirements of the Sanitary Code. Said compartments shall contain movable metal vessels of sufficient capacity to receive the ashes and garbage deposited from each dwelling-house, and shall be connected, when necessary, by a trapped connection with the sewer, and the covers of said receptacles shall be so adjusted as to be locked at all times, except while filling or emptying the same; and said receptacles shall be subject to the approval of the Street Cleaning Department and Board of Health, and subject to the inspection and regulation of the Board of Health as far as relates to their cleanliness and the necessity of disinfecting them.

No person shall deposit any ashes in any receptacle other than that constructed for such purpose in front of the building occupied by such person, and no garbage shall be deposited by any person in any receptacle other than that constructed for such purpose in front of the building occupied by such person; and any person found using or interfering with said receptacles, excepting those legally entitled to the use of the same, shall be deemed guilty of a misdemeanor.

Sec. 2. On and after the 1st day of January, 1880, all parties who shall fail to comply with the provisions of this ordinance shall incur and be liable to a penalty of five dollars for each and every week such failure shall continue, to be recovered in an action before any justice of any of the district courts in the City of New York, on the complaint of the Mayor, Aldermen, and Commonalty of the City of New York.

Sec. 3. All ordinances or parts of ordinances inconsistent with this ordinance are hereby repealed.

Sec. 4. This ordinance shall take effect immediately.

Resolved, That permission be and the same is hereby given to William P. and A. M. Parsons to erect bay-window on building southwest corner of Sixty-fifth street and Lexington avenue, as shown on annexed diagram, the consent of the property-owners for fifty feet accompanying the resolution, the work to be done at their own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

The President put the question whether the Board would agree with said resolution.

Which was decided in the affirmative.

By Alderman Bennett—

Resolved, That permission be and the same is hereby given to George K. Otis to raise the grade of the sidewalk in front of his premises Nos. 86 and 88 Wooster street, consent for the same having been granted by the property holders fifty feet on each side of the said premises, the work to be done at his own expense, under the direction of the Commissioner of Public Works; such permission to continue only during the pleasure of the Common Council.

The word street or streets, whenever used in chapter 35 of the Revised Ordinances of the Mayor, Aldermen, and Commonalty of the City of New York, passed June 20, 1859, shall be deemed to include not only the carriageway and sidewalk, but every portion thereof, as established by law or ordinance, and also every porch, stoop, step, platform, stand, case, balustrade, post, rail, stairway, and every other structure, and every area, cellarway, and space, standing, placed, or being in or upon any portion of the ground which forms any such street or streets, as so established.

Alderman Pinckney offered the following as a substitute:

AN ORDINANCE to explain and amend chapter 35 of the Revised Ordinances of 1859.

The word street or streets, whenever used in chapter 35 of the Revised Ordinances of the Mayor, Aldermen, and Commonalty of the City of New York, passed June 20, 1859, shall be deemed to include only the carriageway and sidewalk outside of the stoop, area, or cellarway; but nothing herein contained shall be construed to authorize any obstruction or incumbrance on any sidewalk between said stoop, area, or cellar line and the curb thereof except for the reception and delivery of goods, as provided by ordinances of the Common Council; and provided that no stall or stand for the sale of meat, beef, mutton, veal, or lamb shall be established or kept within the distance of 300 yards from the markets known as Washington and West Washington Markets.

Whereupon Alderman Pinckney moved that the substitute and the original be laid over.

Alderman Reilly moved that the substitute be referred to the Committee on Streets.

Alderman Pinckney moved further to amend by referring both the original resolution and the substitute to the Committee on Streets.

The President put the question whether the Board would agree with the amendment of Alderman Pinckney.

Which was decided in the negative, on a division called by Alderman Keenan, viz.:

Affirmative—Aldermen Biglin, Ehrhart, Gedney, Jacobus, Kiernan, Morris, Perley, and Pinckney—8.

Negative—The President, Aldermen Bennett, Carroll, Foster, Guntzer, Keenan, Lewis, Reilly, Sauer, Sheils, and Slevin—11.

The President then put the question whether the Board would agree with the amendment of Alderman Reilly to refer Alderman Pinckney's substitute to the Committee on Streets.

Which was decided in the affirmative, on a division called by Alderman Keenan, viz.:

Negative—Aldermen Biglin, Ehrhart, Gedney, Jacobus, Kiernan, Morris, Perley, and Pinckney—8.

Alderman Pinckney offered the following as an amendment:

But nothing herein contained shall be construed so as to prohibit persons from exhibiting goods within the stoop lines, who shall obtain a permit from the Mayor, or for the reception and delivery of goods according to the ordinances of the city; and further provided, that no stall or stand shall be permitted upon any sidewalk so as to create a permanent structure or incumbrance.

Alderman Slevin, as an amendment to the amendment, moved to add the following:

Except outside the market limits, which is understood to be 300 yards from the market building. The President put the question whether the Board would agree with the amendment of Alderman Slevin.

Which was decided in the affirmative, viz.:

Affirmative—The President, Aldermen Bennett, Carroll, Foster, Guntzer, Hall, Keenan, Lewis, Reilly, Sauer, Sheils, and Slevin—12.

Negative—Aldermen Biglin, Ehrhart, Gedney, Jacobus, Kiernan, Morris, Perley, and Pinckney—8.

105. Thence to the left on an arc of circle of 57 53-100 feet radius for 108 63-100 feet to a point of compound curve.

106. Thence to the left on an arc of circle of 214 96-100 feet radius for 253 4-10 feet to a point of tangency.

107. Thence southerly on a tangent for 157 63-100 feet to a point of curve.

108. Thence to the right on an arc of circle of 433 23-100 feet radius for 377 16-100 feet to a point of reverse curve.

109. Thence to the left on an arc of circle of 136 5-10 feet radius for 206 23-100 feet.

110. Thence deflecting 90 deg. to the right southwesterly for 10 feet to a white marble monument with the number VI-65 inscribed thereon.

111. Thence southwesterly without deflection for 30 feet to another white marble monument with the numbers VI-38 inscribed thereon.
