

Whereupon, the following resolution, submitted by the Comptroller, was, on motion, adopted : Resolved, That the Comptroller, in accordance with subdivision 11 of section 6 of the act, chapter 574 of the Laws of 1871, be and hereby is directed to prepare and issue, as he may deem necessary to meet the requirements of the Dock Department, two hundred and three thousand five hundred and thirty dollars (\$203,530) Dock Bonds of the City of New York, for the purpose of raising moneys necessary to carry out the provisions of said act, relating to the Department of Docks, its powers and duties ; the said sum being the amount of the requisition by the Commis-sioners of Docks, dated September 5, 1879.

The following report of the Comptroller, on the petition of Thomas Wall, for a new deed properly and duly executed, of the premises on the east side of the Fifth avenue, 76 feet 8 inches north of Eighty-first street, No. 34 of Plot M, sale of May, 1866, was submitted :

In the matter of petition of Thomas Wall, that a new deed be executed by the Mayor, as well as the Clerk of the Common Council, for premises on east side of Fifth avenue, 76 feet 8 inches

north of Eighty-first street. These premises were sold at public auction, in May, 1866, and were struck down to Griffith Rowe, who paid the ten per cent. Griffith Rowe assigned the receipt of the ten per cent. to Thomas Wall, October 23, 1866. The name, Thomas Wall, in the original deed, is written on an erasure. Thomas Wall paid twenty per cent., and executed a mortgage for the balance of the considera-tion, which mortgage was paid off March 18, 1873. The full consideration having been paid, there can be no reason why a sufficient deed to convey the title of the city should not be delivered to the party entitled thereto, and it is recommended that the matter be referred to the Counsel to the Corporation, to prepare the necessary deed for execution. The Comptroller submitted the following report, in relation to real estate authorized, by resolu-tion of the Commissioners of the Sinking Fund, passed March 24, 1879, to be sold at public auction:

To the Commissioners of the Sinking Fund: To the Commissioners of the Sinking Fund: The Comptroller would report that all of the Corporation real estate, directed to be sold at auction, has been disposed of, except the Harlem Market property and the Hamilton square prop-erty, and that further sale was adjourned on September 25, 1879, to October 9, next. The action as to the Harlem Market property being still at issue, no valid title for such lots could now be given ; and an application has been made by the Eighth Regiment, National Guard, for a portion of the Hamilton square property, to be used by such regiment as an armory. The day fixed for the delivery of the deeds, by the terms of sale heretofore adopted, was July 12, 1879, and it will be necessary to establish another date for the delivery of the deeds on any sales which may be made on October 9. The Comptroller submitted (new) lease to "The Orphans' Home and Asylum of the Protestant Episcopal Church in New York," of the premises now occupied by said Home and Asylum, on the southwest corner of Forty-ninth street and Lexington avenue, for twenty-one years, from the date of the expiration of the present lease, May I, 1881, at an annual rent of one dollar; prepared and approved by the Counsel to the Corporation, which, on motion, was referred to the Mayor to be executed by him, in pursuance of the resolution of this Board, adopted July 23, 1879.

The Comptroller submitted the following report on the application of General John Newton, Colonel of Engineers, for cession to the United States of certain lands belonging to the City of New York, needed for the improvement of the Harlem river and Spuyten Duyvil creek, viz.: The application of Gen. John Newton is that the lands said to belong to the City of New York, needed for the improvement in Harlem river and Spuyten Duyvil creek, as proposed to be made by the general government, and exhibited in the tracings attached, shall be ceded to the United States without expense to the latter.

without expense to the latter. These premises are mostly included within the lines of the proposed channel of such river, as laid out by the United States Government, and the boundary lines of the channel as fixed by the Commissioners of the Central Park.

The application is made pursuant to chapter 147, Laws of 1876, and chapter 345, Laws of

The application is made pursuant to chapter 177 1879. By section 4 of chapter 345, Laws of 1879, the Commissioners of the Sinking Fund, or the Mayor, Aldermen, and Commonalty of the City of New York, are authorized to cede, grant, and convey to the United States, on such terms and for such consideration as may be agreed upon, all the estate, right, title, and interest of the City of New York, in and to any part of said land required for said channel. The whole of the land, the cession of which is requested from the City of New York, will be covered by the channel-way and could not be used for any practical purpose on the surface. No benefit could be derived therefrom except such as is connected with the water, which flows over it, and no loss could arise to the treasury, should the title be vested in the United States Government, while the opening of a new passage from the East to the North river would be of immense benefit to the lands fronting on such passageway, and effect a great saving of time to vessels which are engaged while the opening of a new passage from the past to the rooth river would be of immense benefit to the lands fronting on such passageway, and effect a great saving of time to vessels which are engaged in navigating from points on the Sound to the various landings on the North river. Some of the parcels included in the descriptions are on the Westchester side of the river and do not belong to the City of New York.



Society for Prevention of Cruelty to Children," and payable from the "Sinking Fund for Payment of Interest on the City Debt," the same being the amount of fine imposed upon and collected from James Ross by Court of Special Sessions for "selling liquor to minor;" the said fine, under provision of section 5, chapter 122, Laws of 1876, being payable to the said Society, but by error deposited to credit of the said Sinking Fund, March 5, 1879.

The petition of Peter Tostevin, for relief in the matter of purchase of premises No. 594 Grand street, at sale of real estate of the city of New York, April 24, 1879, was received, and, on motion, referred to the Comptroller.

A communication from D. P. Dey, and Thomas R. Sharp, Receiver of the Long Island R. R. Co., in relation to a proposed ferry from "Hunter's Point, L. I., South Sixth street and Jewell's wharf, Brooklyn; Pier 17, East river, New York City; and Communipaw and Pavonia avenues, Jersey City; for the transportation of railroad passengers and baggage from the termini of the Long Island R. R., Central R. R. of New Jersey, and the New York, Lake Erie, and Western R. R. Cos.," together with the reply of the Mayor to the same, were received, and, on motion, ordered on file.

The Comptroller submitted the following preamble and resolution in relation to transferring the surplus revenues of "The Sinking Fund for the Payment of the Interest on the City Debt" to "The Sinking Fund for the Redemption of the City Debt."
Whereas, Section 2 of chapter 383 of the Laws of 1878 provides, that the surplus revenues of the Sinking Fund for the Payment of Interest on the City Debt shall be transferred to the Sinking Fund for the Redemption of the City Debt, as follows, to wit:
"Sec. 2. The fund known as the 'Sinking Fund of the City of New York, for the payment of the interest accruing and to accrue upon the stocks of said city until the same be fully and finally redeemed, 'shall be continued, and after providing for the payment of the interest on the bonds and stocks of said city, now payable therefrom, as provided by law, shall form a fund, which shall be transferred after the year eighteen hundred and seventy-eight to the 'Sinking Fund for the Redemption of the City Debt,' and which transferred fund is hereby, in addition to the revenues and moneys aforesaid, pledged and appropriated to said last-mentioned Sinking Fund, until all the bonds and stocks of said city as aforesaid are fully redeemed and paid ;" therefore
Resolved, That, in pursuance of the provision of law contained in section 2 of chapter 383 of the Laws of 1878, warrants shall hereafter be drawn in favor of the City Debt, when the Comptroller shall deem it to be for the interest of the city to make such transfer.
