HOUSING PRESERVATION AND DEVELOPMENT

PUBLIC HEARINGS

PLEASE TAKE NOTICE that a public hearing will be held on September 19, 2023, at City Hall at 1:00 P.M., or as soon thereafter as the matter may be reached on the calendar, at which time and place those wishing to be heard will be given an opportunity to be heard concerning the proposed disposition of the real property identified below.

Pursuant to Section 576-a(2) of the Private Housing Finance Law, the Department of Housing Preservation and Development ("HPD") of the City of New York ("City") has proposed the sale of the following City-Owned property (collectively, "Disposition Area") in the Borough of Manhattan:

<u>Address</u> 244 East 106th Street Block/Lot 1655/ p/o 29 (Tentative New Lot 129)

The Disposition Area is a vacant portion of privately-owned Lot 29. The City previously conveyed the entirety of Lot 29 (formerly Lot 29 and Lot 128) to a housing development company for a rehabilitation project, pursuant to accelerated UDAAP approved by the City Council on May 16, 1995 (Resolution No. 1009) and by the Mayor on May 25, 1995 (Calendar No. 58). Rehabilitation was completed for the existing building, but the vacant portion remained underutilized. HPD will re-acquire and dispose of the Disposition Area to facilitate the proposed project.

Under the Supportive Housing Loan Program, HPD funds the rehabilitation or new construction of buildings which provide supportive housing for the homeless, people with special needs, and other persons of low income. HPD works with the Department of Homeless Services, the Department of Health and Mental Hygiene, the Human Resources Administration's HIV/AIDS Services Administration, and other public agencies to ensure that the completed projects receive appropriate building security and social services.

Under the proposed project, the City will sell the Disposition Area to Ascendant 244 Housing Development Fund Corporation ("Sponsor") for the nominal price of one dollar per tax lot. The Sponsor will also deliver an enforcement note and mortgage for the remainder of the appraised value ("Land Debt"). The Sponsor will then construct one building containing a total of approximately 32 units for occupancy by homeless and low-income persons, plus one unit for a superintendent. The Land Debt or City's capital subsidy may be repayable out of resale or refinancing profits for a period of at least thirty (30) years following completion of construction. The remaining balance, if any, may be forgiven at the end of the term.

STATEMENT OF BASIS AND PURPOSE OF PROPOSED RULE

Local Law 14 of 2020 amended the New York City Plumbing Code and Local Law 126 of 2021 amended the New York City Building Code, the New York City Mechanical Code and the New York City Fuel Gas Code.

The Department's Referenced Standards are found in Chapter 15 of the Plumbing Code, Chapter 35 of the Building Code, Chapter 15 of the Mechanical Code and Chapter 8 of the Fuel Gas Code. Local Laws 14 and 126 repealed those chapters and added new ones.

Whereas, the New York City Department of Design and Construction ("DDC"), on behalf of the New York City Department of Transportation ("DOT") and the City of New York ("City"), has proposed the acquisition of certain street bed properties on Amboy Road between Richmond Avenue and Ridgecrest Avenue, as shown on the Damage and Acquisition Map No. 4272, dated 08/17/2020, and last revised 12/12/2022 (Capital Project No. HWR00508) in the Borough of Staten Island (the "Project"); and

Whereas, the New York State Eminent Domain Procedure Law ("EDPL") sets forth uniform procedures for condemnations by municipalities throughout the State of New York, which also governs this acquisition; and

Whereas, pursuant to the EDPL, the City is required to hold a public hearing to inform the public of the proposed roadway acquisition, the impact on the lotted property listed below, to review the public use to be served by the Project, and the impact on the environment and residents; and

Whereas, on June 7th, 2023 the City held a public hearing pursuant to EDPL Section 204 (with an option to attend virtually) in relation to this acquisition, in the Borough of Staten Island. Having given due consideration to the complete hearing record, which includes, amongst other things, all documents submitted and all public comments, the City makes the following determination and findings concerning the above and below described acquisition and project:

- 1. The public use and benefit of this project is for the reconstruction of Amboy Road between Richmond Avenue and Ridgecrest Avenue in the Borough of Staten Island
- 2. The property proposed to be acquired is within the acquisition limits shown on Damage and Acquisition Map No. 4272, dated 08/17/2020, and last revised 12/12/2022, as follows ("the acquisition area"):
 - Block 5236, part of Lot 1.

The portion of lot proposed to be acquired includes the location, as shown on the Tax Map of the City of New York for the Borough of Staten Island:

The City selected this location based on a need for the reconstruction of the roadway in Amboy Road between Richmond Avenue and Ridgecrest Avenue.

The general effect on the neighborhood will be to improve current living conditions.

An environmental assessment of the proposed property acquisition location was conducted in accordance with the requirements of the State Environmental Quality Review Act (SEQRA) and the New York City Environmental Quality Review process. New York City Department of Transportation, as lead agency, determined that the proposed project would have no potential significant adverse impact on the environment, and issued a Negative Declaration (CEQR No. 16DOT010R) on December 24, 2015.

Comments presented at the public hearing have been reviewed by the City and given due consideration. Comments were made about the effect of road construction on: the Burger King business, the front stairs of the property, the sidewalk, the "handicap" ramp and the handicap parking spaces at the property, and the landscaping and the location of the sign at the property. Comments were made about compensation. Concern was also expressed about the construction duration and timing.

The record of the hearing remained open for written comments until 5:00 PM June 14th, 2023. No written comments were received subsequent to the hearing.
