EXECUTIVE ORDER NO. 27

JANUARY 26, 1979

DEPUTY MAYORS

BY THE POWER VESTED IN ME AS MAYOR OF THE CITY OF NEW YORK, IT

is hereby ordered:
Section 1. There shall be seven Deputy Mayors. One of them shall be designated Deputy Mayor for Administration, one shall be designated Deputy Mayor for Intergovernmental Re-

lations, one shall be designated Deputy Mayor for Policy, one shall be designated Deputy Mayor for Economic Policy and Development, one shall be designated Deputy Mayor for Financial Management, one shall be designated Deputy Mayor for Criminal Justice, and one shall be designated Deputy Mayor for Human Services.
§ 2. The Deputy Mayor for Administration shall:

(a) Develop and supervise programs involving coordination among administrations, departments, boards and agencies, and including management and personnel practices and matters arising out of the periodic reports submitted to the Mayor by the heads of agencies,

(b) Administer, on behalf of the Mayor, Executive Order No. 90 with the Director of

Management and Budget.

(c) Represent the Mayor when so directed on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor may direct. The Deputy Mayor for Intergovernmental Relations shall:

(a) In the absence of the Mayor from sessions of the Board of Estimate act on behalf

of the Mayor at such sessions of the Board of Estimate.

(b) Act on behalf of the Mayor with respect to all Federal, State and local legislative matters affecting the City; direct the activities of the Mayor's legislative representative, the Albany office, and the Washington, D.C. office; represent the Mayor before Congressional and State legislative committees, maintain liaison with the Office of the President and all Federal departments and agencies thereof, the Office of the Governor and all State departments and agencies thereof, the Board of Estimate and the City Council and supervise the activities of the New York City Commission for the United Nations and for the Consular Corps.

(c) Serve as the Mayor's representative on and maintain liaison with the regional

bodies and intergovernmental agencies operating within the New York metropolitan region.

(d) Maintain liaison with the United States Conference of Mayors, the National League of Cities, the New York State Conference of Mayors and other similar bodies.

(e) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(f) Perform such other duties as the Mayor may direct.
§ 4. The Deputy Mayor for Policy shall:

(a) Advise and assist the Mayor on matters of City policy.
(b) Maintain liaison with and review the activities of the Board of Education and the Board of Higher Education of The City of New York.

(c) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor may direct.

§ 5. The Deputy Mayor for Economic Policy and Development shall:

(a) Head the City's economic development program, including tax, energy and government regulatory policy and coordinate the efforts to foster the economic growth of the City.

(b) Direct the activities of the Office for Economic Development and the Business Marketing Corporation, coordinate the activities of the Public Development Corporation and the Industrial Development Agency, and act as Chairman of the Development Funds Steering Committee.

(c) Represent the Mayor when so directed by the Mayor on any board, committee, com-

mission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor may direct.

The Deputy Mayor for Financial Management shall:

(a) Supervise and coordinate the City's financial management operations including fiscal and management reforms relating to budget and accounting practices

- (b) Act on behalf of and at the direction of the Mayor in exercising and carrying out the functions, powers and duties vested in or imposed upon the Mayor by the New York State Municipal Assistance Corporation Act, the Municipal Assistance Corporation for The City of New York Act and the New York State Financial Emergency Act for The City of New York.
- (c) Act on behalf of and at the direction of the Mayor in the exercise of all functions, powers and duties which the Mayor may have pursuant to Article 10 of the Public Authorities Law, as enacted by Chapters 168 and 169 of the Laws of 1975 as from time to time amended (hereinafter called the Act), including, but not limited to, full power to execute for, on behalf of, and at the direction of the Mayor any agreement pursuant to section 3038 of the Act between The City of New York and the Municipal Assistance Corporation for The City of New York, any certificate pursuant to section 3037 of the Act, and any other document in connection with the Act. The exercise of functions, powers and duties for, on behalf of and at the direction of the Mayor by such Deputy Mayor pursuant to this delega-

tion shall not require the consent in writing of the Mayor or any other official of the City.

(d) For the purposes of Article 2, section 9 of the Public Officers Law, notwithstanding the temporary inability of the Mayor to exercise such functions, powers and duties as he may have pursuant to the Act, by reason of sickness or otherwise, or his absence from the City, the delegation established by subdivision (c) of this section 6 shall devolve upon

the Deputy Mayor for Financial Management.

(e) Act for, on behalf of and at the direction of the Mayor in the exercise of all functions, powers and duties which the Mayor may have pursuant to the New York City Seasonal Financing Act of 1975, Public Law 94-143, as the same may be from time to time amended, and a credit agreement made thereunder as of December 30, 1975 by and among the United States of America on the one hand and the State of New York, The City of New York and the New York State Emergency Financial Control Board on the other hand, including but not limited to full power to execute for on behalf of each of the distriction of the New York. but not limited to, full power to execute for, on behalf of and at the direction of the Mayor, any document pursuant to such agreement and any agreement, amendment to agreement or other document pursuant to such law; and to act for, on behalf of and at the direction of the Mayor in the exercise of all functions, powers and duties which the Mayor may have #27

pursuant to the New York City Loan Guarantee Act of 1978, P. L. 95-339, as the same may be from time to time amended, an Agreement to Guarantee by and among the United States of America, the State of New York, The City of New York, the New York State Financial Control Board and the Municipal Assistance Corporation for The City of New York, a Loan Agreement between The City of New York and certain banks and pension funds, and a Guaranteed Bond Purchase Agreement by and among The City of New York, certain City pension funds, certain State pension funds and the United States of America, each dated as of November 15, 1978, including, but not limited to, full power to execute for, on behalf of, and at the direction of the Mayor, any document pursuant to any such agreement on behalf of, and at the direction of the Mayor, any document pursuant to any such agreement and any agreement, amendment to agreement or other document pursuant to such law. The exercise of functions, powers and duties for, on behalf of and at the direction of the Mayor by such Deputy Mayor pursuant to this delegation shall not require the consent in writing of the Mayor or any other official of the City.

(f) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(g) Perform such other duties as the Mayor may direct. The Deputy Mayor for Criminal Justice shall:

(a) Serve as the coordinator of Criminal justice provided by section 13 of the New York City Charter.

(b) Supervise and coordinate the operations of the Department of Correction, Police Department and Department of Probation.

(c) Represent the Mayor when so directed by the Mayor on any board, committee, commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor shall direct. The Deputy Mayor for Human Services shall:

(a) Develop and supervise planning and programs among administrations, departments, boards and agencies in the areas of public assistance, health care, services to the aging and community action.

(b) Succeed to the powers and duties of the Health Services Administrator, as specified in Chapter 1016 of the Laws of 1969 (Section 7381 et seq. of the Unconsolidated Laws

of New York).

(c) Represent the Mayor when so directed by the Mayor on any board, committee,

commission or corporation of which the Mayor is a member.

(d) Perform such other duties as the Mayor shall direct.

§ 9. Section 2 of the Executive Order No. 3 of January 12, 1978, is hereby amended as of January 1, 1979 by deleting the reference to the "Deputy Mayor for Intergovernmental Relations" and substituting therefore "Deputy Mayor for Administration." Sections 1 through 6, and 8, of Executive Order No. 2 of January 1, 1978 are revoked as of January 1, 1979. Section 7 of Executive Order No. 2 of January 1, 1978, Executive Order No. 21 of September 8, 1978, and Executive Order No. 26 of November 17, 1978 are revoked as of January 26, 1979. Nothing in this Executive Order shall be construed to affect the validity of any act performed pursuant to the provisions of the Executive Orders hereby amended or revoked.

§ 10. This Order shall take effect as of January 1, 1979, except for Sections 6 and 8 which shall take effect on January 26, 1979, and Section 9, which shall take effect as described therein.
