MINUTES OF PUBLIC MEETING New York City Loft Board Public Meeting Held at 22 Reade Street, 1st Floor Spector Hall

February 21, 2013

The meeting began at 1:15 p.m. The attendees were Elliott Barowitz, Public Member; Gina Bolden-Rivera, Public Member; Chief Ronald Spadafora, Fire Department's Representative; Chuck Delaney, Tenants' Representative; Le Ann Shelton, Public Member; Matthew Mayer, Owners' Representative and Chairperson Robert LiMandri.

INTRODUCTION

Chairperson LiMandri introduced himself and welcomed those present to the February 21, 2013 public meeting of the New York City Loft Board.

VOTE ON JANUARY 17, 2013 MINUTES

REPORT OF EXECUTIVE DIRECTOR

Ms. Alexander introduced Christina Graham an Office Assistant Level II who has joined the staff to assist with various projects. **Ms. Alexander** reported that Deborah Fremder, Assistant General Counsel, is temporarily reassigned to DOB's General Counsel's Office to assist with the building code revision and is scheduled to return to the Loft Board next month. Prior to her reassignment, Ms. Fremder worked on the renewal registrations. Last month, 40 buildings had not renewed their registration. There are now 13 buildings that have failed to renew their registration.

Ms. Alexander reported that there are 334 buildings in the Loft Board's jurisdiction. There are currently 37 buildings that have certificates of occupancy. Of these, 23 buildings have removal applications pending. There are 100 buildings with temporary certificates of occupancy or 7-B compliance. Of these 100 buildings, 34 buildings have temporary certificates of occupancy and 66 buildings have filed certificates of 7-B compliance with the Loft Board. There are 104 buildings with permits. There are 56 buildings in the narrative statement process, 17 of which have completed the narrative statement process but have not obtained a permit, and 39 in the open narrative statement category. There are 7 buildings that have filed alteration type 1 applications and 30 buildings that have not yet begun the process.

Ms. Alexander reported that the Five Year Report has been pushed back a month. She is hopeful that she will be able to distribute a draft of the report to the Board in March.

Ms. Alexander reported that the staff has worked out the last issue with Corporation Counsel on Rule 2-01. The staff was ready to finalize the rule when the state legislature passed the 2013 amendment to the Loft Law. A chart that illustrated the changes of the amendment was distributed to each Board Member.

Ms. Alexander asked the Board if they wanted her to continue to distribute the building spreadsheet every month. The Board agreed that it would be sufficient to distribute the spreadsheet quarterly.

DISCUSSION OF DRAFT RULE 2-01

Martha Cruz reviewed the chart for Rule 2-01, which highlighted the changes to the rule, and the Board held a brief discussion. The staff would like to have the Rule in its final form for a vote by the Board at the March 21st meeting.

Ms. Alexander distributed the Rule tracking chart to the Board and gave a brief overview of the status of each Rule.
