

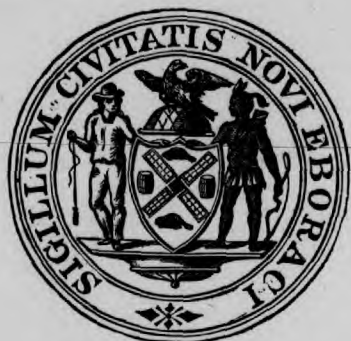

Report for the Quarter ending December 31, 1882.

POLICE DEPARTMENT, CITY OF NEW YORK,
300 MULBERRY STREET,
January 20, 1883.

To the Honorable FRANKLIN EDSON, Mayor, City of New York:

SIR—Pursuant to section 27, chapter 335, Laws of 1873, the Board of Police of the Police Department of the City of New York hereby respectfully submits the following report of the operations and transactions of the Police Department and force for the three months ending December 31, 1882:

REPORT.

On the 31st day of December, 1882, the number of members of the force of the several grades, including Surgeons, was 2,722.

SICK TIME.

The time lost by members of the Police force by reason of sickness, disability, and injuries, for the quarter ending December 31, 1882, and the details thereof, are shown in the annexed table, marked "A," from which it will be seen that the time lost was 8,595½ days.

Schedule "B" exhibits a valuable collection of miscellaneous statistics, to which attention is respectfully called.

NOTE.—The discrepancy existing between the number arrested for particular offenses on felony report and on general report (in Schedule "B") is accounted for by the fact that the general report is made up from daily returns, and the felony report from quarterly returns. An offense charged in the station-house, at the time the arrest is made, is liable to be and frequently is changed to a greater or less offense, on evidence elicited before the magistrate on arraignment.

DEPARTMENT OF DOCKS.

At a meeting of the Board of Docks held January 24, 1883.

Present—The full Board.

The minutes of the meeting held January 17th instant, were read and approved.

The following communications were received, read, and,

On motion, laid on the table to await action, as stated, to wit:

From the Common Council—Resolution requesting the Department to construct a public dock at One Hundred and Thirty-eighth street, Harlem river, or Long Island Sound, for the accommodation of the business men in the Twenty-third and Twenty-fourth Wards. Engineer-in-Chief to be directed to examine and report as to the most suitable location and the estimated cost of constructing the same.

From Fire Department—Requesting that the Department assign a berth at either Morton or Leroy street pier for use by the Fireboat "Zophar Mills."

The following communications were received, read, and,

On motion, placed on file, action being taken where necessary, as stated, to wit:

From Comptroller of the City—Requesting the Department to furnish in triplicate a diagram of the ferry premises at Twenty-third street, East river, occupied by the Greenpoint Ferry Company

under the lease to them which expired August 1, 1882. Secretary stating that the diagrams had been made and transmitted to the Comptroller, his action was approved.

From F. Perkins—In reference to permit for tally house on Pier 27, East river. Secretary directed to advise that the Board desire to be informed as to when the new tally house will be ready.

From James C. Bergen, attorney for Brooklyn Trust Company—Requesting an extension of time in which to make repairs to the bulkhead between Piers, old 28 and old 29, North river. Time to make repairs extended for twenty days, and the order to the Engineer-in-Chief to do the work suspended during that period.

From C. H. Mallory & Co., lessees—Requesting permission to repair Pier 21, East river. Permission granted, work to be done under the supervision and direction of the Engineer-in-Chief.

From Counsel to the Corporation—Enclosing check for \$375 collected from William H. Wood for one quarter's rent, due November 1, 1882, for the north half of Pier 56 and south half of Pier 57, East river, with the bulkhead between. Secretary to advise that credit therefor was given on the books of this Department.

From Lawrence & Co.—In reference to the condition of the bulkhead at the foot of Cherry street, East river.

From Decker & Rapp—In reference to the amount of the bill rendered for repairs made by this Department to the Pier at Bethune street, North river. Engineer-in-Chief to be directed to examine and report in relation thereto.

From Counsel to the Corporation—Requesting information in regard to the lessees of certain wharf property in order to properly prepare the form of lease to be executed therefor. Secretary directed to obtain the desired information and to transmit the same when obtained to the Counsel to the Corporation.

From Engineer-in-Chief:

1st. Reporting as to repairs required to the bulkhead south of Bethune street, North river. Secretary directed to notify the alleged owners thereof to repair the same within ten days, under the supervision and direction of the Engineer-in-Chief, or this Department will do the work at their cost and expense.

2d. Reporting amount of work done during the week ending January 20th instant.

3d. Report on Secretary's Order No. 2714, that repairs had been made under his supervision to the bulkhead between Bank and Bethune streets, North river, and also reporting that dirt, ashes, etc., had been dumped thereat since the completion of the work, which should be removed to ensure safety. Secretary directed to request the Department of Street Cleaning to have the same cleaned.

4th. Report on Secretary's Order No. 2799, that Pier 4, East river, had been repaired under his supervision.

5th. Report on Secretary's Order No. 2836, that repairs were made to the twenty-five feet of bulkhead commencing seventy-five feet easterly from Pier 54, East river, under his supervision.

6th. Report on Secretary's Order No. 2870, that the coal hoppers on Piers 53 and 54, East river, had been removed and taken to the Department Yard at Seventeenth street, East river.

7th. Report on Secretary's Order No. 2873, as to providing for removal of stairway at Seventy-fifth street, East river.

8th. Report on Secretary's Order No. 2448, that he had superintended the erection of the Pier and shed thereon between Sixty-seventh and Sixty-eighth streets, North river.

9th. Report on Secretary's Order No. 2532, that he had superintended the construction of a retaining wall at the foot of and south of Fifty-seventh street, East river, under permit granted to Thomas Fitzgerald.

10th. Report on Secretary's Order No. 2758, that he had superintended the erection of a shed on the Pier at Sixty-eighth street, North river, by the New York Central and Hudson River Railroad Company.

11th. Report on Secretary's Order No. 2743, as to the condition of and repairs required to the bulkhead north of the Pier at West Twelfth street, North river. Engineer-in-Chief to be directed to make the necessary repairs to twenty feet of the bulkhead north of the Pier at West Twelfth street, North river, and the Secretary directed to notify the alleged owners of the adjoining fifteen feet of the bulkhead to repair the same within ten days, under the supervision of the Engineer-in-Chief, or this Department will do the work at their cost and expense.

12th. Report on Secretary's Order No. 2849 as to condition of and repairs required to the "coal and passenger docks" at Randall's Island. Engineer-in-Chief to be directed to do the work in accordance with his report.

13th. Report on Secretary's Order No. 2826, that he had superintended the placing of leaders on Pier, new 28, North river.

14th. Report on Secretary's Order No. 2851, as to the condition of and repairs required to the bulkhead at foot of Cherry street, East river. Engineer-in-Chief to be directed to do the work.

From John Butler, Corporation Wharfinger:

1st. Reporting that the spring piles at the Pier at Thirty-second street, East river, were loose and required to be fastened. Engineer-in-Chief to be directed to make the necessary repairs.

2d. Reporting that the canal boat "Belle" had sunk at the dock at Eighty-sixth street, East river. Secretary directed to notify the owner of the boat, and also the lessee of the pier, to have the same removed at once.

From William L. McConkey, Corporation Wharfinger:

1st. Reporting that the dumping of ice and snow in the slip between Piers 19 and 20, East river, was done by the Department of Street Cleaning. Secretary directed to advise the Commissioners of Pilots that the dumping complained of by them had been done by the Department of Street Cleaning.

2d. Reporting that Pier 18, East river, required three mooring piles on the outer and easterly end. Engineer-in-Chief to be directed to examine and report.

3d. Reporting that the bulkhead between Piers 5 and 6, East river, required to be repaired. Secretary directed to notify the lessees to make the repairs thereto within ten days, under the supervision and direction of the Engineer-in-Chief, or this Department will do the work at their cost and expense.

4th. Reporting that a mooring pile was broken off on Pier 51, East river. Engineer-in-Chief to examine and report.

From John McKeon, Corporation Wharfinger:

1st. Reporting that the canal boat "C. F. Titus" had sunk on the south side of the Pier at Ninety-sixth street, North river.

2d. Reporting that James Rogers had not removed the brick from Pier at One Hundred and Thirty-first street, North river, which he had been notified to remove on or before December 20, 1882. Secretary directed to transmit report to the Counsel to the Corporation for collection of the penalty for violation of Rule 4—30 days, \$1,500.

A report from the Engineer-in-Chief on Secretary's Order No. 2746, in reference to dangerous obstructions on the bulkhead north of Jane street, North river, was received, read, and, On motion, laid on the table, and the following resolution, offered by Commissioner Voorhis, was unanimously adopted:

Resolved, That the Secretary be and hereby is directed to notify, through the Corporation Wharfinger of the District, the several parties using and incumbering the bulkheads along the water-front on the North river, from West Eleventh street to Twenty-third street; that the Board will hold a meeting on Thursday, February 8, at two o'clock P. M., for the purpose of conferring with them, and taking such action as may be proper in respect to such incumbrances, in order to keep the bulkheads clear for a distance of at least twenty feet back from the backing log.

Commissioner Voorhis, to whom was referred the communication from the Engineer-in-Chief, in respect to the newly-laid pavement on West street having been taken up by the Department of Public Works, and relaid by them with sand joints, reported orally that he had prepared a communication to the Commissioner of Public Works in relation thereto, and that the same had been transmitted by the Secretary.

On motion, the report was received and the action taken approved, and the communication from the Engineer-in-Chief ordered on file.

A communication from the Engineer-in-Chief on Secretary's Order No. 2781, submitting plans and specifications for repairing the under structure of Pier, new 42, North river, was received, read, and,

On motion, placed on file, and the following resolution in relation thereto was unanimously adopted:

Resolved, That the plans, specifications, and form of contract, as prepared by the Engineer-in-Chief, for repairing the under structure of Pier, new 42, North river, be and hereby are approved and adopted, subject to the approval of the Counsel to the Corporation as to form, and that the Secretary be and hereby is directed to have a sufficient number of blank forms of proposals printed, and proper advertisements, inviting bids for doing the said work, inserted in the papers designated by law.

The President offered the following resolution, which was unanimously adopted:

Resolved, That the action taken by the Board on the report heretofore made by the President in the matter of James Brady, which was referred to him, be reconsidered—

And the matter in question was,

On motion, referred to the full Board, hearing to be given on Monday, 29th instant, at 2 o'clock P. M.

Commissioner Vanderpoel offered the following resolution, which was unanimously adopted:

Resolved, That the Corporation Wharfingers be and hereby are directed to forthwith report to this Board all coal hoppers in their respective districts, on the North and East rivers, where

located, and the names of the owners thereof, and that they notify the said owners to remove them within ten days from service of notice, or this Department will remove the same and at their cost and expense.

The President offered the following preamble and resolution, which was unanimously adopted:

Whereas, The Department of Public Charities and Correction have heretofore made application to the Department for the construction of a dock at Fifty-fifth street, East river, as a landing place for the accommodation of passengers on the boats running to and from Blackwell's Island, and permission was granted to the said Department to construct the same at their own cost and expense, under the supervision of the Engineer-in-Chief of this Department;

Whereas, It has been represented that it is a matter of public necessity that the said work should be done to afford adequate facilities for the accommodation of the public; therefore

Resolved, That the Engineer-in-Chief be and hereby is directed to examine and report as to the most advisable plan providing for a landing at that location.

On motion of Commissioner Voorhis, the preamble and resolutions in respect to the premises known as West Washington Market, was taken from the table, and, after being amended to read as follows, was unanimously adopted:

Whereas, It appears by the statements and representations made to this Board at its meeting held on the 10th inst., by Messrs. Robert G. Cornell, Simon Hatch, and others, on behalf of the West Washington Market Association, composed mainly of occupants of the property lying west of West street, between Dey and Vesey streets, that they had neither individually or collectively received any notification from the Comptroller, as requested in the resolution of this Board, adopted August 30, 1882, to vacate the aforesaid premises occupied by them in their business on or about the first day of January, 1883; and

Whereas, The said parties composing the West Washington Market Association have petitioned this Board for a stay of action in regard to the proposed immediate improvement of the river front of the premises in question on the plan of 1871, for the reasons above stated, and also the reason that to compel them to at once vacate the premises occupied by them as stand-holders and lessees of West Washington Market would be an act of injustice and in violation of the privileges and courtesies which as tenants of the city they are entitled to receive, and would be exceedingly ruinous and disastrous to their several and respective kinds of business; and

Whereas, The said West Washington Market Association pledged themselves, through their accredited officers and representatives, that if sufficient time was afforded them, to wit, not exceeding one year from January 1, 1883, that they would voluntarily vacate the said premises, free from any objection, litigation, legislation, or hindrance on their part; therefore be it

Resolved, In view of the circumstances set forth in the foregoing preamble, that the prosecution of the work of improvement on the plan of 1871 of the water-front on the North river, opposite the West Washington Market, be and hereby is temporarily suspended, not to exceed the period of one year from date.

Resolved, That the Secretary of this Board transmit to the Comptroller of the City and the President of the West Washington Market Association a copy of the foregoing preamble and resolution.
