

SIR-The Board of Health of the Health Department of the City of New York respectfully submits the following report for the three months ending March 31, 1875, with the vital statistics of the City for the same period :

THE SANITARY BUREAU.

The following is a summary of the operations of the Sanitary Bureau, which is charged with the duty of inspecting and reporting, in proper form, all nuisances or causes of danger to the public health, with the execution of the orders of the Board, and with the care of contagious diseases :

Sanitary and Assistant Sanitary Inspectors to cases of contagious diseases, was twelve hundred and twenty-six.

The amount of meat and fish condemned by the officers of the Sanitary Company of Police during the quarter ending March 31, 1875, was as follows : Cattle, ten carcasses ; calves (bob), one hundred and thirty-five carcasses ; calves (case), seven carcasses ; sheep, seventy-two cases ; hogs, one hundred and seventeen carcasses ; beef, seven hundred and six pounds ; veal, three hundred and thirtyfive pounds; poultry, five hundred and ten pounds; mutton, two hundred and ten pounds; sausage, one hundred and six pounds ; and fish, fourteen thousand, five hundred and twenty-five pounds.

Since the last quarterly report all that section of the city lying below Houston street, on the west side, and Grand street, on the east side, has been inspected ; and a revisitation begun at Sixty-sixth street, on the east side, which has proceeded as far down as Tenth street. Also, two Vaccinators have been continually employed in school-vaccinations, and, as will be seen, have already vaccinated all children who wish it in sixteen public schools, and about twenty of the smaller industrial schools. It will also appear that 1,326 station-house lodgers have been vaccinated, which work is being performed with the assistance of the Police Department as thoroughly as possible.

Among the poor classes vaccination is much neglected, as shown by the number (5,788) of primary vaccinations, of which 3,353 were between the ages of one and seven years.

The number of complaints received from citizens during the three months ending March 31, 1875 was six hundred and thirty-nine, all of which were referred to the Sanitary Inspectors for investigation and report.

The Sanitary Superintendent during the same period granted, under instructions and authority of the Board, three hundred and eighty-eight permits to vessels to discharge cargoes upon proper vouchers from the Health Officer of the Port ; four hundred and thirty-six permits to scavengers to empty privies, their work being inspected by officers of this Board detailed for that purpose ; thirtysix permits to remove and transport manure; and forty-five permits were granted to land rags (in bulk) under bonds.

The number of places visited where cases of contagious disease were found and reported was ten hundred and eighty-one; the number of persons sick with contagious disease, who could not be properly isolated or cared for at their own houses and were therefore removed to hospital, was five hundred and thirty-six. The number of premises disinfected and funigated, where contagious diseases had prevailed, including privy sinks, clothing, bedding, etc., was nine hundred and eighty. RECORD. THE CITY

JUNE I.

During the three months ending March 31, 1875, seven thousand seven hundred and fourteen (7,714) permits were granted for burnals. During the same period two hundred and eighty-five (285) applications for transit permits were received and permits granted ; five hundred and sixty-four (564) permits were granted for the burial of still-born children; seven hundred and seventy-four (774) Coroners' certificates were received and recorded ; three hundred and eighty-five (385) searches of the records of births, marriages, and deaths were made ; and three hundred and eight (308) transcripts of the records of deaths, forty-four (44) of marriages, and fifty-five (55) of births from said records were issued. There were three thousand three hundred and two (3,302) persons registered as married during the quarter. The statistics of marriage during the last quarter of the year 1874 and the first quarter of the present year compare as follows :

These statistics for the first quarter of the present year show that the ratio of mortality, which from special causes, associated with an unusally inclement winter, was equal to a yearly death rate of 29.58 in the 1,000, the population being estimated at 1,060,000 ; and that the birth rate estimated by the number of births registered, appears as 23.38 per 1,000 inhabitants yearly ; and the marriage rate as 12.46 persons married in every 1,000 in the year. The number of marriages has doubtless decreased during the past year, but it is believed that not less than 35 to 40 out of every 100 persons who marry fail to make the return of their marriage for registration. This registration is regarded with increasing interest by the leading clergymen, but the duty to make their returns is neglected by others. The birth registration has steadily increased during the past year, and still there is much neglect among the ignorant and indifferent classes in bringing in the records of their births.

The rate of mortality in the quarter was increased by the continued cold weather. Two contagious diseases, diphtheria and small pox, prevailed extensively, causing 980 deaths altogether, and pneumonia and bronchitis caused 1,467 deaths. The mean temperature for the 13 weeks as registered by Director Draper in the Central Park, was 26.3 degrees Fahr., or colder by more than 6 degrees than the mean average temperature for the corresponding weeks of the past fifty years. There were 1,395 deaths in hospitals and other public institutions. The crowded state of many of the institutions as well as the common tenement houses contributed to the causes of mortality, but no epidemic fevers have prevailed in them.

ORDERS OF THE BOARD.

The orders of this Board for the abatement of nuisances are issued upon the facts and evidence contained in the written reports of the Sanitary Inspectors, the result of personal inspection of the premises complained of. During the three months ending March 31, 1875, the number of orders issued by the Board was two thousand three hundred and ninety-eight. Of this number five hundred and thirty-four were issued under the first sub-division of section 14, chapter 74, Laws of 1866, by the terms of which the party served is allowed three days in which to demand a hearing by the Board of the testimony, which may be presented to show that the order should be modified or revoked. In cases where no hearing has been asked for, and the orders have not been complied with, final orders, in the original or amended form, to the number of seventy-six, have been issued, and the Board has directed the attorney to commence action for penalties for non-compliance with such orders. All other written orders, in number one thousand eight hundred and sixty-four, have been issued, under the second sub-division of section 14, chapter 74, Laws of 1866, and are of a peremptory character, requiring that the nuisance be abated within five days, and if not complied with, directing the Sanitary Superintendent to enforce the same without further notice, unless the Board shall elect to commence a suit for penalty in lieu of the execution of the order by its officers or agents.

This tract shall contain such statistical information as shall be best adapted to the end in view; briefly and ex-plicitly state the reasons for vaccination, and the statement that the Board of Health will perform creaturious vacination from 0 A. M. to 4 P. M.

statement that the Board of Health will perform gratuitous vacination from 9 A. M. to 4 P. M. That a copy of the report of the Sanitary Super-intendent, in regard to the plots or parcels of land lying between and bounded by Seventh and Tenth avenues, One Hundred and Fortieth street and Harlem river, within the corporate limits of the City and County of New York, be placed on file in this Department, and that said Department be respectfully requested and directed to cause the respectfully requested and directed to cause the said plots or parcels to be drained by other means than by sewers, under and by virtue of the pro-visions of chapter 566, of the Laws of 1866.

Resolved, 1st. That it is advisable to increase the number of Vaccinators by twenty, at least for the present month.

2d. To attempt the thorough vaccination of the people in the districts where the disease is most prevalent.

3d. To prepare a tract for distribution among the tenement-house population, stating the ad-vantages of vaccination and revaccination, the necessity of their performance, and that the Board of Health will do it gratuitously.

4th. That a short tract be sent to the physicians of the city, notifying them of the presence of the disease, its intensity, and the localities where it is prevailing, requesting them, in their private prac-tice, to vaccinate all children who need it.

Resolved, That in all cases where insufficient excuses are made for declining vaccination, the Vaccinator take the name and address of the people and of the family physician; and the Board notify the physician of the fact.

Resolved, That whenever any person sick with small pox is removed from any house, it be the duty of those removing such person to see that the halls are cleared of people, the doors shut, and that the people do not come within ten feet of the person removed. That, if unable to carry out this provision, they call upon the police to

Resolved, That it be the duty of the Inspector sent to investigate any case of small-pox reported or the first time to ascertain the place or places at which the members of the family work, or to which they go, and that a Vaccinator be sent to these places and offer vaccination to the people there living or employed.

Rules for Reception Hospital.

Ist. No patient shall be detained for a longer period than till the time of first departure of the boat subsequent to his or her arrival.

2d. No persons shall be allowed to enter the building except those whose duties bring them there.

3d. The Matron shall see that the doors leading to the hospital grounds are closed, except for such period as is necessary to allow of ingress and egress.

4th. The vehicle bringing small-pox patients shall always be required to back into building, and the doors must be shut before taking patients out.

5th. The Orderly and Matron will be expected to see that these rules are carried out, and shall take great care in going from this building to change clothing, etc.

6th. The Orderly and the Matron shall not be absent from the building at the same time.

Sanitary Bureau. The following is a record of the work per-formed by the Sanitary Bureau for the week end-ing May 22, 1875. The total number of inspec-tions made by the Inspectors was 2,514, as follows: 3 public buildings, 1,304 tenement houses, 210 private dwellings, 168 other dwellings, 14 manu-latories and workshops, 9 stores and ware-houses, 116 stables, 8 railroad cars, 61 slaughter-houses, 2 fat-rendering establishments, 1 public swer and drain, 1 pier and dock, 58 sunken and vacant lots, 99 yards, courts, and areas, 57 cellars and basements, 93 waste-pipes and drains, 162 privies and water-closets, 32 streets, gutters and isdewalks, 15 dangerous stairways, 13 other uisances, together with 98 visits of the Sanitary Inspectors to cases of contagious disease. The number of reports thereon received from the Inspectors during the past week was 723. Ting the past week to5 complaints were received from citizens, and referred to the Inspec-tors for investigation and report. 2 spermits were issued to consignees of vessels to discharge cargoes, on vouchers from the Health officer of this Port. 238 permits were granted scavengers to the deam and disinfort origination.

238 permits were granted scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 102 prem ises where contagious diseases were found, and have disinfected and fumigated 4,182 privy-sinks, 42 yards and 30 cellars ; also, 2,073 miles of street gutters.


