2. An Urban Development Action Area Project for such property; and

3. The disposition of such property to a sponsor/developer selected by HPD.

The application was filed by the Department of Housing Preservation and Development on June 4, 2003.

Approval of this application would facilitate the development of the Arverne Urban Renewal Area within an area generally bounded by Beach 32nd Street, Beach 84th Street, Beach 74th Street, the Boardwalk and Rockaway Beach Boulevard, Queens, Community District 14 as an Urban Development Action Area;

The Department of Housing Preservation and Development states in its application that:

The site comprises an area whose deterioration negatively impacts on the surrounding neighborhood and tends to impair or arrest the sound development of the surrounding community, with or without tangible physical blight. This blighting influence and the existence of such areas constitute a serious and growing menace which threatens the source of public revenues. Incentives are needed in order to induce the correction of these substandard, unsanitary and blighting conditions.

The project activities would protect and promote health and safety and would promote sound growth and development. The proposed project is therefore eligible to be an Urban Development Action Area Project pursuant to Article 16 of the General Municipal Law.

RELATED ACTIONS

In addition to this application which is the subject of this report, implementation of the proposed development also requires action by the City Planning Commission on the following applications which are being considered concurrently with this application:

1. C 030433 MMQ	Amendment to the City map involving the mapping, demapping, and alteration of streets and parks.
2. C 030509 HUQ	Second Amendment to the Arverne Urban Renewal Plan.
3. C 030510 ZMQ	Changes in zones from R6 to R6/C2-4, from R6/C2-4 to R6, from R6 and R6/C2-4 to C4-4, and establish R6 on demapped park.

BACKGROUND

A more detailed description of the site, surrounding area and proposed project is included in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

ENVIRONMENTAL REVIEW

This application (C 030511 HAQ), in conjunction with the applications for the related actions (C 030433 MMQ), (C 030509 HUQ) and, (C 030510 ZMQ) was reviewed pursuant to the New York State Environmental Quality Review Act (SEQRA), and the SEQRA regulations set forth in Volume 6 of the New York Code of Rules and Regulations, Section 617.00 <u>et seq</u>. and the New York City Environmental Quality Review (CEQR) Rules of Procedure of 1991 and Executive Order No. 91 of

1977. The designated CEQR number is 02HPD004Q. The lead agency is the Department of Housing Preservation and Development.

A summary of the environmental review and the Final Environmental Impact Statement appears in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

UNIFORM LAND USE REVIEW

This application (C 030511 HAQ), in conjunction with the applications for the related actions (C 030433 MMQ), (C 030509 HUQ), and (C 030510 ZMQ) was certified as complete by the Department of City Planning on June 16, 2003, and was duly referred to Community Board 14 and the Borough President, in accordance with Article 3 of the Uniform Land Use Review Procedure (ULURP) rules.

Community Board Public Hearing

Community Board 14 held a public hearing on this application on July 29, 2003, and on that date, by a vote of 29 to 5 with 9 abstentions, adopted a resolution recommending approval of the application with conditions.

A summary of the recommendation of Community Board 14 appears in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

Borough President Recommendation

This application was considered by the Borough President, who issued a recommendation approving the application with conditions on September 17, 2003. However, the Borough President's recommendation was submitted after the 30-day review period, and was therefore non-complying.

A summary of the Borough President's recommendation appears in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

City Planning Commission Public Hearing

On September 10, 2003 (Calendar No. 8), the City Planning Commission scheduled September 24, 2003, for a public hearing on this application (C 030511 HAQ). The hearing was duly held on September 24, 2003 (Calendar No. 18), in conjunction with the public hearings on the applications for the related actions (C 030433 MMQ), (C 030509 HUQ), and (C 030510 ZMQ).

There were a number of speakers, as described in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ), and the hearing was closed.

Waterfront Revitalization Program Consistency Review

This application, in conjunction with the applications for the related actions, was reviewed by the Department of City Planning for consistency with the policies of the New York City Waterfront Revitalization Program (WRP), adopted by the Board of Estimate on September 30, 1982 (Calendar No. 17), pursuant to the New York State Waterfront Revitalization and Coastal Resources Act of 1981 (New York State Executive Law, Section 910 et seq.). The designated WRP number is 03-017.

A discussion of WRP Consistency Review appears in the report on the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

CONSIDERATION

The Commission believes that the application for the disposition of 123 city-owned properties is appropriate.

A full consideration and analysis of the issues, and reasons for approving this application, appear in the related application for the Second Amendment to the Arverne Urban Renewal Plan (C 030509 HUQ).

RESOLVED, that having considered the Final Environmental Impact Statement (FEIS), for which a Notice of Completion was issued on October 24, 2003, with respect to this application (CEQR No. 02HPD004Q), the City Planning Commission finds that the requirements of Part 617, State Environmental Quality Review, have been met and that, consistent with social, economic and other essential considerations:

- 1. From among the reasonable alternatives thereto, the actions to be approved are ones which minimize or avoid adverse environmental impacts to the maximum extent practicable; and
- 2. The adverse environmental impacts revealed in the FEIS will be minimized or avoided to the maximum extent possible by incorporating as conditions to the approval those mitigative

measures that were identified as practicable.

The report of the City Planning Commission, together with the FEIS, constitutes the written statement of facts, and of social, economic and other factors and standards, that form with the basis of the decision, pursuant to Section 617.9(c)(3) of the SEQRA regulations; and

WHEREAS, the Department of Housing Preservation and Development has recommended the designation of 123 properties within the Arverne Urban Renewal Area in Community District 14, Borough of Queens, as an Urban Development Action Area; and

WHEREAS, the Department of Housing Preservation and Development has also recommended the approval of an Urban Development Action Area Project for such area;

THEREFORE, be it **RESOLVED**, that the City Planning Commission, after due consideration of the appropriateness of actions, certifies its unqualified approval of the following matters pursuant to the Urban Development Action Area Act:

- 1) the designation of 123 properties as an Urban Development Action Area:
- 2) an Urban Development Action Project for such area;

and the City Planning Commission recommends that the New York City Council finds that:

1. The present status of the area tends to impair or arrest the sound development of the municipality;

BE IT FURTHER RESOLVED, by the City Planning Commission, pursuant to Section 197-c of the New York City Charter, that based on the environmental determination and the consideration described in this report, the application of the Department of Housing Preservation and Development for the disposition of city-owned property generally located within the area bounded by Beach 32nd Street, Beach 84th Street, Beach 74th Street, the Boardwalk and Rockaway Beach Boulevard within the Arverne Urban Renewal Area, Community District 14, Borough of Queens, to a developer to be selected by the Department of Housing Preservation and Development to facilitate the development of the Arverne Urban Renewal Area, is approved (C 030511 HAQ).
