FDNY 2012 ANNUAL REPORT ON CDA INSPECTIONS

This report describes the New York City Fire Department's continuing efforts to improve its construction, demolition and asbestos abatement (CDA) inspection program and provides data on the results of those efforts. The Department remains in compliance with its agreement with the Manhattan District Attorney's Office following that Office's investigation into the tragic August 2007 fire at 130 Liberty Street.

Throughout 2012, the Department continued to devote resources to CDA inspections to ensure CDA buildings comply with the City's Fire Code. Among other accomplishments in 2012, the Department:

- Completed more than 28,890 inspections at CDA sites.
- Audited 3,670 of those CDA inspections.
- Began transitioning from schedule based inspections to risk based inspections with the launch of the Risk Based Inspection System (RBIS).
- Finalized requirements to incorporate the CDA business processes into RBIS, which will fully automate CDA inspections.
- Continued to work closely with the Mayor's Office of Operations and other City
 agencies to expand Data Share, and reconcile unique building identifiers. Data
 Share's primary goal of CDA data integration is intended to improve information
 sharing among the City agencies having some involvement with CDA buildings,
 Department of Buildings, Department of Environmental Protection and
 Environmental Control Board.

Results of Inspections

The Fire Department reports on compliance for the entire CDA building workload, which includes buildings inspected by both the Fire Prevention CDA Unit and the Fire Operations field units. The Fire Prevention CDA Unit primarily inspects buildings 75 feet and taller that are legally required to have standpipes. Fire Operations field units are responsible for inspecting CDA buildings that are less than 75 feet in height.

As of December 31, 2012, the CDA workload consisted of 2,282 buildings. Since July 2009, 6,503 CDA buildings have returned to the regular cyclical building inspection program after construction, major alteration or abatement work was completed, and an additional 1,471 buildings have been demolished.

Between January 1, 2012 and December 31, 2012:

- The FDNY conducted 28,890 CDA inspections:
 - o Fire Operations field units conducted 23,910 CDA inspections

- o Fire Prevention's CDA Unit conducted 4,980 CDA inspections
- CDA inspections resulted in 4,558 enforcement actions:
 - o 3,957 Violation Orders
 - o 340 Notices of Violation
 - o 261 Summonses
- Fire Operations field units conducted 1,067 familiarization drills on CDA buildings in the Fire Prevention CDA Unit's workload

Current Status

As of December 31, 2012, the on-time CDA inspection compliance rate for both the Fire Prevention CDA Unit and the Fire Operations field units was 92.20% (2,104 of 2,282 buildings in the program were being inspected within the required time frame).

Separately, the compliance rates are:

- 91.42% for Fire Operations field units with 1,821 of the 1,992 buildings in the Operations workload inspected timely; and
- 97.59% for the Fire Prevention CDA Unit with 283 of the 290 buildings in the CDA Unit workload inspected timely.

Staffing

The Fire Prevention CDA Unit has 16 Fire Prevention Inspectors and four Supervising Inspectors; the Compliance Unit CDA Audit Group has four Fire Prevention Inspectors and one Supervising Inspector; and Fire Prevention Suppression Unit has two Fire Prevention Inspectors also conducting CDA audits.

CDA Inspection Audits

CDA Audit units from the Bureau of Fire Prevention Suppression Unit and the Department's Compliance Unit CDA Audit Group perform inspection audits on randomly selected buildings, trace standpipes, issue enforcement actions, conduct follow up on Violation Orders and work closely with Fire Operations and the Fire Prevention CDA Units to identify training issues and improve inspection procedures.

Between January 1, 2012 and December 31, 2012, the efforts of the Fire Prevention Suppression Unit and the CDA Compliance Unit yielded the following results:

- 3,670 Quality Assurance (QA) audits and follow-up inspections:
 - o 858 Fire Prevention Suppression Unit audits and inspections completed
 - o 2,812 CDA Compliance Unit audits and inspections completed
- 4,298 Standpipes traced:
 - o 559 by the Fire Prevention Suppression Unit
 - o 2,975 by the Fire Prevention CDA Unit

- o 764 by the CDA Compliance Unit
- 476 enforcement actions resulting from CDA audits and inspections:
 - o 434 Violation Orders
 - o 2 Notices of Violation
 - o 40 Summonses
- 2,447 random QA audits conducted by the Compliance Unit
 - o 1,504 QA audits of Fire Operation's field unit inspection sites
 - o 943 OA audits of Fire Prevention's CDA Unit inspection sites

Enhanced Computer Tracking

The Department continues to develop a Coordinated Building Inspection and Data Analysis System (CBIDAS) and is working closely with various City agencies, including the DOB and the DEP to resolve data-integration issues. The Department has created a risk-based inspection application and a building data warehouse providing access to computerized building information for Fire Operations field personnel.


During 2012, the FDNY focused on the transition from a schedule-based inspection program to an inspection program based on risk. This has resulted in the development of RBIS that will replace the existing legacy scheduling application in early 2013. RBIS is designed to schedule building inspections based on risk and fully automates CDA tracking, scheduling, and inspection details. The Department is currently training all fire officers to use the application and maintains an inspection hot-line to answer questions from the field.

Conclusion

The FDNY CDA inspection and auditing efforts continue to achieve excellent results leading to enhanced safety of both the public and FDNY's first responders.




Combined CDA Special Inspection Tracking Report

92.20% or 2,104 of the 2,282 Buildings Currently In the Program Are In Compliance




FIRE OPERATIONS FIELD UNITS


CDA Special Inspection Tracking Report




