RESOLVED That the Design Commission, having considered designs for the reconstruction of a community center, 70 Mulberry Street at Bayard Street, Manhattan, submitted by the Department of Design and Construction and Department of Citywide Administrative Services represented by exhibits 6685-L, M, N, O, P & Q of record in this matter, hereby gives to the same unanimous preliminary approval with the understanding that before returning for final, the team will (1) at the façade (a) further clarify where BIPV and porcelain panels are being located, suggesting that Department of Citywide Administrative Services (DCAS) and the solar consultant be further engaged to ensure that the panel locations are optimized for maximum energy generation, (b) explore light-colored alternatives for the porcelain panels, noting that a dark, low-albedo tone is counterproductive to the team's sustainability goals, and (c) clarify what material is being used at the location where the massing volume steps in; (2) further clarify (a) the window proportions, including fenestration details, (b) the function and detailing of the light wells and inset sills, (c) the detailing of the BIPV-integrated solar shade, and (d) how the prefabricated modular construction will impact and/or overlay with the fenestration locations; (3) provide an update on the forthcoming maintenance agreement with the DCAS, which should include a plan for panel maintenance or replacement that prevents an ad hoc appearance if BIPV panels lose functionality, noting that leaving defunct BIPV panels on the rainscreen is preferable to replacement with dark porcelain; and (4) continue to restudy the plant selections and adjacencies to address how (a) the sun-thriving understory species selected will survive under shaded trees, (b) the edible annual plants will be maintained, since they need to be replaced after they are harvested, and (c) the sedum will survive within planted areas with taller plants that require deeper soil depth, as these species do not typically mix well.
