

BOARD OF ALDERMEN.

THURSDAY, August 6, 1885, } 11 o'clock A. M.

The Board met in their chamber, No. 16 City Hall.

The reading of the minutes of the meetings of June 29, July 3, 10, 13, 17, 20, 24, 28 and 31, and August 4, 1885, were read and approved.

REPORTS.

The Committee on Streets, to which was referred the annexed ordinance to amend the pro-visions of the Revised Ordinances of 1880, relating to the placing of building materials in the streets during the erection or repairing of buildings, respectfully

REPORT :

That an investigation of the subject has convinced your Committee that some modification of That an investigation of the subject has convinced your Committee that some modification of the existing ordinances is necessary, in order to accommodate them to the necessities inseparable from the changed condition in the business of erecting buildings, at the present time as compared with that of the year 1839, when the said ordinances were passed. Then a four or five story build-ing, covering half a city lot, was considered a large building, and the ordinances were passed with a view to the occupation of portions of the public streets by material used in the erection of such a structure; now, there appears to be no limit to the size of buildings, some of which cover entire blocks of ground, and ranging from eight to fifteen stories in height, so that the space required to "handle" the immense foundation-stores, iron and girders—in some instances over twenty tons in weight—renders it necessary to amend the ordinances so as to meet the changed conditions in the subject to which they relate. subject to which they relate.

The ordinance so referred to your Committee, and herewith accompanying, appears to contain the necessary amendments for this purpose, and your Committee therefore respectfully recommend its adoption.

AN ORDINANCE to amend sections 77 and 78 of article VII. of chapter 6 of the Revised Ordinances of 1880.

of 1880. The Mayor, Aldermen and Commonalty of the City of New York do ordain as follows: Section 1. Section 77 of article VII. of chapter 6 of the Revised Ordinances of 1880 is hereby amended by striking therefrom, after the word "person," in the second line of said section, the words "who shall place building materials in any of the public streets or avenues, or be," so that said section, when so amended, shall read as follows: "Sec. 77. The provisions of the preceding section shall apply to every person engaged in building any vault or constructing any lateral drain from any cellar to any public sewer, or who shall do or perform any work causing obstructions in the public streets, by virtue of any permit from any executive department, and also to all public or corporation officers engaged in performing any work in behalf of the Corporation whereby obstructions or excavations shall be made in the public streets." streets."

streets." Sec. 2. Section 78 of article VII. of chapter 6 of the Revised Ordinances of 1880, is hereby amended by striking out sub-division 6 and inserting in lieu thereof the following : "6. In placing building materials in the streets, the said materials shall be so placed as to occupy not more than one-third of the width of the carriageway of the street or avenue. In streets or the street is a street or avenue. In streets of feet

All ordinances or parts of ordinances inconsistent or conflicting with the provisions of this ordinance are hereby repealed. Sec. 4. This ordinance shall take effect immediately.

Negative—The President, Aldermen Brown, Cleary, Murray, McGinnis, Oakley, and Walsh—7. Alderman McKenna asked to be excused from voting, and the Board granted his request. Subsequently he withdrew the request to be excused, and was permitted to vote. He voted in the affirmative.

Grant have accepted the offer of the Corporation of the City of New York, of a sepulture in one of the public parks of the city, and have selected a site in Riverside Park for that purpose; be it therefore Resolved, That the right of said sepulture in said Riverside Park be and is hereby given to Gen. U. S. Grant, and to his wife upon her demise ; and be it further Resolved, That a proper deed of cession, for the purpose designated, be prepared by the Counsel to the Corporation, when the exact location and dimensions of the ground are fixed, and that said deed be therefor duly executed by the city authorities.

deed be therefor duly executed by the city authorities. On motion, the vote by which the preamble and resolution was adopted was reconsidered, and the paper was referred to the Committee on Law Department.

In paving any street or avenue, by extending it across the carriageway of such street or avenue, or if but a portion of the width of such carriageway be obstructed, across such portion, in which case the obstruction shall be so arranged as to leave a passageway through, as nearly as may be of milder. be, of uniform width.

3. In building a sewer, by placing it across the carriageway at the ends of such excavation, as shall be made.

"4. In the building of a well, by inclosing the same, and the obstructions connected there with, on one or more si

with, on one or more sides. "5. In building vaults, by inclosing the ground taken from the vaults. "6. In placing building materials in the streets, the said materials shall be so placed as to occupy not more than one-third of the width of the carriageway of the street or avenue. In streets or avenues where railroads occur said materials shall not be placed nearer to the track than two feet. In all cases sufficient lights shall be placed upon such building materials, and kept burning through the night, as provided in the preceding sections.
