AN ORDINANCE for the better protection of life and property in the City of New York. The Mayor, Aldermen and Commonalty of the City of New York do ordain as follows : Section I. Every owner, agent or other person having charge of and operating any portable steam boiler used for rock-drilling, excavating, hoisting or other purpose, and every steam boiler within the City of New York which is required to be tested by the Sanitary Company of the Police Department of the City of New York, under the provisions of chapter 180 of the Laws of 1884, shall have firmly placed and permanently secured upon such boiler a metal number or numbers corresponding with the number of the said boiler, as it is recorded upon the books of the Police Department of the City of New York. of New York.

Every failure to comply with the provisions of this ordinance shall be deemed a misdemeanor, and shall be punished, on conviction thereof, by a fine not exceeding twenty-five dollars (\$25) for each offense, or, in default of payment of such fine, by imprisonment not exceeding ten days. Sec. 2. This ordinance shall take effect immediately.
