From the Corporation Counsel:

1st. Requesting information relative to claims of this Department against M. M. McDermott for rent of Pier foot of West One Hundred and Thirty-fourth street, North river, for \$84.11, cost of repairing and cleaning said pier, amounting to \$985.10. Information furnished July 20, 1904.

2d. Advising that the claim against Thomas Connelly for \$210.53, cost of repairs to the Pier foot of West Thirty-fourth street, where damaged by the schooner "John W. Butterick," is uncollectible. Auditor directed, July 15, to cancel the claim on the books of the Department.

3d. Transmitting check for \$6,000 drawn by the National Surety Company, in payment of its liability upon its bond on Contract No. 673, for granite, Antonio Rizzolo, contractor. Notified July 15, that the amount due the Department in connection with the failure of said contractor to furnish the granite called for was \$7,276.45, and requested to advise the Department whether he can collect the balance of the claim, amounting to \$1,276.45.

4th. Requesting information relative to claim against Robert Rogers for \$27.87, cost of repairs to the Pier foot of West Twentieth street, and of claim against the Rogers Towing Company for \$34.70, cost of repairing the backing log on the bulkhead between Piers, new 57 and 58, North river. Information furnished July 20, with statement that both claims are chargeable against the Rogers Towing Company.

5th. Advising that the two most westerly gas holders on the marginal street between Sixteenth and Seventeenth street, North river, to which the City has acquired title, may be sold at public auction, and that such portions of the two most easterly holders as the City has acquired title to may also be sold, but that the Department has no authority to sell any portions of the easterly holders to which title has not been acquired by the City. Filed.

6th. Transmitting copy of judgment entered in the action brought by Clifford L. Miller against the City directing the City to dredge Cromwell's Creek, from One Hundred and Sixty-first street to the Harlem river, to a depth of at least 11 feet, and to so protect the northerly side of said creek that mud, dirt or stones may not enter into said creek. Engineer-in-Chief directed to prepare specifications and form of contract for dredging to a depth of 11 feet at mean low water, as required by the judgment, and the Park Department requested to report as to what action it is proposed to take with reference to strengthening the embankment along the creek.

From the Board of Education:

Requesting that they may be again permitted to occupy for school purposes the Pier at the foot of East Third street, at the opening of the school year for 1904. Notified July 15, that this Department deems it unwise to shorten the period for which the piers may be kept open for recreation purposes, and that it is therefore hoped that other arrangements can be made for quarters elsewhere.

From Bellevue and Allied Hospitals:

1st. Requesting the removal of the railing which rests on the coping of the bulkhead-wall in front of Bellevue Hospital. Notified July 20 that the work of removal and the erection of a temporary fence in place thereof will be done by this Department.

2d. Requesting permission to occupy a portion of the southerly side of the Pier foot of East Twenty-eighth street for the purpose of unloading coal thereat, for the use of said hospital. Berth assigned as requested to continue until the work of constructing the Bellevue section is completed.

From James A. Deering, attorney:

In relation to the desired acquisition of the property owned by his clients between Forty-second and Forty-third streets, North river, and suggesting the appointment of appraisers by the City and by the owners with a view to selling the property to the City by private agreement. Copy of said communication forwarded to the Comptroller for his consideration.

From the New York Central and Hudson River Railroad Company:

1st. Requesting reduction in the rental fixed for the privilege of maintaining tracks and switches leading to the new transfer bridges, adjoining the south side of Pier, new 73, North river. Rent reduced July 15, and permit of February 26, 1903, amended by fixing the compensation at the rate of \$100 per annum, to take effect from April 9, 1904, the date on which the tracks were completed.

2d. Requesting that a provision be inserted in the renewal lease of Pier, new 76, North river, to the effect that the repairing, rebuilding and renewing of the old portion of the understructure of said pier shall be done by the City. Recommendation for the granting of a new lease amended July 15 accordingly, and the Commissioners of the Sinking Fund requested to approve lease, eliminating the shedding privilege and providing that repairs to the substructure of the old portion of the pier shall be made by the City whenever required.

From the Staten Island Rapid Transit Railway Company:

Declining offer of the City of \$500,000 for the land, land under water, ferry house, etc., at St. George, Borough of Richmond, to be used in connection with the operation of the new Staten Island ferry. Copy of said communication forwarded to the Commissioners of the Sinking Fund July 15, and the Corporation Counsel requested to institute condemnation proceedings for the acquisition of the property.

From the Rapid Transit Ferry Company:

Declining to apply for an extension of its existing lease of the Staten Island Ferry franchise for a period of one year from June 1, 1904, as suggested by the Commissioners of the Sinking Fund. Copy of communication forwarded to the Commissioners of the Sinking Fund July 15.

From the New York City Railway Company:

Protesting against any additional charge for the privilege of maintaining intake and overflow flumes and coal and ash conveyor on premises leased to said company between Two Hundred and Sixteenth and Two Hundred and Eighteenth streets, Harlem river. Matter referred to Corporation Counsel for opinion as to whether this Department can fix and collect the additional rental of \$121.04 for the additional privileges granted.

From the Estate of I. and S. Bernheimer:

Agreeing to pay the cost of dredging required at the foot of One Hundred and Thirty-ninth and at the foot of One Hundred and Fortieth streets, Harlem river, at property owned by said Estate. Engineer-in-Chief directed July 15 to order the dredging and to report the cost for collection.

Requesting an extension of time within which to complete the delivery of yellow pine piles under Contract No. 816, and inclosing consent of surety thereto. Time extended July 18, to and including July 5, 1904.

From William P. Durando:

Requesting reduction in rental charged him for the maintenance of a boat house on the southerly side of Sherman's creek, Harlem river. Permit of July 1, 1904, amended by fixing the rental at \$50 per annum, payable quarterly, in advance to the Cashier.
