Bureau of Sewers.

On March 31, 1918, the sewerage system of the Borough of Manhattan consisted of 531,037 miles of sewers, 7,120 receiving basins and 1,339 inlets.

During the quarter, 1,208 linear feet of sewer, 13 receiving basins and 39 inlets were built as new work.

Work Completed.

Number and Character of Complaints Received.

Basins stopped (of which 251 were Departmental), 410; water in premises, 300; manhole cover broken, 187; sewer cave in, 18; manhole cover missing, 16; sewer stopped, 15; manhole cover dangerous, 8; examine basins and sewers, 8; basin cover broken, 13; had odor from basins or sewers, 6; cave in street, 6; set manhole head to grade, 4; lost articles, 3; exchange basin cover, 3; sluice grating broken, 2; basin cover missing, 1; steam in sewer, 1; explosion in sewer, 1; basin wash stone broken,

1; miscellaneous, 7. Of these complaints 265 were without cause for complaint so far as the sewer system is concerned.

The following work was performed for the Department of Street Cleaning while employed on excess work due to snow removal: The Repair Division was employed 10 working days on snow removal, the Pipe Sewer, Brick Sewer, Basin Cleaning and Emergency Gangs were employed 16 working days on snow removal. Basin inspected, 110; examined, 3; relieved, 97; cleaned, 620. Cubic yards dirt run from basin, 1,185.2. Culverts relieved, 1; flushed, 1. Brick sewer inspected, linear feet, 72,493; examined, 6,525; cleaned, 2,139; relieved, 1,100. Brick sewers relieved, 3. Cubic yards dirt run from brick sewers, 71.3. Pipe sewer examined, linear feet, 105,100; cleaned, 4,085; relieved, 5,055. Pipe sewers relieved, 20. Cubic yards dirt removed from pipe sewers, 5.6. Manholes covers placed, 15. Basin covers placed, 3.

Bureau of Public Buildings and Offices.

Minor repairs, open market orders, and check orders that are treated in the regular routine are noted in tabulated form at the conclusion of this report.

The larger and more important work accomplished is detailed by buildings or locations.

During the quarter the Bureau's plant was affected as never before in its history by the shortage of coal and the continued abnormally low temperature, which resulted in shutting down baths and comfort stations for a period of about three weeks. It was with difficulty that other buildings were kept going, fortunately important buildings were kept going without a reasonable complaint—the only exception being the Municipal Building, which cannot be kept up to 70 degrees F. on the west side when outside temperature is low and a strong wind is blowing.

Considerable damage was done to plumbing in baths and comfort stations due to freezing; a large number of mixing valves in the baths were damaged beyond repair due to the impossibility of fully draining them.

Municipal Building—Installed about 20 lights of glass. Cleaned by contract 400 window shades. Relined firebox of boiler No. 2. Started running hot and ice water return lines from second and third floors, inside the building, instead of through concourse piers. This involves running 1,100 feet of pipe. Repaired and braced up marble, in various parts of building, loosened up from vibration of elevators, etc. Erected partition for Department of Education on twenty-eighth floor. Painted three rooms for Commissioner of Correction. Installed electrical wiring and bell system in tower section for Board of Education. Installed 12 desk lamps in room of Fire Department. In Room 2355 installed buzzer and bell system. Installed enameled signs on essential parts and valves of refrigeration system; also safety gauge glasses for safe operation in accordance with regulations of Fire Department. Installed new gasket in feed water heater of boiler plant. Repaired 11 lengths vacuum hose used for cleaning offices. Issued order to overhaul refrigerating plant, viz.: enlarged weak liquor cooler, installed 2 expansion valves, also pump and various other valves, replaced corroded nipples in header of condenser, cleaned condenser, absorber, rectifier and weak liquor cooler, made joints tight, packed 50 valves and installed cork insulation. Permitted Red Cross to establish booths throughout building for raising of funds. Several tower floors occupied by Board of Education—construction department—as their building at 59th st. and Park ave. was put out of commission by fire. The tower offices, etc., were turned over to the Borough President as completed by Department of Plant and Structures.

City Hall—Painted two rooms on second floor for Minority Leader of Board of Aldermen and refinished oak floors of these rooms. Made various minor repairs in heating system. Started work of "restoration of cupola and reconstruction of third floor and roof over central portion." General contractor, P. T. Cox Contracting Company having a contract for \$45,355. Steam heating contractors Philip and Paul having a contract for \$1,697. After work had started President Dowling decided to put in a bell which was the property of the City and was stored in the old Fire Headquarters at 67th st. This bell was cast many years ago for the former Village of Tremont and was set up as the village fire alarm bell. It is 37 inches high and 42 inches in diameter at the mouth and weighs 1,500 lbs. It is to be run every hour automatically by the clock's mechanism and is also arranged so that it can be rung at other times. This reconstruction work, which was caused by the fire of May 11, 1917, is confined to the middle section of building and above third floor level. It consists of removing remains of old wooden cupola, removal of the roof and renovation of third story and building a fireproof roof of steel and concrete and a fireproof cupola of same construction covered with sheet copper and painted. The new cupola is carried in part on roof truss at north side of cupola and in part on an existing brick wall; formerly the cupola instead of being carried on a truss was carried on wooden struts, which directed the load down to the marble columns around rotunda in second story. The clock to be installed is a mechanically operated clock of the E. Howard Clock Company. It will be wound up automatically by an electric motor. The dials will be 5 feet 3 inches in diameter and each will be of one piece of glass five-eighths of an inch thick. At night the dials will be illuminated by electric lights, turned on and off automatically by the clock's mechanism.

Hall of Records—Painted 3 rooms comprising private office of Register and large public office on second floor, Centre st. side, also Room 410. Relined completely firebox of boiler No. 2. Contracted work of alterations to metal furniture and other alterations in progress have been nearly completed. Did necessary carpenter work to equipment of Laboratory of Bureau of Weights and Measures to install it in Room 10 in basement. Installed feeder to sub-basement electric lighting panel. Installed signs for safe operation of refrigerating plant in accordance with rules of Fire Department. Installed new cylinder head on Watertown engines. Installed independent bearings for forced draft fan and engines so that either engine may be overhauled without interference with system. Let contract for installing new steam main in place of present one which is corroded and wasteful from condensation losses. Overhauled ash hoist to sidewalk, including shaft, doors and railing. Repaired various minor parts of elevator system. A huge wooden sign on south front of building was provided and placed by Mayor's Committee on National Defence.

Criminal Court—Painted new quarters of Charities Department in northeast corner of the basement, also three toilet rooms. Repaired entrance doors on White and Franklin st. sides and installed four new door checks. Repaired a large section of No. 1 elevator cylinder by banding with heavy band irons and forcing broken section together. Overhauled blower engine for forced draft. Installed new 2-inch visor (in place of one burst by frost) to supply hot water radiators in southeast wing. Repaired bushings on elevator pumps. Prepared plans and specifications for fire sounding boards in back of judges' bench for Court of General Sessions.

County Court—Repaired roof of central section. Painted dado and base of entire first story. Erected platform in one of court rooms.

City Court—Altered Judge's bench in part 8 court room. Put patch on elevator pressure tank. Lowered Judge's bench, trial 8, about 8 inches as an experiment for Judge to move readily see jury and counsel.

264 Madison St.—Moved Judge's library from second floor to basement and painted this room and officers' room on second floor. Also relettered various parts of building. Repaired plaster in record room and Janitor's office, basement and jury room, second floor.

57 Centre St.—Painted ceilings of the four stories and walls of fourth story. Made alterations to plumbing system of first story. In conjunction with Department of Plant and Structures made estimate for additional alterations to adopt this building for use of Department of Licenses.

125-127 Worth St.—Dismantled shelving, bins, counters, railings, etc., of City Record at old location, 96 Reade st., and re-erected same on the first and second floors, of this building. Painted walls, ceilings, woodwork of first and second stories throughout. Repaired damage caused by fire on sixth and seventh stories. Installed about 1,000 feet new piping to repair damage done by frost due to lack of coal. Made plans and estimates for alterations to cellar, first and second stories for City Record; alterations to be contracted for.

49 Lafayette St.—In conjunction with the Department of Plant and Structures made study of various buildings with reference to housing various departments now in building, but which must be provided for elsewhere to make way for Public Service Commission. Repaired elevator No. 3 by installing new parts to main 6-inch valve. Installed new cut off cable on No. 2 elevator. Repaired numerous small defects and leaks in heating system. Installed length of 8-inch pipe in elevator pressure system. Large alterations undertaken by Public Service Commission throughout building, including rehabilitation of heating plant. Building presumably to be turned over in entirety to Public Service Commission. All City departments have been moved out.

146 Grand St.—Installed wooden platform at entrance. Made three other platforms and several wood cases for use of Clerks.

300 Mulberry St.—Repaired damage to plumbing pipes due to frost.

2d St. and 2d Ave., Magistrates Court—Work of excavation started. This

building is to be 21-2 stories high and is to occupy a frontage on 2d st. of 100 feet and on 2d ave. of 54 feet 6 inches. It is to be about 45 feet high above sidewalk. It is to be used exclusively for a Magistrates' Court. Contracts have been entered into as follows: General construction, \$104,975; plumbing, \$8,587; heating, \$3,611.

Jefferson Market Court—Made plan and estimate for new toilet for employees of Magistrates' Court.

Children's Court—Alterations made to third floor to fit it for psychopathic clinic. Relaid linoleum in psychopathic clinic. Installed closets in cellar for storing records. On third floor furnished and installed new electric lighting system for medical examination division. Prepared plans and specifications for two awning frames on roof.

East 32d St. Court—Installed radiator guard over large radiator, top floor. Installed new grate in hot water heater.

East 57th St. Court—Painted four rooms comprising new quarters of Probation Bureau, Magistrates' Court. Altered Judge's bench of Domestic Relations Court and repaired various doors and sashes.

155 E. 88th St.—Repaired furniture of Judge's Library.

Harlem Court—Repaired brick work outside of both boilers. Remedied electrical defects in elevator system. Repaired various parts and stopped leaks of antiquated heating system.

E. 11th St. Bath—Painted skylight, ceiling and walls of second story and cleaned off and touched up painting of waiting rooms. Also painted woodwork and ironwork at entrances and front of building. Installed about 200 feet pipe to repair damage due to frost. Installed three drips to drain leaks in rear of engine room. Repaired skylight over second story. Installed two new skylights over rear of first story. Completed contract work changing plant from high to low pressure. Renewed covering on cold water lines in shower rooms, main floor. Repaired clockwork of Bristol recording thermometer. Installed new blow-off line, made new connections to and from blow-off tank. Replaced various parts of corroded piping.

E. 23d St. Bath—Cleaned with oxalic acid mosaic tile of pool. Installed two new 3-inch valves on pool circulation line. Installed and replaced mixing valves. Repaired various parts heating equipment. Installed new valves on refiltration system. Repaired door leading from boiler room. Permitted marines from E. 24th st. pier special privileges.

W. 28th St. Bath—Painted ceilings and woodwork of waiting rooms and stairs, all windows and skylights, ironwork of entrance and on roof and all doors except stall doors of second story, which are not yet completed. Cleaned with oxalic acid mosaic tile of pool and grouted same. Installed 30 marble seats. Repaired tile over pool. Repaired sterilizer for pool. Repaired defects in heating system.

W. 51st St. Bath—Completed installation cast iron mains for second story shower rooms. Repaired two dozen or more mixing valves for showers. Repaired all shower compartment doors and put in full quota of slats. Provided a small slot in each door.

E. 54th St. Bath—Installed about 300 feet pipe to repair damage caused by frost. Repaired stall doors throughout. Batched chloride tank of filtration system. Overhauled turbine driven centrifugal pump for emptying pools. Repaired about forty mixing valves and connections. Repaired various portions of piping.

W. 60th St. Bath—Painted section of pool ceiling of slate wainscot on second floor and fifty stall doors. Cleaned with oxalic acid mosaic tile of pool and grouted same. Repaired skylight over pool and installed new turret sash. Repaired shower doors throughout. Repaired clockwork of Bristol recording gauge and thermometer. Made minor repairs to heating system. Overhauled feed pumps. Overhauled about 35 mixing valves and connections. Made temporary repairs to coal chute.

East 76th St. Bath—Painted walls, ceiling, ironwork, etc., of waiting rooms and bathing wells, first floor, and repaired plastered surface of same. Expanded leaky tubes in boilers. Repaired about 2 dozen mixing valves.

East 109th St. Bath—Refinished men's and women's entrance doors. Painted 40 stall doors. Repaired all stall doors. Overhauled dynamo engine No. 1. Repaired Bristol recording thermometer. Overhauled 2 dozen mixing valves.

Allen St. Bath—Painted all stall doors and touched up painted walls. Repaired numerous small defects in heating and plumbing system. Overhauled forced draft fan motor. Overhauled feed pumps. Overhauled vacuum pump. Repaired automatic regulators for shower heaters. Overhauled 2 dozen mixing valves and showers. Reboxed cylinders of No. 2 engine, installed new pistons and piston rings.

Carmine St. Bath—Painted iron work of entrances, stall doors and pipe covering of men's side and varnished woodwork of office and men's and women's vestibules. Installed 100 feet pipe to repair damage caused by frost. Overhauled 35 shower mixing valves. Overhauled 3-inch water meter. Tightened up shoring braces along outside of east wall in conformity with advice of Bureau of Buildings. Park Department requested to clean gymnasium and portion under their jurisdiction.

Cherry and Oliver St. Bath—Painted all doors to showers and touched up walls. Repaired pipe covering on men's and women's sides and at manifolds. Installed 10 new tubes in boilers. Completed installation forced draft fan and motor for boilers.

Rivington St. Bath—Painted iron work and plaster walls of men's and women's front stairs. Repaired plaster third story rear. Installed new screens on second and third stories rear to openings in ventilating well. Prepared specifications for rebuilding copying women's stoop. Installed 10 new tubes in boilers No. 2. Overhauled minor parts heating system. Repaired 3 dozen mixing valves. Tightened up piping in heating system.

Rutgers Pl. Bath—Refinished entrance doors men's and women's sides and woodwork of office. Painted south bay of women's bathing well, first floor. Repaired shower doors and sashes throughout. Scraped, painted and reinstalled screens over second floor showers. Overhauled thermostat control on tank heaters. Installed 4 new tubes in boiler No. 2. Overhauled about 50 mixing valves. Overhauled various parts of heating system. Repaired coal scales. Repaired forced draft blower. Overhauled and repaired suspended lights on roof.

Battery Park Comfort Station—Installed new header in heating system and overhauled system. Overhauled all plumbing and repaired damage due to frost. Installed new door check and repaired others.

Hanover Sq. Comfort Station—Completed plastering with Portland cement direct on brick arches after damp proofing. Also continued tile walls from old ceiling line to line of brick arches. Also repaired tile walls in other portions.

Mail St. Comfort Station—Reset and reglazed top of women's kiosks.

Abingdon Sq. Comfort Station—Overhauled plumbing and repaired damage due to frost.

Greeley Sq. Comfort Station—Reopened station and overhauled plumbing and steam heating systems and installed 3 new radiators. Negotiations now going on with the Public Service Commission to repair plaster and leaks. Repaired doors.

Long Acre Sq. Comfort Station—Repaired doors. Repaired leaky vault lights.

Queensboro Bridge Comfort Station—Renewed the entire water line and repaired damage due to frost.

Third Ave. and 129th St. Comfort Station—Overhauled plumbing and repaired damage due to frost.

General—During the quarter the following completed jobs were executed by the Bureau's various mechanical squads: Carpentry, 56; steamfitting, 25; roofing, 90; electrical, 233; machinist, 44; masonry, 14; plumbing, 30; painting and varnishing, 54; awnings, 29; total 575; 359 requisitions and open market orders were issued; 406 check orders were drawn against miscellaneous monthly orders. The patronage for the interior baths was: January, 83,315; February, 99,589; March, 511,493; total, 694,397.

Bureau of Topography.

Proposed Street Through Battery Park—At request of Merchants' Association we have made a study of suggestion to lay out a street connecting State st. with the Ferries west of Whitehall st. The need for an additional thoroughfare is caused by congestion in Whitehall st. and at the ferries. However, we believe it would be unwise to map a street through the park at this date and suggested that through co-operation with the Park Department a temporary roadway be built instead—which could be removed should future conditions so warrant.

Street System North of 42d St. on Park Ave.—When ramp at 34th st. and 4th ave., and viaduct south of 42d st. are completed the problem of providing a continuous route north will still remain unsolved—under existing conditions. Tentative plans are being studied for an improved street system, whereby north bound traffic may follow a roadway to the east of the terminal, and south bound traffic utilize the thoroughfare to the west. At 45th st., by means of viaduct, these two viaduct roadways are to join at 46th st. and Park ave.

Improvement of Harlem Ship Canal at Johnson Iron Works—We are making studies for straightening out the dangerous curve at northerly end of Borough to

provide more direct connection between the Hudson and Harlem Rivers. This will require real estate transaction, in the deflection of present course of canal and filling in of part of present waterway.

Street System at Manhattan End of Queensboro Bridge—Due to lack of proper traffic facilities at 2d ave., between 59th and 60th sts., caused by crossing of various lines of traffic using the bridge and streets, a dangerous impediment to traffic has resulted. Studies are being made to relieve this condition. Preliminary plans are in progress which seem to offer the much needed relief and at the same time to compare very favorably in cost, both for land taking as well as construction, with plans previously considered, which did not solve the problem in spite of their high cost.

Interborough Yard—Negotiations are still in progress between this office and the Interborough Rapid Transit Company regarding changes in street system north of 147th st. and East of 7th ave. suggested, for improvement of the railroad yards. In all studies we have attempted to preserve to the City the use of all streets now laid out and not interfere with a practical development of the yard.

Street Connection South of Speedway—Negotiations are still in progress with Interborough Rapid Transit Company regarding layout of a street through property leased by them as a railroad yard north of 155th st. at the Harlem River connecting the Speedway south with 7th and 8th aves., thus providing a water level route from the Battery to Dyckman st.

Blackwells Island—The Department of Charities, having no engineering force, asked aid in making a topographical survey of that part of the Island where new roads were intended to be laid out. Lines were run, test pits located, etc.

Franchise, 10th Ave. from 14th to 15th Sts.—As a result of petition by the Armour Company to lay a track siding in westerly roadway of 10th ave., from 14th to 15th sts., we reported adversely, recommending at the same time that if the track could not be laid within private property it be located along their building line and thus remove obstruction to vehicular traffic and permit pedestrian traffic on westerly sidewalk. After negotiating with representatives of petitioners they consented to our recommendation.

Change in City Map.

This supersedes the one submitted in 1916, which was held up pending action on West Side Improvement. Reports and investigations, maps on city plan matters. 59th st., 5th, 8th aves., widening; Vermilyea ave. extension, layout; 7th ave. and 11th st., triangular park; 215th st., pedestrian viaduct; street through Battery Park to ferries; street system around Grand Central Terminal; street system in vicinity of Interboro yard at 148th st. and Harlem River; copy of layout and grade map of Marble Hill section.

Work Completed—(Maps submitted to Board of Estimate for certification and file). Plaza Lafayette, layout of park and closing central portion west of Haven ave.; area bounded by Riverside Drive, 158th st., 165th st. and Broadway, adjustment of street dimensions and change in line of Drive between 161st and 162d sts.

Work in Progress—Dongan Place (Broadway to Arden st.), layout of new street and closing and discontinuing sickles st., between Sherman ave. and Broadway. (Substitute plan for Vermilyea ave. extension.) Street system around Grand Central Terminal joining Park ave. north of 45th st. with 4th ave. south of 42d st. (See Special.) Fort George Hill, street system north of 190th st., between Amsterdam and Audubon aves., additional topographical surveys made for use in preparing final map. Harlem Ship Canal, proposed straightening of curve at Johnson Iron Works, northerly end of Manhattan, see special. Queensboro Bridge, approach in Borough of Manhattan (see special). Riverside Drive service street between 124th and 129th sts., layout. Stairway street on 168th and 173d sts., from Haven ave. to Riverside Drive service street (new studies). 59th st., 5th to 8th aves., additional surveys for widening. Street system in area bounded by Harlem River, 147th st. and 7th ave. and 150th st., in connection with Interborough yard improvements.

MONUMENTS.

Work Completed—Loose and broken monument covers removed, space filled with cement and monument remarked.

Work in Progress—Copy made of old map prepared by Holden, locating monuments in section between 185th and 218th sts. Fixing final theoretical position of monuments in section between 155th and 190th sts. (a) Final block dimensions and co-ordinates of street corners were computed in section bounded by Amsterdam ave., Wadsworth ave., 168th st. and 190th st.; (b) Preliminary work on fixing street line of Broadway, from 168th to 181st sts.

BENCH MARKS.

Work Completed—On Madison ave., Greenwich st. and on Lexington ave., bench marks disturbed by construction were checked and re-established.

BOROUGH SURVEY AND BUILDING LINE DETERMINATION.

Work Completed—Base Line Work: The line on 5th ave., from 14th to 110th sts. is complete. This ties in the main primary traverses of the Borough. There still remains the 1st ave. line to be run. On 14th st., 57th st. and 110th st., from 5th to 10th aves., we tied in the base line of 5th ave. with that previously run on 10th ave. This comprised 17,000 linear feet. Bolts were set and offsets taken, and references made to all buildings thus insuring permanence of the work. It will now be relatively simple to tie in any isolated section with main system. Twenty-one blocks of unfinished section of borough survey, started in 1917, were completed. This necessitated location of 29,500 linear feet of building lines, the chaining of 18,300 linear feet of traverse. The section covered is bounded by Broadway, McDougal st., Broome st., and Houston st. Area bounded by East River, Avenue D, Houston st. and E. 4th st., prepared for purpose of definitely tying on new bulkhead line, as changed, at Tompkins st. with base line traverse. 14th st., 5th to 6th aves.; building lines furnished to Public Service Commission. 14th st. and 1st ave., from 13th to 15th sts., line of 1st ave. and developed correct angle with 14th st., furnished to Public Service Commission.

Work Completed—Map of Borough showing by colors the prices for vaults in every street. 116 vaults surveyed, many containing sub-vaults. Plans examined and checked up and reported on, 94, covering area of 8,855 square feet. Certificates

checked, 18, covering area of 18,753 square feet. Exports based on surveys, 21, covering area of 9,262 square feet. Cases of excess area, 14, covering area of 4,069 square feet.

A report on the Hudson Terminal Building vaults was made in answer to request from Public Service Commission. A large portion of old space under the walk, with the exception of Church st. side, is covered by a franchise, and we were asked to state whether the area in Church st. had been paid for as vault. Due to there being several permits which covered the entire building, it was necessary to go into great detail in analysis. As a result, we found that there was still 160 square feet of vault space unpaid for.

Corporation Counsel.

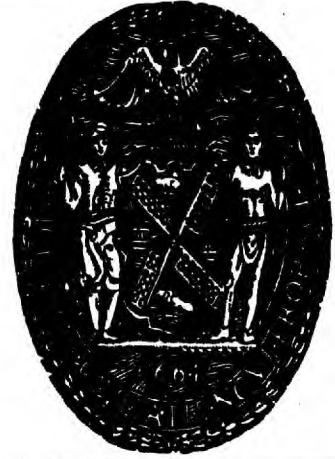
