









Number and Percent of Patients with Confirmed COVID-19 May 15 – May 21, 2021




Number of Currently Incarcerated Patients with Confirmed COVID-19 March 17, 2020 – May 21, 2021












Number and Percent of Open Units Above and Below 50% Capacity by Housing Category May 20, 2021
