IN THE MATTER OF an application submitted by the Department of City Planning, Department of Parks and Recreation, and the New York City Economic Development Corporation, pursuant to Sections 197-c and 199 of the New York City Charter, and Section 5-430 *et seq.*, of the New York City Administrative Code, for an amendment to the City Map involving:

- the establishment of new streets;
- the establishment of new parks and park additions;
- the modification and adjustment of grades of existing streets;
- the elimination, discontinuance and closing of portions of streets;
- the elimination of portions of parks;
- the delineation of easements and corridors;
- the extinguishment of record streets, all within an area generally bounded by West 8th Street, Surf Avenue, West 23rd Street, and the Public Beach; and
- any acquisition or disposition of real property related thereto,

Community District 13, Borough of Brooklyn, in accordance with Map Nos. X-2710 and X-2711, dated January 14, 2009 and signed by the Borough President.

The application (C 090107 MMK) for an amendment to the City Map was filed by the Department of City Planning, Department of Parks and Recreation, and the New York City Economic Development Corporation on September 18, 2008, in order to facilitate, in the Coney Island area of Brooklyn, the redevelopment of vacant and underutilized land through the creation of new block configurations, the elimination, reconfiguration and mapping of parkland, the enhancement of access to the Boardwalk from Surf Avenue, and the development of new east-west connections between the residential communities and the amusement area. The proposed mapping would also establish the transportation network necessary to accommodate the anticipated pedestrian and vehicular circulation in the area.

RELATED ACTIONS

In addition to the proposed amendment to the City Map, which is the subject of this report, implementation of the proposed project also requires action by the City Planning Commission on the following applications which are being considered concurrently with this application:

- 1. N 090273 (A) ZRK: Zoning Text amendment to create the Special Coney Island District.
- **2. C 090272 ZMK:** Amendment to the Zoning Map, Section Nos. 28d, to rezone C7 and R6 districts to R7A, R7X and R7D districts with C2-4 overlays within the proposed Special Coney Island District and to rezone C7 district to R5 outside of the Special Coney Island District.
- 3. C 090274 PQK: Acquisition of property located within the Coney East sub-district.
- **4. C 090275 PQK:** Acquisition of property located at West 19th Street and Surf Avenue for development of residential uses with ground-floor retail pursuant to the proposed zoning.
- **5.** C **090276 HAK: UDAAP** designation, project approval and disposition of City-owned property located between West 19th Street and West 20th Street and between Surf Avenue and Mermaid Avenue.
- **6.** C **090277 PPK:** Disposition of City-owned property within the Coney East sub-district.

BACKGROUND

A full background discussion and description of this application appears in the report on the related zoning text change application, N 090273 (A) ZRK.

ENVIRONMENTAL REVIEW

This application (C 090107 MMK), in conjunction with the applications for the related applications (C 090272 ZMK, N 090273 (A) ZRK, C 090274 PQK, C 090275 PQK, C 090276 HAK, and C 090277 PPK), was reviewed pursuant to the New York State Environmental Quality Review Act (SEQRA), and the SEQRA regulations set forth in Volume 6 of the New York Code of Rules and Regulations, Section 617.00 *et seq.*, and the City Environmental Quality Review (CEQR) Rules of Procedure of 1991 and Executive Order No. 91 of 1977. The designated CEQR Number is 08DME007K. The lead agency is the Office of the Deputy Mayor for Economic Development and Rebuilding.

It was determined that the proposed actions may have a significant effect on the environment. A Positive Declaration was issued on January 11, 2008, and distributed, published and filed. Summaries

of the environmental review process, the Final Environmental Impact Statement (FEIS), and the Technical Memorandum, dated June 15, 2009, appear in the report on the related zoning text change application, N 090273 (A) ZRK.

UNIFORM LAND USE REVIEW

This application (C 090107 MMK) was certified as complete by the Department of City Planning on January 20, 2009, and was duly referred to Brooklyn Community Board 13 and the Brooklyn Borough President in accordance with Title 62 of the Rules of the City of New York, Section 2-02(b).

Community Board Public Hearing

Community Board 13 held public hearings on this application (C 090107 MMK), in conjunction with the applications for the related actions (C 090272 ZMK, N 090273 ZRK, C 090274 PQK, C 090275 PQK, C 090276 HAK, and C 090277 PPK), on March 3, 2009, and on March 11, 2009. A full discussion of the Community Board 13 resolution appears in the report on the related zoning text change application, N 090273 (A) ZRK.

Borough President Recommendation

This application (C 090107 MMK), in conjunction with the applications for the related actions (C 090272 ZMK, N 090273 ZRK, C 090274 PQK, C 090275 PQK, C 090276 HAK, and C 090277 PPK), was considered by the Borough President of Brooklyn. A full discussion of the Brooklyn Borough President resolution appears in the report on the related zoning text change application, N 090273 (A) ZRK.

City Planning Commission Public Hearing

On April 22, 2009 (Calendar No. 9), the City Planning Commission scheduled May 6, 2009 for a public hearing on this application (C 090107 MMK). The hearing was duly held on May 6, 2009 (Calendar No. 24) in conjunction with the public hearings for the related actions (C 090272 ZMK, N 090273 ZRK, N 090273 (A) ZRK, C 090274 PQK, C 090275 PQK, C 090276 HAK, and C 090277

PPK).

There were several speakers as described in the report on the related zoning text change application, N 090273 (A) ZRK, and the hearing was closed.

WATERFRONT REVITALIZATION PROGRAM CONSISTENCY REVIEW

This application in conjunction with the applications for the related actions, was reviewed by the Department of City Planning for consistency with the policies of the New York City Waterfront Revitalization Program (WRP), as amended, approved by the New York City Council on October 13, 1999 and by the New York State Department of State on May 22, 2002, pursuant to the New York State Waterfront Revitalization and Coastal Resources Act of 1981, (New York State Executive Law, Section 910 *et seq.*). The designated WRP number is 08-097. This action was determined to be consistent with the policies of the New York City Waterfront Revitalization Program.

CONSIDERATION

The City Planning Commission believes that this amendment to the City Map is appropriate.

A full consideration of the issues and reasons for approving this application (C 090107 MMK) appears in the report on the related zoning text change application, N 090273 (A) ZRK.

RESOLUTION

Therefore, the City Planning Commission, deeming the proposed amendment to the City Map and any related acquisition or disposition of real property to be appropriate, adopts the following resolution:

- 2. The adverse environmental impacts disclosed in the FEIS will be minimized or avoided to the maximum extent practicable by incorporating as conditions to the approval, those mitigative measures that were identified as practicable.

The report of the City Planning Commission, together with the FEIS, and the Technical Memorandum, dated June 15, 2009, constitutes the written statement of facts, and of social, economic and other factors and standards, that form the basis of the decision, pursuant to Section 617.11(d) of the SEQRA regulations; and be it further

RESOLVED, that the City Planning Commission, in its capacity as the City Coastal Commission, has reviewed the waterfront aspects of this application and finds that the proposed action is consistent with WRP policies; and be it further

RESOLVED, by the City Planning Commission, pursuant to Sections 197-c and 199 of the New York City Charter, that based on the environmental determination and the consideration described in this report, the application (C 090107 MMK) for the amendment to the City Map involving:

- the establishment of new streets;
- the establishment of new parks and park additions;
- the modification and adjustment of grades of existing streets;
- the elimination, discontinuance and closing of portions of streets;
- the elimination of parks and portions of parks;
- the delineation of easements and corridors; and
- the extinguishment of record streets, all within an area generally bounded by West 8th Street, Surf Avenue, West 23rd Street, and the Public Beach,

including authorization for any acquisition or disposition of real property related thereto, in Community District 13, Borough of Brooklyn, in accordance with Map Nos. X-2710 and X-2711, dated January 14, 2009, revised June 17, 2009, and Map Nos. Y-2715, X-2716, X-2717, and Y-2718, dated June 17, 2009, and signed by the Borough President, is approved;

RESOLVED that, pursuant to Section 5-432 of the New York City Administrative Code, the City Planning Commission determines that "such closing or discontinuance will further the health, safety, pedestrian or vehicular circulation, housing, economic development or general welfare of the City"; and be it further

RESOLVED that, pursuant to Section 5-433 of the New York City Administrative Code, the City Planning Commission adopts the legally required number of counterparts of Map No. X-2711, dated January 14, 2009, revised June 17, and Map No. Y-2718, dated June 17, 2009, providing for the discontinuance and closing of various streets and walkways within the area generally bounded by West 8th Street, Surf Avenue, West 23rd Street, and the Public Beach, more particularly described as follows:

- Ontinuing thence northerly, along said former westerly street line of West 22nd Street, discontinued and closed, said course forming a deflection angle to the right with the last mentioned course of 1 degree 00 minutes 44 seconds, 20.00 feet to its intersection with the newly established southerly street terminus line of West 22nd Street;
- Running thence easterly, along said newly established southerly street terminus line of West 22nd Street, said course forming a deflection angle to the right with the last mentioned course of 89 degrees 31 minutes 08 seconds, 60.00 feet to the Point or Place of Beginning.
