

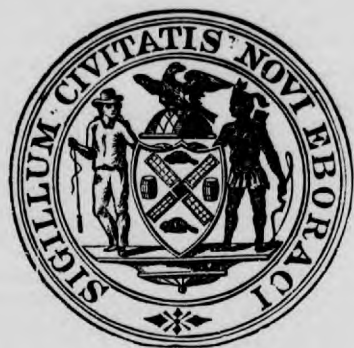

BOARD OF EDUCATION.

WEDNESDAY, May 22, 1878.

The Board of Education held an adjourned session on Wednesday, May 22d, at the hall of the Board, corner of Grand and Elm streets, at 4 o'clock P. M.

Present—Wm. Wood, Esq., President, and Commissioners Beardslee, Cohen, Dowd, Goulding, Halsted, Jelliffe, Katzenberg, Kelly, Manierre, Place, Traud, Vermilye, Watson, West, Wetmore, Wheeler, and Wickham—18.

Absent—Commissioners Bell, Donnelly, and Walker—3.

The minutes of the Session of May 15 were amended and approved.

A communication from Miss Susan Wright, Principal of Primary Department Grammar School No. 50, relative to the course of instruction, was read and ordered to be printed, and referred to the Committee on Course of Study and School Books.

Also, from Joseph Jackson, relative to the treatment of colored children in Grammar School No. 62. Referred to the Committee on By-Laws, etc.

From John B. McLean, relative to printing for the Board. Referred to the Committee on Supplies.

Several bills for work on furniture were referred to the Committee on School Furniture.

Reports from Standing Committees were presented as follows:

Commissioner Goulding presented a report from the Committee on School Furniture, recommending the payment of sundry bill for repairs, etc., to furniture. Referred to the Committee on By-Laws, Elections, and Qualifications.

Also, relative to repairs on sundry buildings, recommending advertisement and appropriation for the same. First resolution adopted, and second resolution referred to the Finance Committee.

Commissioner Katzenburg presented a report from the Committee on Warming and Ventilation, recommending sundry repairs to heating apparatus, etc. Referred to the Finance Committee.

Commissioner Watson presented a report from the Committee on Buildings, relative to sundry alterations and repairs on school buildings. Referred to the Finance Committee.

Also, to pay bills for extra work on Grammar Schools Nos. 39 and 70. Referred to the Finance Committee.

Also, to amend the lease of No. 32 City Hall place. Adopted.

Also, a majority report on the premises Nos. 15 and 17 Third street.

Commissioner Manierre presented a minority report on the same subject. Laid over, and printed in the minutes.

Commissioner Watson presented a report from the Committee on Buildings, adverse to erecting wings to Grammar School building No. 51. Adopted.

Also, relative to rehiring premises for Public School No. 21. Adopted.

Commissioner Jelliffe presented a report from the Committee on Sites and New Schools, relative to the site in Seventh street. Adopted.

Commissioner Halsted presented a report from the Committee on Teachers, relative to the salary of several Vice-Principals. Referred to the Committee on Salaries and Economy.

Commissioner Manierre presented a report from the Committee on Colored Schools, recommending an appropriation of \$800 for repairs to Colored Schools. Referred to the Finance Committee.

Commissioner Place presented a report from the Committee on Nomination of Teachers, recommending sundry appointments of Teachers. Recommended.

Commissioner Vermilye presented a report from the Finance Committee, recommending the payment of the bills of William J. O'Connor, and Knifton & Haflin, for extra work on School Buildings Nos. 39 and 70. Adopted.

On motion of Commissioner Wetmore, the report of the Committee on Nautical School, to pay the bill of Dr. Burleigh for expenses, was taken from the table and adopted.

On motion of Commissioner Wickham, the report of the Committee on School Furniture relative to Grammar School No. 15, was taken from the table and recommended.

Resolutions of thanks to several Senators and Members of the Assembly, for their attention to the Public School interests, offered by Commissioner Manierre, were adopted.

On motion, the Board adjourned.
