**Re: Agency-based Voter Registration Under LL29 of 2000, Mayoral Directive One of 2014, LL61 of 2014 and LL63 of 2014**

**January 1 through June 30, 2021 Report**

Local Law 29 of 2000 requires that specified agencies offer voter registration in their encounters with the public. Mayoral Directive One of 2014 strengthened the requirements of LL29, putting a structure in place to monitor agency efforts to increase voter registration. Local Laws 61 and 63 of 2014 increased the number of agencies required to offer voter registration.

The Board of Elections reported that it processed 1,429 voter registration applications originating at City agencies (called Code 9 applications) between January 1 and June 30, 2021. This does not include applications from DSS/HRA, where voter registration applications are offered, collected and sent to the Board of Elections under the requirements of the National Voter Registration Act (NVRA) and are not denoted as Code 9. DSS/HRA reported sending 3,132 applications to the Board of Elections during the reporting period, yielding a combined total of 4,561 City agency submissions to the Board of Elections. The total for the comparable period in 2020 was 8,271.

Some highlights of agency activities during the reporting period include:

1. The persistence of the COVID-19 pandemic continues to challenge in-person activities, including in-person voter registration activities by City agencies. As a result, City agencies have been focusing their voter registration-related activities through the mail and online:
  - a. ACS continued to chair virtual voter registration workshops via web conference and will continue to use this method and other online resources to engage New Yorkers to vote. Their focus has been educating the younger generation on the importance and purpose of voting and how the system works.
  - b. DOC: the Department distributed voter packets to all people in custody. Each packet included voter registration paperwork and absentee ballot request paperwork in both English and Spanish. The packets also included NYCCFB instructions for completing both forms, also in English and Spanish. The packets

additionally included an instructional cover page, which listed the key election and registration deadlines, as well as voter eligibility criteria with specific information for incarcerated persons. The Department also partnered with the health provider in NYC jails, Correctional Health Service (CHS), to conduct on-unit engagement and assistance.

- c. DOF: voter registration cards are also sent out by the SCRIE and DRIE units with each SCRIE and DRIE renewal application.
- d. DPR: recreation centers, which serve as a hub for voter registration and outreach, have slowly began reopening following the public health crisis. The closure has greatly impacted the Department's ability to conduct in-person outreach.
- e. TLC: focused primarily on promoting Ranked Choice Voting through bi-monthly newsletters, informational flyers and prominently posted the link on their website.

**Describe how your agency distributes applications.**

Voter registration forms are disseminated throughout ACS borough offices and youth- concentrated programs which includes The Nicholas Scopetta Children’s Center (NSCC), Family Permanency Services Housing Academy Collaborative( HAC) (a program that helps youth in foster care obtain housing) and our Youth Reception Centers. Voter registration forms are also included in hiring packets distributed by ACS Human Resources team. Many of our in-person events, meetings and ACS youth centered activities were limited to online activity this year; however, as restrictions ease, there are several in- person community events that trained ACS staff will attend over summer. ACS also chaired virtual voter registration workshops via WebEx and MS teams platforms and will continue to use this method and other online resources to engage and inform New Yorkers to vote.

**ACS Website and Social Media Page:** ACS Intranet Newsletter portal delivered content to over 6,000 staffers. The page served as a hub to provide resources promoting civic engagement info, voter registration deadlines, and information needed to engage and guide voters and potential voters in the electoral process. The information was shared via the following tech methods:

- ACS Commissioner Public Service Announcement: ACS released a PSA, available on YouTube at NYC Child Services, featuring the commissioner, encouraging ACS staff, partners, and stakeholders to register to vote, while providing general guidance on voting safely, key dates to register, alternate ways to vote in addition to in-person and voting policies. The PSA reached over 1,000 subscribers.
- ACS E- Bulletin: Early voting ad Election Day Reminders were sent out weekly reaching over 6,906 employees

**Describe any special registration activities, if any.**

**Rank the Vote: Courageous Conversations:** In the month of June, ACS held a virtual talk on how local elections can promote equity. As calls for racial justice have increasingly grown, intergenerational discussions were had in terms of finding ways to build racial equity was the focus. Strategies of how racial equity could be promoted and the ramifications of not doing so, will impact future elections. The event garnered over 100 views.

**Children’s Center (CC) Voter Registration Workshop:** ACS liased with NYC Votes/ Campaign Finance Board (CFB) and hosted several virtual interactive voter registration meeting with a focus on the young demographics and how patterns in socio-economics plays a role in voter turnout in communities with higher incomes versus those living in low-income communities. Over 30 youth from ages 15- 21 participated on the workshop. During the presentation, the NSCC youth learned how they could make an impact in their communities by volunteering, organizing community events (such as beautification projects), using their social media platforms to share information, contacting their local elected officials to insight change and other civic engagement activities.

**Paid Voter Registration Opportunities:** ACS worked with The NYC Campaign Finance Board to provide paid opportunities for our youth in care. The Campaign Finance Board was seeking youth 18 and older that speak Spanish or mandarin to participate in a focus group. The campaign Finance Board was conducting research to find ways to better connect and communicate with NYC Voters, specifically those that are underpresentes in elections. Those that participated received a \$50 visa electronic gift card.

**Election Poll Worker:** The Board of Elections (BOE) hires Poll Workers to serve at poll sites across NYC during an election. The information is shared amongst the teens in the CC and respective

facilities. Opportunities as such places or youth in the center of elections, providing them with first hand experience from meeting some of the candidates first hand and learning about the election process and engaging in civic duty.

**Family Permanency Services:** The Housing Academy Collaborative (HAC) provides a series of weekly trainings to young adults to prepare them to meet the challenges of renting an apartment and maintaining it via financial literacy, education resources, tenant rights and more. At each of these trainings a voter registration table is set up. Time is set aside in each training to discuss few voter rights and voter registration and access to voter registration applications. 5 youth were registered.

**College Internship Program:** This year the Division of Administration recruited 7 Summer College Interns. However, the Summer college interns in the Division of Administration will commence work on creating Voter Registration Info sheet, set for agency wide distribution at the end of August. The info sheet will encompass all matters as it relates to voter registration, dates of elections, poll worker information, location of voter registration site and more.

**Children's Center (CC) Voter Registration Workshop:** ACS is again liasing with the Campaign Finance Board (CFB), bringing in a series of new trainings and workshops to engage youth at the Children's Center, Youth Residential Centers, and The Housing Academy Collaborative. The division of administraion also coordinates with ACS Divisions- Family Permancecy Services (FPS), Division of Youth and Family Justice(DYFJ), and Division of Child Protection (DCP) to enagage youth in the voting process through education programs and to provide information and skills to become an enagedd and informed citizen. The NYC Votes Civic Engagement Course is a series of three trainings + workshops designed to provide context for why voting and local government are important and to give youth the skills needed to organize their own community events. While this series is youth-focused, we are hoping to include in future programs educators, service providers to host an intergenerational communication around voting and civic- engagement.

### 1. Youth Civic Engagement Workshop

- Our Civic Engagement Workshop provides an on overview into why voting at the local level is so important. ACS teens will learn about how New York City youth turnout to vote, what each elected official does at the local level, and how to encourage other young New Yorkers to show up at the polls.

### 2. Voter Mobilization Training

- In this training, teens will be walked through the process of how to organize and execute a voter registration drive. Youth will have the opportunity to break out into small groups and make a plan for implementing a drive. Small groups will then share out their ideas and we will workshop them together.

### 3. Ranked Choice Voting Train the Trainer

- In this train-the-trainer, youth learn about Ranked Choice Voting and how it works, but they also receive training in how to host their own forum about RCV with their peers, adults, and senior citizens in their communities. This is being built in partnership with the Civics for All team at the Department of Education.

**Voter Registration Challenges:** Planned for this year's National Voter Registration Day in Septemnberr, ACS will coordinate a friendly divisional "Voter Registration Challenge". Whichever division registers or host the most voter registration drives will be recognized on an agency wide level.

**Describe challenges, both resolved and unresolved.**

While most restrictions for in-person engagement has been lifted, many of our youth centered activities are still being conducted virtually.

**Challenge:**

While ACS campaign supports all those eligible to vote, our target audience is centered around the young adult population. Based off some of the responses received from our youth in care from our online trainings, many are unaware of just how government and elections work or sometimes feel they do not have enough info on the candidates and forgo registering to vote or vote at all. Some of the teens surveyed shared their distrust of the government and expressed their vote won't make a difference.

Through the NYC Campaign Finance Board Trainings, discussion circulate around helping the younger generation discover why voting matters and how issues can be addressed by getting to know your local community leaders and attending community discussion events, such as board and town hall meetings.

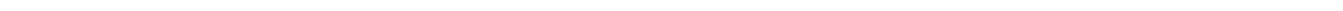

Describe how your agency distributes applications.

Due to COVID-19, the Department suspended the majority of in-person and volunteer services program provision. As a result, in advance of the June Primary election, the Department distributed voter packets to all people in custody. Each packet contained voter registration paperwork and absentee ballot request paperwork in both English and Spanish with information on how to request additional languages. The packets also included NYCCFB instructions on how to complete both forms and NYCCFB information on Ranked Choice Voting, also in English and Spanish. The packets additionally included an instructional cover page, which listed the key election and registration deadlines, as well as voter eligibility criteria with specific information for incarcerated persons. The Department also partnered with the health provider in NYC jails, Correctional Health Service (CHS), to conduct in-person engagement and assistance.

Describe any special registration activities, if any.

Prior to the June Primary election, DOC conducted limited in-person voter registration drive and engagement efforts in collaboration with CHS staff who also in-person engagement. Additionally, voter registration information was made available through informational flyers distributed weekly to the incarcerated population and voter educational posters were placed in housing areas. The Department partnered with Columbia University's Eric H. Holder Jr. Initiative for Civil and Political Rights to offer a voter assistance hotline on selected days to answer questions and assist persons in custody with completing forms, including voter registration.



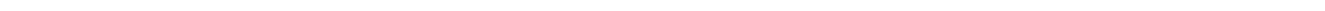

Describe challenges, both resolved and unresolved.

As with the previous reporting period, conducting civic engagement and registration activities, especially in-person efforts, remains a major challenge due to circumstances related to a global pandemic. The majority of in-person DOC activities, including volunteer services program provision continued to be suspended due to COVID-19. In consideration of the challenging circumstances that limited the return of a pre-pandemic level in-person civic engagement, the Department created and distributed non-partisan voter registration information and materials to the incarcerated population. The voting packets ensured that all individuals in custody were afforded the information and opportunity to register and vote in the June Primary election. In addition to the voter packets, the Department provides individuals in custody with three free weekly stamps or pre-stamped envelopes, which can be used to send voter registration and absentee ballot request forms should individuals choose not to have Department staff collect and hand-deliver their forms to the respective BOE office. The Department also operates a social services request system using paper request slips that can be utilized to provide voter documents in various languages and to provide voter assistance, when requested.

To ensure the Commission's staff can best address the needs of the public in a way that complies with health and safety guidance, the Commission schedules appointments to ensure we're best prepared for that meeting. *Describe challenges, both resolved and unresolved.*

Challenges noted in prior reports remain. While the Commission continues to serve and reach thousands of individuals during the COVID-19 pandemic, it is not able to track how many people who receive links to voter registration materials use them, analogous to the same challenges noted in prior reports to the distribution of hard copy voter registration forms which the public may use but which are not submitted to the agency.

There are a number of factors that may determine the number of people served. They include the number of individuals in attendance at Commission workshops, presentations, and conferences, the number of intakes conducted by the Law Enforcement Bureau, and the number of those who use online resources to access the electronic voter registration form. It may also be determined by the virtual setting, technological platform, and type of event taking place, as well as the extent to which technology is accessible to the public. Although there has been a significant increase in the use of technology by the public, access to technology and electronic means of communication is still not completely widespread for a variety of reasons.

Another reality influencing the number of electronic voter registration forms that are submitted to the Board of Elections is the receiving population's eligibility to vote. Commission events are regularly frequented by individuals who may not be eligible to vote, which may depress the number of voter registration forms that are accessed, filled out, and ultimately submitted online.

Continuing to emphasize the importance of political engagement to the public across all channels may contribute to an increased number of distributions and submissions.

Describe how your agency distributes applications.

The TLC currently maintains a staff of approximately 600 employees, many of whom interface daily with TLC licensees. However, the COVID-19 pandemic has limited these face to face interactions during this reporting period. The agency also provides TLC employees with helpful resources from organizations and other city agencies.

We are targeting these two groups by distributing forms in four separate ways to various TLC divisions and departments:

- **Human Resources** (located in Lower Manhattan) includes registration forms in hiring packets for new employees.
- **Policy/External Affairs** (located in Lower Manhattan) distributes voter registration forms at outreach events and presentations to licensees and driver industry stakeholders across all 5 boroughs.
- **Licensing Division** (located in Long Island City, Queens) has forms available for visitors to take at its licensing transaction counters. We keep about 300 applications available for distribution at all times. Also, information on how to contact the Board of Elections is included on many TLC-issued forms for licensees.
- **Safety + Emissions Division** (located in Woodside, Queens & Staten Island) has forms available for distribution at its counter operations that licensees must visit on a regular basis (ranging from three times a year to once every two years) for inspection of their vehicle.

By using these targeted strategies, TLC helps TLC licensees and incoming employees receive voter registration information.

*Describe any special registration activities, if any.*

COVID-19 continues to limit in person voter registration activities. However, we continue to promote voter registration information to our TLC-Licensed Drivers. This year we also promoted information about Ranked Choice Voting (RCV).

The TLC promoted RCV in the following ways:

- RCV information was featured in our our bi-monthly newsletter [Keys to the City](#). Our newsletter is sent to all TLC-Licensed Drivers (over 200,000 people).
  - April Newsletter (Sent 3/5): Informed Drivers that RCV will be used in the June 22<sup>nd</sup> Primary. Drivers were encouraged to check their registration status and register to vote if eligible before the 5/28 registration deadline to vote in the June primary.
  - June Newsletter (Sent 6/10): Informed Drivers that the June 22<sup>nd</sup> Primary will utilize RCV , and provided information on the different methods of voting absentee ballots, early voting, and voting on election day. Drivers were also provided a link to look up their poll site location.
- Multiple emails were sent to Drivers regarding the June 22<sup>nd</sup> primary and RCV. Similar to Keys to the City, emails were sent to all TLC-Licensed Drivers (over 200,000 people).
  - May 19<sup>th</sup> Email: Informed Drivers that RCV will be used in the June 22<sup>nd</sup> Primary. Drivers were encouraged to check their registration status and register to vote before the 5/28 registration deadline for the June primary.
  - June 22<sup>nd</sup> Email: Drivers were reminded that June 22<sup>nd</sup> is election day, and that RCV will be used in the election. Drivers were encouraged to vote and were provided with a link to look up their poll site location.
- RCV Informational flyers were made available next to our voter registration forms at our Long Island City facility.
- RCV is currently featured on our [homepage carousel](#)
- We posted several times about RCV across various social media platforms.
- All TLC employees were notified about the June 22<sup>nd</sup> primary and RCV on the first day of early voting (June 12<sup>th</sup>). Emploeyss were also provided with a link to look up their poll site location.

*Describe challenges, both resolved and unresolved.*

Encouraging drivers to take the time to fill out voter registration forms at tabling events, continues to be a challenge.

COVID-19 Challenges

- There were no public facing events during the reporting period. Before Covid-19, Policy/External Affairs attended multiple public facing events where registration forms were made available to our licensees, as well as the general public.

Describe how your agency distributes applications.

DOT remains committed to registering voters during the Covid-19 pandemic. At the end of March 2020, due to Covid-19, DOT’s public service centers (PSCs) closed. DOT will resume distribution of the voter registration packets as soon as the PSCs reopen. Prior to the pandemic, printed voter registration (VR) material was distributed. That was curtailed until Q3 of 2021, when DOT resumed mailing printed VR forms with all document requests. Since July 2020, DOT has also included PDFs of VR packets emailed directly to customers:

- 1) CSLACU includes VR packets with every piece of correspondence sent to customers.
- 2) DOT customers calling 311 are sent VR packets.
- 3) The DOT website has a “Register to Vote” icon/tile on its landing page. The hyperlink sends DOT customers directly to “nyc votes”.

Describe any special registration activities, if any:

Pre-Covid-19, DOT distributed voter registration materials at all DOT outreach events. DOT will resume this practice at expanded outreach events once it is safe to do so.

Describe challenges, both resolved and unresolved:

It is impossible for DOT to know which customers receiving the VR packets with their correspondence and/or documents, or visiting DOT’s PSCs (when they reopen) are already registered to vote. DOT can readily disseminate the voter registration materials, but cannot compel customers to complete the forms and return them to the Board of Elections, or submit them to the PSC managers (when the PSCs reopen). If completed forms are not collected on-the-spot and sent to the BOE by the PSC managers, it is not possible to monitor and track the level of customer participation and the number of forms being returned to the Board of Elections.
