


I. Population Change: Total Population in DOC Custody

Total DOC Population by Custody Status January 29, 2022 – February 4, 2022





I. Population Change: City Sentenced Population by Custody Status


City Sentenced Population by Custody Status January 29, 2022 – February 4, 2022





Number and Percent of Patients Ever Confirmed Positive for COVID-19 While in Custody January 29 – February 4, 2022




Number of Incarcerated Patients Ever Confirmed Positive for COVID-19 While in Custody March 17, 2020 – February 4, 2022






Number of People in Likely Exposed but Asymptomatic Housing


Number of People in Confirmed/Symptomatic Housing March 16, 2020 – February 4, 2022

Number and Percent of Open Cell and Dorm Units Above and Below 50% Capacity February 3, 2022




Number and Percent of Open Units Above and Below 50% Capacity by Housing Category February 3, 2022
