

AQUEDUCT COMMISSION.

Minutes of Adjourned Meeting of the Aqueduct Commissioners, held at their Office, No. 209 Stewart Building, on Thursday, January 2, 1890, at 3 o'clock P. M.

Present—Commissioners Duane, Tucker, Scott and Howe.

The minutes of the stated meeting of December 18, and of the adjourned meeting of December 26, 1889, were read and approved.

The Committee of Finance and Audit reported their examination and audit of bills contained in Vouchers Nos. 5459 to 5475, inclusive, amounting to \$1,536.24; also of Vouchers Nos. 5476 and 5477, being estimates for gate-house superstructure walls for blow-off chamber at Ardsley, and for grouting between Stations 778 and 779+30, amounting to \$5,485.

On motion of Commissioner Howe, the same were approved, and ordered certified to the Comptroller for payment.

The Construction or Executive Committee presented the resignation of Inspector of Masonry W. B. Osterhout, and recommended that the same be accepted, to take effect as of December 30,

On motion of Commissioner Howe, the same was accepted.

The Committee also reported in favor of the adoption of the following resolution:

Resolved, That, upon the recommendation of the Chief Engineer, Edward L. Ripley is hereby appointed Helper on one of the diamond drill parties, with compensation at the rate of \$65 per month, to fill a vacancy made by the retirement of Samuel Elkins; and John Currie is hereby appointed a Laborer for one of the drill parties in the Croton Basin, with compensation at the rate of

"Resolved, That the Aqueduct Commissioners hereby determine upon and direct the construction of a main dam and reservoir to be known as Reservoir D, on the West Branch of the Croton river, near Carmel, on the New York and Northern Railway, in Putnam County, New York; and the Commissioner of Public Works is hereby requested to prepare and submit to us plans, maps, specifications, estimates and details to provide for the construction of said dam and reservoir; and the Secretary is hereby directed to take the necessary steps to provide for giving notice of a public hearing thereon"; and

Whereas, A copy of the foregoing resolution was duly transmitted to the Commissioner of Public Works on the 21st of May, 1889; and
Whereas, On the 15th day of August, 1889, the Secretary of the Commission, by direction of the Construction Committee, again transmitted a copy of said resolution to the Commissioner of Public Works and requested the said Commissioner of Public Works to furnish the maps, plans, etc.,

referred to in said resolution; and
Whereas, The Commissioner of Public Works has not complied with the request contained in the foregoing resolution, and has given no reason for non-compliance therewith, except that contained in a letter, dated September 4, 1889, in which he stated that the work of surveying the dam site for said Reservoir D could be proceeded with as soon as the survey of the dam site for Reservoir

M had been completed; and
Whereas, The final plan sheets and property maps for the dam site of said Reservoir M have
long since been completed, certified and filed; and
Whereas, On the 13th day of December, 1889, the President of the Commission, by instruction of the Committee on Construction, again addressed a letter to the Commissioner of Public

Works, asking for information as to what progress, if any, had been made with reference to the surveys for said dam site for Reservoir D, to which no reply has been received; and

Whereas, The Aqueduct Commission is powerless to proceed with the construction of said dam and reservoir until the said Commissioner of Public Works shall comply with the request contained in said resolution; and

Whereas, In the opinion of the Aqueduct Commission, it is of the utmost importance that additional storage should be provided at the earliest possible moment, and that any delay in commencing the work of constructing the dams and reservoirs already determined upon, including said Reservoir D, will prove to be detrimental to the best interests of the City of New York; therefore

Resolved, That the Commissioner of Public Works be and hereby is requested to advise this Commission what progress has been made with the preparations of the surveys, maps, plans, etc., asked for in the resolution of May 15, 1889, and at what date he will be able to submit to the Aqueduct Commission a survey of the dam site, in order that a final plan sheet may be prepared.

On motion of Commissioner Scott, the preambles and resolution were adopted; and the Secretary was directed to transmit a copy of the same to the Commissioner of Public Works.

ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1880), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty, containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, ir writing, specifying the ward number and street number of the lot, that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns, shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

PUBLIC NOTICE AS TO WATER RATES. PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887 the following changes are made in charging and collect new water repris.

the following changes are made in charging and conecting water rents:

1. 1st. All extracharges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretotore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prolibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1881, will be canceled of record on the books of the Department.

REGULATIONS ESTABLISHING A SCALE OF WATER RENTS AND RULES GOVERNING THE USE OF WATER, FOR THE CITY OF NEW YORK, BY ORDER OF THOMAS F. GILROY, COM-MISSIONER OF PUBLIC WORKS.

UNDER CHAPTER 410, LAWS 1882, SECTIONS 350, 351, 352 and 353, and as amended by chapter 559, Laws 1887, as follows:

"The commissioner of public works shall, from time to time, establish scales of rents for the supplying of water, which rents shall be collected in the manner now provided by law, and which shall be apportioned to different classes of buildings in said city in reference to their dimensions, values, exposure to fires, ordinary uses for dwellings, stores, shops, private stables and other common purposes, number of families or occupants, or consumption of water, as near as may be practicable, and modity, alter, amend and increase such scale from time to

The rent of all tenements which shall exceed in width fifty feet shall be the subject of special contract with the Commissioner of Public Works.

The apportionment of the regular rents upon dwelling-houses are on the basis that but one family is to occupy the same, and for each additional family, one dollar per year shall be charged.

Meters will be placed on all houses where waste of water is found, and they will be charged at rates fixed by the Department for all the water passing through them.

The extra and miscellaneous rates sha be as follows, to wit:

BAKERIES.—For the average daily use of flour, for each barrel, three dollars per annum.

BARBER SHOPS shall be charged from five to twenty dollars per annum each in the discretion of the Commissioner of Public Works: an additional charge of five dollars per annum shall be made for each bathtub therein

BATHING TUBS in private houses, beyond one, shall be charged at three dollars per annum each, and five dollars per annum each in public houses, boarding-houses, and bathing establishments. Combination stationary wash-tubs, having a movable division in the centre and capable of use for bathing, shall be charged the same as bathing tubs.

BUILDING PURPOSES.—For each one thousand bricks laid, or for stone-work—to be measured as brick—ten cents per thousand. For plastering, forty cents per hundred yards.

COWS.—For each and every cow, one dollar per annum. DINING SALOONS shall be charged an annual rate of from five to twenty dollars, in the discretion of the Commissioner of Public Works.

1.SH STANDS (retail) shall be charged five dollars per annum each.

For all stables not metered, the rates shall be as follows: Horses, Private.—For two horses there shall be charged six dollars per annum; and for each additional horse, two dollars.

Horses, Livery.—For each horse up to and not exceeding thirty in number, one dollar and fifty cents each

For all stables not metered, the rates shall be as follows:
Horses, Private.—For two horses there shall be charged six dollars per annum; and for each additional horse, two dollars.
Horses, Livery.—For each horse up to and not exceeding thirty in number, one dollar and fifty cents each per annum; and for each additional horse, one dollar horses, Omnibus and Cart.—For each horse, one dollar per annum.
Horse Troughs.—For each trough, and for each half barrel or tub on sidewalk or street, twenty dollars per annum; each trough is to be fitted with a proper ball-cock to prevent waste.
Hotels and Boarding Houses shall, in addition to the regular rate for private families, be charged for each lodging room, at the discretion of the Commissioner of Public Works.
LAUNDRIES shall be charged from eight to twenty dollars oer annum; in the discretion of the Commissioner of Public Works.
Liquor and Lager Beer Saloons shall be charged an annual rate of ten dollars each. An additional charge of five dollars per annum shall be made for each tap or wash-box.
Photograph Galleries shall be charged an annual rate of from five to twenty dollars, in the discretion of the Commissioner of Public Works.

Printing Offices, when not metered, shall be charged at such rates as may be determined by the Commissioner of Public Works.

Soda, Minwral Water and Root Beer Fountains shall be charged five dollars per annum each.

Steam Engines, where not metered, shall be charged by the horse-power, as follows: For each horse-power up to and not exceeding ten, the sum of ten dollars per annum; for each exceeding ten, and not over fifteen, the sum of seven dollars and fifty cents each and for each horse-power over fifteen, the sum of lower dollars for each exceeding ten, and not over fifteen, the sum of the private and the charged two dollars per annum, whether in a building or on any other portion of the prem

drawn by holding up the handle, per year, each, five dollars.

For any form of hopper or water-closet, supplied from any of the forms of waste-preventing cisterns, that are approved by the Engineer of the Croton Aqueduct, which are so constructed that not more than three gallons of water can be drawn at each lift of the handle, or depression of the seat, if such cisterns are provided with an overflow pipe, such overflow pipe must not connect with the water-closet, but be carried like a safe-waste, as provided by the Board of Health regulations, per year, two dollars.

Cistern answering this description can be seen at this Department,

Under the provisions of section 352, Consolidated Act 1882, water-meters, of approved pattern, shall be hereafter placed on the pipes supplying all stores, workshops

hotels, manufactories, public edifices, at wharves, terry-houses, stables, and in all places where water is furnished for business consumption, except private dwellings. It is provided by section 352, Laws of 1882, that "all expenses of meters, their connections and setting, water rates, and other lawful charges for the supply of Croton water, shall be a lien upon the premises where such water is supplied, as now provided by law." * *

All manufacturing and other business requiring a large supply of water will be fitted with a meter.

The rate charged for steam-vessels taking water daily or belonging to daily lines, is one-half cent, per ton (Custom House measurement) for each time they take water. Steamers taking water other than daily, one cent per ton (Custom House measurement).

Water supplied to sailing vessels and put on board, twenty-five cents per hundred gallons.

All matters not hereinbefore embraced are reserved for special contract by and with the Commissioner Public Works.

HYDRANTS, HOSE, TROUGHS, FOUNTAINS, ETC., ETC.

No owner or tenant will be allowed to supply water to another person or persons.

All persons taking water from the City must keep their own service-pipes, street tap, and all fixtures connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste of mater.

their own service-pipes, street tap, and all fixtures connected therewith, in good repair, protected from frost, at their own risk and expense, and shall prevent all waste of vaster.

The use of hose to wash coaches, omnibuses, wagons railway cars or other vehicles or horses, cannot oe permitted.

No horse-troughs or norse-watering fixtures will be permitted in the street or on the sidewalk, except upon a license or permit taken out for that purpose. Allicenses or permit must be annually renewed on the first of May. Such fixtures must be kept in good order and the water not allowed to drip or waste by overrunning the sidewalk or street, or to become dangerous in winter by freezing in and about such troughs or fixtures. No hydrant will be permitted on the sidewalk or in the front area, and any hydrant standing in a yard or alley, attached to any dwelling or building, must not be left running when not in actual use, and if the drip or waste from such hydrant freezes and becomes dangerous in winter, the supply will be shut off in addition to the penalty of five dollars imposed.

Taps at wash-basins, water-closets, baths and urinals must not be left running, under the penalty of five dollars for each offense, which will be strictly enforced.

Fountains or jets in hotels, porter-houses, eating-saloons, confectioreries or other buildings are strictly prohibited.

The use of hose for washing sidewalks, stoops, areas, house-fronts, yards, court-yards, gardens, and about stables, is prohibited. Where premises are provided with wells, special permits will be issued for the use of hose, in order that the police or inspectors of this department may understand that the permission is not for the use of Croton water.

Opening fire-hydrants to fill hand sprinklers or other vessels will not be allowed.

The penalty for a violation of any of the preceding rules and regulations will be five dollars for each offense, and if not paid when imposed will become a lien on the premises in like manner as all other charges for unpaid wate

NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

ject can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore given to all householders that, in all turther applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occurrant of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will he allowed for any portion of one year.
