Whereas, By the provisions of the lease made by the Mayor, Aldermen and Commonalty to the New York Central and Hudson River Rail Road Co., for certain land under water between Sixtieth and Sixty-fifth streets, North river, and dated June 22, 1874, this Department granted permission to

said Company to erect on said premises two piers, each of a width of 80 feet; and
Whereas, The said Company now desire to change the construction of said two piers, and have
applied for permission to increase the width thereof to 100 feet each, and to erect them upon an angle extending southerly from the bulkhead instead of at right angles thereto, in order that the said piers may afford better terminal facilities for the business of the said Company; and
Whereas, It is the earnest desire of this Board to advance the interests of the City, by exercising

all lawful powers at its command, towards improving all terminal facilities whenever required; there-

Resolved, That the plan for the lines for the said piers referred to in said lease, and annexed thereto, be and is hereby changed, altered and amended, so as to permit both of said piers to be of a width of 100 feet each, and to be constructed at angles extending southerly from the bulkhead; and

Resolved, That permission be and is hereby granted to the said company, to erect and maintain on the southerly pier of the said two piers, an Elevating Warehouse to facilitate the receiving and discharging of cargo received thereat by steam transportation; provided that the said two piers be constructed so as not to obstruct the free flow and ebb of the tide, and upon plans to be first approved by the Engineer-in-Chief of this Department, and that all the work of making said improvements be done under the supervision of that officer; and provided further that the said Elevating Warehouse be constructed subject to the regulations of the Superintendent of Buildings, and upon plans to be first approved by the said Engineer-in-Chief of this Department, in conformity with the provisions of chapter 240. Laws of 1875.

2 public buildings, 735 tenement-houses, 167 private dwellings, 90 other dwellings, 11 manufactories and workshops, 15 stores and warehouses, 36 stables, 41 slaughter-houses, 1 head-cleaning establishment, 3 public sewers, 2 manure dumps, 1 garbage dump, 1 fat-rendering establishment, 28 sunken and vacant lots, 60 yards, courts, and areas, 85 cellars and basements, 183 waste-pipes and drains, 139 privies and water-closets, 28 streets, gutters, and sidewalks, 2 dangerous stairways, 3 smoky chimneys, 3 piggeries, 9 other nuisances, together with 70 visits of the Sanitary Inspectors to cases of contagious disease.

The number of reports thereon received from the Inspectors was 609.

During the past week 117 complaints were received from citizens and referred to the Sanitary and Assistant Sanitary Inspectors for investigation and report.

Permits were issued to the consignees of 61 vessels to discharge cargoes, on vouchers from the Health Officer of the Port.

SI permits were granted scavengers to empty, clean, and disinfect privy-sinks.

The Disinfecting Corps have visited 44 premises where contagious diseases were found, and have disinfected and fumigated 39 houses, 39 privy-sinks, together with clothing, bedding, etc.

2 cases of contagious disease were removed to the hospital by the Ambulance Corps.

Sir—509 deaths were reported to have occurred in this city during the week ending Saturday, April 6; this is a decrease of 21, as compared with the preceding week, and 58 less than the number reported for the week ending March 23, but is 27 more than the number-reported for the corresponding week of 1877. The actual mortality for the week ending March 30 was 514, which is 27.2 below the average of the corresponding weeks of the past five years, and represents an annual death-rate of 24.75 per 1,000 inhabitants, the population estimated at 1,079,755.

There were 309 deaths, or 67.07 per cent. of the total weekly mortality from the following 8 diseases, viz.: phthisis pulmonalis, 79; pneumonia, 62; bronchitis, 36; diseases of the nervous system, 43; diphtheria, 23; diseases of the heart, 22; and Bright's disease and nephritis 21. The following diseases showed a decrease in the number of deaths compared with the preceding week, viz.: small pox, 1: measles, 1; scarlatina, 5; inanition, 1; cancer, 5; phthisis pulmonalis, 4; pneumonia, 3; diseases of the heart, 8; diseases of the brain and nervous system, 6; enteritis, gastritis, and peritonitis, 4: Bright's disease and nephritis, 7; cyanosis and atelectasis, 1; and premature and preternatural births, 4; while croup increased 3; erysipelas, 5; cerebro-spinal fever, 3; malarial fevers, 7; puerperal diseases, 7; diarrhocal diseases, 5; rheumatism and gout, 5; bronchitis, 2; marasmus and scrofula, 1; hydrocephalus and tubercular meningitis, 4; cirrhosis and hepatitis, 1. Diphtheria caused 23 deaths; whooping cough, 6; typhoid fever, 1; and aneurism, 2, which was the same number reported for the preceding week.

Of the total number of deaths reported for the week, 97 were in institutions, 249 in tenement houses, 157 in houses containing three families or less, 2 in hotels and boarding-houses, 4 in rivers, streets, boats, etc.; 6 were on the basement floor, 90 on the first, 148 on the second, 99 on the third, 52

(Roman Catholic), 3; Washington (undenominational), 1.
