The 727 deaths represent a death-rate of 20.43 against 19.54 for the previous week, and 24.49 for the corresponding week of 1891.

The increase of 32 deaths over the previous week was mainly due to an increase of 7 in the deaths from diphtheria, of 8 from cancer, of 22 from phthisis, and of 19 from diseases of the nervous system, partially offset by a decrease of 13 in the deaths from bronchitis, of 5 from croup, and of 10 from pneumonia.

The deaths from diphtheria were most numerous in the Nineteenth Ward, from measles also in the Nineteenth Ward, from scarlet fever in the Twenty-third Ward, and from typhoid fever in the Twentieth Ward.

DEPARTMENT OF DOCKS.

At an adjourned meeting of the Board of Docks of the City of New York, held at the office of the Board, Pier "A," Battery place, Tuesday, December 13, 1892, at 11 o'clock A. M.

Present—President Cram.

The minutes of the meeting held the 8th instant were read and approved.

George X. M. Collier, attorney, residing in Detroit, Michigan, was present and stated that he was duly authorized to represent the following parties, owners in part of Pier, old 5, North river, and the adjoining bulkhead, viz.: Mary Robinson, Lucretia Lull, Lewis Brown, Martha A. Lull, and Jennie M. Collier. He informed the Board that his clients declined its offer of June 9, 1892, to purchase said pier and bulkhead, but would be willing to sell, and would in a short time submit an offer to the Board.

Vernon H. Brown, agent of the Cunard Steamship Company (Limited), appeared and renewed his application of June 30, 1892, for a lease of Pier, new 40, North river, when extended, and agreeing to cancel the existing lease of said pier.

On motion, the following preamble and resolutions were adopted:

Whereas, At a meeting of the Board of Docks held this date, Vernon H. Brown, agent of the Cunard Steamship Company (Limited), appeared before the Board and offered to cancel the existing lease of Pier, new 40, North river, provided the Board would grant said company a lease for a term of ten years, with the privilege of renewal for a further term of ten years of said pier, to commence upon completion of the extension of said pier, and agreeing to pay a rental of thirty-six thousand five hundred dollars (\$36,500) for the first term of ten years, and forty thousand one hundred and fifty dollars (\$40,150) for the second term of ten years; now, therefore, be it

Resolved, That by virtue of the power and authority vested in this Board, and in pursuance of the statutes in such cases made and provided, this Department hereby agrees to lease, assign and to farm-let to the Cunard Steamship Company (Limited), all and singular, the wharfage which may arise, accrue or become due in the manner and at the rates prescribed by law for the use and occupation of Pier, new 40, North river, as extended, together with the shed thereon and the shed to be erected on the extension by said company, for a period of ten years from the date of the completion of said extension, for the sum of thirty-six thousand five hundred dollars (\$36,500) per annum, payable quarterly in advance to the Treasurer of this Department. The said lessee shall have the privilege of a renewal of said lease for a further term of ten years, upon three months' notice being given prior to the expiration of the first term; the rental for the second term of ten years to be forty thousand one hundred and fifty dollars (\$40,150) per annum, payable quarterly in advance as above. The said lease, or any renewals thereof, shall contain the usual covenants and conditions as at present embodied in the lease of wharf property now used by this Department.

Provided, the Cunard Steamship Company (Limited) release the City of New York from any and all claims for damage by reason of the construction of the new stone bulkhead under and pursuant to the new plan for the improvement of the water-front of the City of New York, adopted in accordance with the provisions of chapter 574 of the Laws of 1871, in front of that portion of the westerly side of West street, running 75 feet northerly from the northerly side of Clarkson street, and provided that Daniel D. Lord convey to the City of New York all his right, title and interest in and to the bulkhead along the westerly side of West street, running 75 feet northerly from the northerly side of Clarkson street.

Resolved, That permission be and hereby is granted to the Cunard Steamship Company (Limited), to erect a shed upon the extension to Pier, new 40, North river, in accordance with plans to be submitted to and approved by this Board; the said shed to be erected at the cost and expense of the Cunard Steamship Company (Limited), under the supervision of the Engineer-in-Chief of this Department. The title and ownership of said shed, whenever completed and ready for occupancy, shall thereupon become vested in and owned by the Mayor, Aldermen and Commonalty of the City of New York, free of all claims, charges and incumbrances of any kind whatsoever.

It being understood that the above preamble and resolutions shall be of no force or effect unless the Cunard Steamship Company (Limited) file in this office, within thirty days from date, of the receipt of said preamble and resolutions, their written acceptance of the terms and conditions thereof.

Whereas, The Board of Dock Commissioners, at its meeting of July 7, 1892, adopted a resolution deeming it advisable to change the location and width of Pier, new 22, North river, near the foot of Jay street, from the location therefor as laid down on the plans determined by the Board of Dock Commissioners April 13, 1871, adopted and certified to by the Commissioners of the Sinking Fund April 27, 1871, and requesting the consent and approval of this Board to the proposed change, as follows:

Whereas, the change recommended is: Beginning at a point in the bulkhead line established in 1871, distant 316.90 feet northerly from the northerly side of Pier, new 21, as it now exists; thence westerly in a line making an angle of 89 degrees 47 minutes 40 seconds with the said bulkhead line on the southerly side, 100 feet; thence southerly and at right angles with the preceding course 28 feet; thence deflecting to the west through an angle of 70 degrees 29 minutes 23 seconds and running southwesterly 170.67 feet; thence deflecting to the north through an angle of 19 degrees 30 minutes 37 seconds and running thence westerly and parallel to the first-mentioned course 423.88 feet to the pier-head line determined by the Department of Docks July 3, 1890, and approved by the Commissioners of the Sinking Fund July 24, 1890; thence southerly and along said pier-head line 80.02 feet; thence easterly and parallel to the first-mentioned course 425.58 feet; thence deflecting to the south through an angle of 16 degrees 22 minutes 13 seconds and running southeasterly 166.76 feet; thence deflecting to the south through an angle of 73 degrees 37 minutes 47 seconds and running southerly and at right angles with the first-mentioned course 28 feet; thence easterly and parallel with the first-mentioned course 100 feet to the aforesaid bulkhead line; thence northerly along said bulkhead line 240 feet to the point or place of beginning.

Resolved, That the Commissioners of the Sinking Fund hereby consent to and approve of the change in the length and width and location of a pier to be erected near the foot of Jay street, North river, to be known as Pier, new 22, in accordance with the plan approved and adopted by the Commissioners of Docks, under a resolution adopted by them on said July 7, 1892, as above described and as exhibited on the maps submitted therewith.

Submitting a list of expenses incurred in the examination of the title of the bulkhead property on West street, twenty-five feet south of Houston street, formerly owned by the Protestant Episcopal Church Missionary Society for Seamen. be revoked, for the reason that said bulkhead is leased to the New York Central and Hudson River Railroad Company, and reporting that instructions have been issued to the Dock Master directing him to allow said boats to be unloaded at the inner end, south side, of Pier, new 60, North river, at ordinary wharfage rates.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1889), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees and their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act:

When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
