

William Walsh, which occurred at his residence in this city on the 7th inst.; and
Whereas, As the deceased during his lifetime was beloved by all who knew him for his simplicity, honesty and fidelity, so in death his memory will be cherished, and the example of his exemplary life, both public and private, will be held up for emulation by all who admire the upright man, the good citizen, the honest public official, the devoted husband and father ; and
Whereas, His election by the people of the district in which he resided as a member of the Assembly of this State, and as member of the Board of Aldermen of this city, and by that body as its president, and ex-officio Mayor, supplemented by his elevation by the people of this county to the office of County Clerk, testified unmistakably that he was a man of rare talent and ability, and that he possessed in a marked degree the confidence and esteem of the people of this city and county.
