REPORT:

It is a subject of reproach to the city authorities that the bill has not before this been finally acted upon. The expense was incurred in receiving and enter-taining a dignitary from a foreign country, upon the recommendation of the late Mayor Have-meyer, and simple equity would seem to require that the bill so incurred be paid, if not as presented, then at such a sum as should appear, upon examination, to be just. The credit of the city and its good faith as a debtor is involved. This delay or indifference in the liquidation of the indebtedness of the city will injure the reputation of our people for homitality, as it will be claimed that while good faith as a debtor is involved. This delay of indifference in the inquidation of the indebtedness of the city will injure the reputation of our people for hospitality, as it will be claimed that while making a great public display of this civic virtue, as in the case under consideration, the individuals who supply the means have themselves to bear the expense in consequence of the neglect or refusal of the city to pay the bills. It may, and doubtless will be said that the amount of the bill is excessive; that extravagance and waste took place in the lavish use of wines, cigars, coaches, etc., on the occasion. The objection may be good, and is doubtless too true; but who is to blame? Certainly not the proprietors of the hotel, as they acted under orders from the Committee of the Common Council, appointed to receive and entertain the king, and if that Committee neglect or refuse to testify to the correctness or falsity of the charges, as it has done, in order to furnish data upon which to arrive at a just conclusion, can the hotel people be held responsible? Clearly not. Your Committee, believing that this claim should be paid, endeavored to as certainfor themselves

what would be an equitable sum to allow. From a report made on this subject by the Committee on Printing and Advertising of the late Board of Aldermen, your Committee find the following : "That the Special Committee insisted upon having assigned a suite of rooms upon the first floor of the hotel for the king, and, in order to obtain them, a gentleman who occupied them with his family, and for which he paid three hundred and fifty dollars per week, was obliged to vacate. Dinners for twelve persons were ordered every day by the Committee, and, on an average, sixteen others were daily invited and attended, and the most costly wines, cigars, etc., supplied. Delegations of army daily invited and attended, and the most costly wines, cigars, etc., supplied. Delegations of army and navy officers, the Board of Trade, and other associations were constantly presented and received, and, on one occasion, the carpeting on the Committee's room was entirely spoiled, and cost six hun-dred dollars to replace it. At the public reception, which was attended by nearly two thousand persons, the public parlors were used, and the effect of such a promiscuous gathering upon the carpet-ing, furniture, etc., can be well imagined. An extra dining room and a state dinner was supplied every day, and not the usual and ordinary dining room of the hotel, which greatly added to the expense of the reception of the king. In fact, all that could be done was done to impress the king with the splendor and magnificence of a civic reception in the City of New York, and it would appear that even all former precedents were set aside, and the degree of extravagance indulged in appear that even all former precedents were set aside, and the degree of extravagance indulged in was in keeping with the dignity of the recipient of the city's hospitality, in this instance being nothing short of royalty itself.

"That the proprietors of the hotel acted in good faith there can be no question; as there can be none, the bill submitted, in view of all the circumstances attending the extravagant reception and entertainment, is but fair, and should be paid."

Your Committee believe that the sum of five thousand dollars would be a fair compensation for the services rendered and supplies furnished on the occasion ; and accordingly they respectfully offer for your adoption the following

Resolved, That the Board of Estimate and Apportionment be and is hereby requested to transfer from any appropriation of former years, five thousand dollars (\$5,000), that amount being the sum required to pay the annexed bill of the proprietors of the Windsor Hotel for expenses of the Joint Special Committee of the Common Council of 1874, incurred in the reception and entertainment of King Kalakaua and suite ; and the Comptroller, after such transfer shall have been made, is hereby authorized and directed to draw a warrant in favor of Hawk & Wetherbee for the said sum of five thousand dollars (\$5,000), and charge the same to the proper appropriation, when made, as above requested, by the Board of Estimate and Apportionment.

The Joint Proceedings of the year 1871 would form volume No. 39 of the series, and is the only one required to complete it. But one copy of the proceedings of that year is in existence, and that is in manuscript, on file in the office of the Clerk of this Board. The loss of that one copy would be irreparable, or nearly so, and would occasion much embarrassment and loss of time to all persons having occasion to consult or refer to the

proceedings of the City Government for that year. Complete sets of this series of books, with this exception, are contained in many, if not all, the principal libraries in this city, and, as a matter of convenience to the public, apart from any other consideration, your Committee believe, would more than compensate for the outlay occasioned by copying, printing, indexing, and binding the missing volume. An estimate of the sum required was obtained in 1874 by General Joseph C. Pinckney, then Clerk of the Common Council, and was ascertained to be \$85 The printing of the book was strenuously urged at that time by the then Clerk, who, in his official capacity, realized the necessity for supplying this missing link in the series of books of reference, containing the proceedings of the Common Council for the year 1871, and this necessity increases constantly. In the opinion of your Committee the work is one of great and constantly increasing necessity, and should be immediately performed, in order to complete the records of the Common Council. Your Committee therefore respectfully recommend the adoption of the resolution herewith accompanying.

That each inmate be furnished at their meals with knife, fork, spoon, and tin dish, and to be kept perfectly clean ; except to those who may be deemed dangerous or improper. Females to be located on separate tiers, and to be distributed according to the offense of which they stand charged. Under no consideration will any Keeper be allowed to charge for or accept any fee, or compensation for services rendered to prisoners. Under direction of the Warden the prisoners shall be allowed to take exercise for half hour in the morning and half hour in the afternoon, and under strict surveilance of Keepers, to prevent improper conduct or attempt to escape. All lawyers of well known respectability are to be admitted to the council room for consultation with their clients who are prisoners, and at no other place, except in cases of sickness or inability to attend at consultation.


