




I. Population Change: DOC Population by Custody Status

Total DOC Population by Custody Status, 1/30/2021 - 2/5/2021




I. Population Change: City Sentenced Population by Custody Status






Number and Percent of Patients with Confirmed COVID-19 January 30 – February 5, 2021

Number of Currently Incarcerated Patients with Confirmed COVID-19 March 17, 2020 – February 5, 2021
















