COMMISSION DIRECTIVE

Dear Licensees and Registrants:

On Sunday, June 25, 2017, the Heritage of Pride Parade and Festival will be holding their annual parade event. In anticipation of this event, the New York City Police Department will temporarily close the following connecting streets and avenues:

- Between Fifth Avenue to Park Avenue From East 42nd Street to East 23rd Street
- 6th Avenue between West 42nd Street and West 8th Street
- Broadway between 34th Street and East 8th Street
- Greenwich Avenue between 6th Avenue and Christopher Street
- Greenwich Street between West 11th Street and Leroy Street
- Hudson Street between 14th Street and Bethune Street
- West 13th Street between 9th Avenue and West 4th Street
- 5th Avenue between 8th Street and Washington Mews
- Bleecker Street between Christopher Street and West 10th Street

Accordingly, all licensees and registrants are hereby directed to complete waste collection and remove their respective containers along the event route before 5:00 a.m. on June 25, 2017. Collection may resume at 5:00 p.m. on June 25, 2017. Moreover, all licensees and registrants must notify all customers along the event route that no waste or containers may be placed on the curbside between 12:00 a.m. to 4:30 p.m. on Sunday, June 25, 2017.

Business Integrity Commission enforcement agents will be on the event route to ensure compliance with this directive. A map of the Heritage of Pride Parade and Festival event route showing the affected roadways is annexed hereto, and is available on the BIC website and at: <http://www.nyc.gov/html/dot/downloads/pdf/heritage-of-pride-parade-festival-embmap-2017.pdf>.

Please be aware that the City's Department of Transportation ("DOT") issued a festival construction embargo along the event route from 12:01 a.m. on Thursday, June 22 through 11:59 p.m. on Sunday, June 25, 2017. DOT will strictly enforce this embargo and violators are subject to be summonsed. Failure to comply with this directive may result in administrative penalties and/or fines up to \$10,000. *See* 17 RCNY 1-09. Failure to comply with this directive may also affect your company's licensing or registration status before the Commission.
