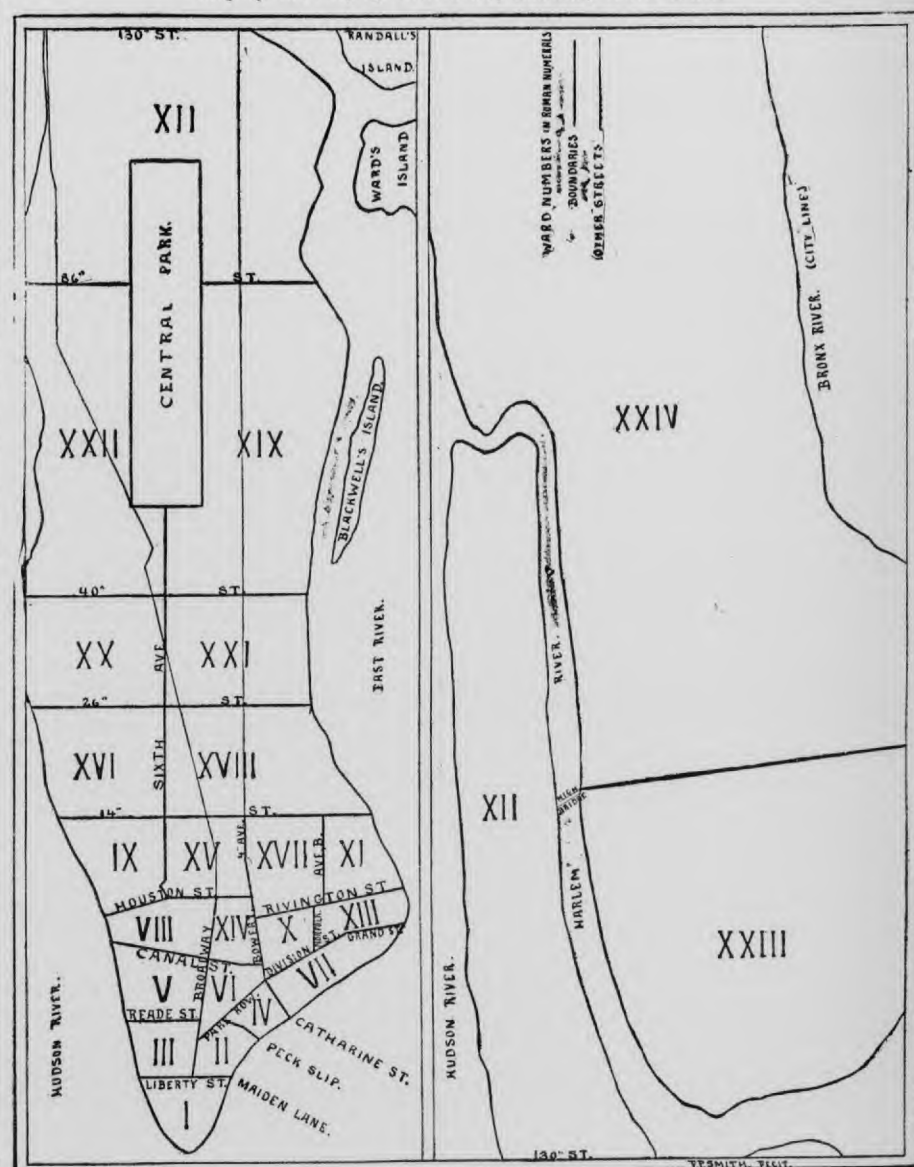

The 758 deaths represent a death-rate of 21.48, against 20.73 for the previous week and 22.45 for the corresponding week of 1891.

Contagious and infectious diseases increased slightly, the number of cases reported of diphtheria, measles, scarlet fever, typhoid fever and small-pox being respectively 79, 37, 44, 58 and 6, against 71, 44, 43, 56 and 5 for the previous week, a total of 224 against 219. Diphtheria increased in the Twelfth, Twentieth and Twenty-third Wards, varying little elsewhere. Measles increased in the Seventh, Thirteenth and Seventeenth Wards, and, as a rule, decreased elsewhere. Scarlet fever increased markedly in the Eighth, Fourteenth and Sixteenth Wards, decreasing or varying little elsewhere. Asiatic Cholera—The report of diarrhoeal diseases last week included 1 death of September 6, since verified as Asiatic cholera. Four deaths reported this week, viz: 1 on September 10, 2 on September 11, 1 on September 13. The death of September 6 was in the Twenty-second Ward; this week 2 were in the Twenty-second Ward, 1 in the Nineteenth Ward and 1 in the Twelfth Ward. One case in the Twelfth Ward recovered.

TO OWNERS OF LANDS ORIGINALLY ACQUIRED BY WATER GRANTS.

ATTENTION IS CALLED TO THE RECENT act of the Legislature (chapter 449, Laws of 1892), which provides that whenever any streets or avenues in the city, described in any grant of land under water, from the Mayor, Aldermen and Commonalty containing covenants requiring the grantees or their successors to pave, repave, keep in repair or maintain such streets, shall be in need of repairs, pavement or repavement, the Common Council may, by ordinance, require the same to be paved, repaved or repaired, and the expense thereof to be assessed on the property benefited; and whenever the owner of a lot so assessed shall have paid the assessment levied for such paving, repaving or repairing, such payment shall release and discharge such owner from any and every covenant and obligation as to paving, repaving and repairing, contained in the water grant under which the premises are held, and no further assessment shall be imposed on such lot for paving, repaving or repairing such street or avenue, unless it shall be petitioned for by a majority of the owners of the property (who shall also be the owners of a majority of the property in frontage) on the line of the proposed improvement.

The act further provides that the owner of any such lot may notify the Commissioner of Public Works, in writing, specifying the ward number and street number of the lot that he desires, for himself, his heirs and assigns, to be released from the obligation of such covenants, and elects and agrees that said lot shall be thereafter liable to be assessed as above provided, and thereupon the owner of such lot, his heirs and assigns shall thenceforth be relieved from any obligation to pave, repair, uphold or maintain said street, and the lot in respect of which such notice was given shall be liable to assessment accordingly.

The Commissioner of Public Works desires to give the following explanation of the operation of this act:

When notice, as above described, is given to the Commissioner of Public Works, the owner of the lot or lots therein described, and his heirs and assigns, are forever released from all obligation under the grant in respect to paving, repaving or repairing the street in front of or adjacent to said lot or lots, except one assessment for such paving, repaving or repairs, as the Common Council may, by ordinance, direct to be made thereafter.

No street or avenue within the limits of such grants can be paved, repaved or repaired until said work is authorized by ordinance of the Common Council, and when the owners of such lots desire their streets to be paved, repaved or repaired, they should state their desire and make their application to the Board of Aldermen and not to the Commissioner of Public Works, who has no authority in the matter until directed by ordinance of the Common Council to proceed with the pavement, repavement or repairs.
