SIR—There were 920 deaths reported to have occurred in this city during the week ending Saturday, July 11, 1885, which is an increase of 111, as compared with the number reported the preceding week, and 35 less than were reported during the corresponding week of the year 1884. The actual mortality for the week ending July 4, 1885, was 789, which is 205.4 below the average for the corresponding week for the past five years, and represents an annual death-rate of 29.35 per 1,000 persons living, the population estimated at 1,397,737.
