Dear Sir—In accordance with the action taken by this Board at the meeting held on the 14th instant, I inclose herewith copy of report made by the Chief Topographical Engineer on the recommendation of the Local Board, Twenty-first District, that the roadway of Tremont avenue be widened by taking three and a half feet off each sidewalk between Third avenue and Boston

In his report the Chief Engineer suggests that the roadway of Tremont avenue be made 100 feet wide. The matter is now referred to you for submission to the Local Board for their further consideration.

Sir.—In reply to the action taken by the Board of Public Improvements, referring, for report, communication from the President of the Borough of The Bronx, recommending that the roadway of Tremont avenue be widened by taking 3½ feet off each sidewalk between Third avenue and Boston road, in the Borough of The Bronx, I have to report as follows:

Tremont avenue is 75 feet wide, and that the width of the sidewalk is 18½ feet, of which 3½ feet are proposed to be taken off, leaving only 15 feet of sidewalk. The width of the sidewalk is regulated by the City Ordinances, and was established after experience had demonstrated what width was best suited to the traffic of the streets, and I do not think it will be an improvement for a street if the sidewalk is made narrower than determined by the City Ordinances.

It is conceded by everybody that the width of 75 feet for Tremont avenue is not sufficient for the future, and a plan was suggested by the Topographical Bureau to widen Tremont avenue, from Third avenue to the Bronx river, to 100 feet, which suggestion was adversely reported upon by the Local Board. The widening of the roadway by reducing the sidewalks might give temporary relief, but it is doubtful whether the majority of the owners along the line would favor it.

I propose, therefore, that the matter be returned to the Local Board for a reconsideration of the decision against widening Tremont avenue to 100 feet.

communication from the President of the Borough of The Bronx, recommending that proceedings be initiated for acquiring title to Davidson avenue, between East One Hundred and Seventy-seventh street and Kingsbridge road, in the Borough of The Bronx, I have to report as follows:

Davidson avenue, from East One Hundred and Seventy-seventh street to the Kingsbridge road, is shown on sections 15 and 16 of the Final Maps and Profiles of the Twenty-third and Twenty-fourth Wards, filed in the Register's office December 17, 1895, and November 18, 1895, respectively, and that portion lying between Fordham road and St. James street, was ceded to the city June 23, 1897.

I have examined the petition signed by Bernard J. Reilly and six (6) others, and by comparing the names in the Tax Department I do not find any of the signers as owners along the line. The proceeding will be very expensive, and I recollect that at the time of the laying out of Davidson avenue considerable opposition was shown against the laying out of the same between East One Hundred and Eightieth street and East One Hundred and Eighty-fourth street. I wish to recommend, therefore, that the petition be returned to the Local Board, with the request that another hearing be given to the matter, to afford an opportunity to the owners to be heard.

Should the Board of Public Improvements conclude to open said Davidson avenue, the limits would have to read "from East One Hundred and Seventy-seventh street to Fordham road and from East One Hundred and Ninetieth street (St. James street) to Kingsbridge road, in the Borough of The Bronx."

There are buildings within the lines. The papers in this matter are herein returned.

The Local Board of the Borough of Queens met at the Borough Hall, Long Island City, June 2, 1899, at which were present Councilman David L. Van Nostrand, Alderman William T. James and the President of the Borough, Frederick Bowley.

Minutes of the previous meeting approved.

The subjects that received the attention of the Board were:
Petition to construct sewer in Elmhurst avenue, Elmhurst, Second Ward, this borough.
Petition to cause flagging to be laid along the Hempstead and Jamaica plank road, from west line of the Phillips property to the west line of the Crum farm in Hollis, in the Fourth

Petition to pave Seventh street, between West avenue and the East river, in the spaces left undone while the other parts were done under private contract, First Ward.

Petition to flag, curb and asphalt Elm street, from Hopkins avenue to Van Alst avenue, First

Petition to grade, curb and flag Taylor street, from Van Alst avenue to Hopkins avenue

Petition to compel New York and Queens County Railway Company to remove its tracks from off the sidewalks, corner of Fiske avenue and Grand street, Maspeth, Second Ward.

Petition for water-main in Trowbridge street, from Van Alst avenue to Willow street, First

Also other matters as hereinafter set forth, and upon which the following action was had:
Whereas, The President of the Borough of Queens, City of New York, did submit to this the
Local Board of borough aforenamed, at meeting held this June 2, 1899, petition for the construction of public sewer in Elmhurst avenue, from Eleventh street to Broadway, in Elmhurst, Second

Ward, said borough; and
Whereas, Public hearing was afforded thereon, as per notice published in CITY RECORD; and
Whereas, It appears to us that the construction of sewers as petitioned is a public necessity;

Resolved, That this Board does hereby recommend to the Board of Public Improvements, this city, that it give the foregoing subject its prompt and favorable consideration and action

Whereas, At public hearing advertised in the CITY RECORD to be afforded by this the Local Board of the Borough of Queens, City of New York, at its meeting this June 2, 1899, upon the petition to grade, curb and flag Taylor street, from Van Alst avenue to Hopkins avenue, First Ward, no person appeared in opposition thereto; and Whereas, The petition for such improvements meets the approval of this Board; therefore Resolved, That this Board hereby recommends to the Board of Public Improvements, this city, that it initiate the necessary proceedings and take such prompt and favorable action upon the foregoing subject as will cause such response to be made to the petition as the signers thereof whereas. The President of the Presiden

Whereas, The President of the Borough of Queens, this city, did cause notice to be published in the CITY RECORD of receipt of petitions to curb, flag and pave with asphalt that portion of Elm street extending from Van Alst avenue to Hopkins avenue, in First Ward, and that public hearing thereon would be had before the Local Board of borough aforenamed, at meeting thereof to be held this June 2, 1899; and

Whereas, No opposition thereto appearing at such hearing, and having determined in approval of such improvements being made; it is accordingly

Resolved, That the same be and hereby is recommended to the Board of Public Improvements, this city, that it extend thereto its prompt and favorable consideration and action; also Whereas, Petition for the laying of public water-main in Trowbridge street, from Van Alst avenue to Willow street, in First Ward, this borough, was received by this the Local Board of the Borough of Queens, City of New York, at its meeting on June 2, 1899, and the same approved of; now, accordingly it is

Resolved, That recommendation be and the same is hereby made to the Board of Public Improvements, this city, that it give to the matter such action as will promptly cause such watermain to be laid, with fire-hydrants erected in connection therewith, in street and to the extent as

aforestated.

In the matter to flag sidewalks along Hampstead and Jamaica plank road, in Hollis, after public hearing thereon on May 26, 1899, and then laid over to this meeting on account of the absence of the Councilman of such district, the subject was, on motion, referred to Councilman Van Nostrand as a committee of one to investigate and report thereon.

In the matter of petition to pave unfinished parts of Seventh street, west of West avenue, First Ward, the President stated that inasmuch as private property-owners along said street undertook to have the work of paving said street done by private contract and in consequence of inability to secure unanimous co-operation therein the portions of streets fronting premises of those who declined to join in the undertaking were therefore left unpaved, the same could not be accepted in such unfinished condition by the City so much so that the only power that the City would have would be to order the paving of the whole street whereby the assessment would have to be laid and paid regardless of what expense the abutting property owners had been put to in the first instance.

On motion, the petition was denied.

On motion, the petition was defined.

The following was also adopted:

Whereas, Due publication in the CITY RECORD was made of the public hearing to be had on May 12, 1899, before this the Local Board of the Borough of Queens in relation to petition received by the President of the borough aforesaid, asking that the New York and Queens County Railway Company be compelled to remove its track from off the sidewalk on corner of Fiske avenue and Grand street, in Maspeth, Second Ward, this borough; and

Whereas, Representatives of both sides put in an appearance on date set for such public hearing and upon announcement made that an agreement had been arrived at to defer proceedings in the matter for one week to enable said company to obtain from the Highway Department permit to change its route, whereby and whereupon the matter complained of would be discontinued and such postponement was directed by this Board; and

Whereas, Subsequent adjournments were taken based upon same representations; and Whereas, It appears from inquiries made at the office of the Deputy Commissioner of Highways this June 2, 1899, that the representative of said company had failed to comply with the understanding had with said Department or the representatives thereof;

Now, in view of the foregoing, this Board feeling constrained to conclude that said company is not acting in good faith toward it, the complainants and the Highway Department, it is accordingly.

Resolved, That this Board does hereby approve of the facts stated in said petition and complaint, and does hereby direct that the matter be certified to the Commissioner of Highways of this city, for him to carry out the desires of the petitioners.

The complaint made against the New York and Queens County Railway Company having a few rails laid in several blocks in College Point, was ordered laid over indefinitely, as the matter is in the courts.

Communication from the Comptroller was received, read and ordered on file, it being in response to communication addressed by the President of this borough to the Comptroller, in the endeavor to obtain city appropriation whereby to pay the expenses of the Volunteer Fire Department of Dunton District, together with copy of report on the subject made by Deputy Fire Commissioner for this borough to Hon. John J. Scannell, Fire Commissioner, dated May 29, 1899, and which concludes as follows:

which concludes as follows:

"It seems to be unjust that Volunteer Fire Companies or Department, who have been liberal enough in the past to defray their own expenses, should be for that reason debarred from assistance now. There seems to be no way out of it unless the Corporation Counsel should find a way as a matter of equity. I would therefore suggest that the matter be referred to him."

On motion, the President was requested to communicate with the Corporation Counsel in keeping with the foregoing suggestion.

Agreeable to the wishes of Councilman Van Nostrand, it was understood that the Commissioner of Water Supply be asked for information as to the present status of affairs relating to extending water-mains from Flushing to Little Neck.

Adjournment to 9th instant.
