WITH REGARD TO ABUSE OF AUTHORITY COMPLAINTS, HOW MANY INVOLVED DISPUTED ARRESTS OR THE CONFISCATION OF STUDENT PROPERTY?

There were three (3) abuse of authority cases during this period. These cases are still open and pending further investigation, but do not appear to involve a disputed arrest or the confiscation of student property.

HOW MANY OF THE FADO COMPLAINTS REMAIN OPEN?

Twenty six (26) of the thirty (30) cases are still open pending further investigation.

HOW LONG HAVE THESE CASES BEEN OPEN?

The number of days open ranges from 10 days to 91 days. The average number of days open is 25.4.

HOW MANY OF THE AGENTS WITH OPEN FADO COMPLAINTS HAVE BEEN THE SUBJECT OF PRIOR COMPLAINTS?

Nine (9) of the Agents with open FADO complaints have been the subject of prior complaint(s).
