

# Loan Reduction Factors For 2025 Retirements

An outstanding loan at retirement will permanently reduce your retirement benefit. The amount of the reduction in your benefit depends on the date of your retirement, your age at retirement, the size of the loan, and whether you are in a Uniformed title (Correction or Sanitation members) or a Non-Uniformed title.

The chart below illustrates the benefit reduction in dollars for every \$1,000 of an outstanding loan, based on a table of factors used for 2025 service retirements from January 1, 2025 to December 31, 2025 for Uniformed and Non-Uniformed titles.

On each chart, locate your age at retirement and multiply the amount in the corresponding box by how many \$1,000s of loan dollars are still unpaid.

**Example:** Age 61 (Non-Uniformed) with a \$10,000 outstanding loan

Age 61 (Non-Uniformed) = \$72.96 per \$1,000 of loan

Multiply that by 10 (for the \$10,000 loan)

\$72.96 x 10 = \$729.60

Your annual Maximum Retirement Allowance will be reduced by \$729.60.
