

To the Honorable Board of Apportionment:

GENTLEMEN-The American Humane Society desire to call your attention to the importance

Gentlemen—The American Humane Society desire to call your attention to the importance and necessity of a free dispensary service.

The President of this Society, having served in the dispensary for over fifteen years, when they were free to all, has seen the importance of having a free dispensary system in reducing the mortality of this city, in saving the lives of the sick poor, in relieving their distress of body and mind, in shortening their sicknesss, in enabling their families to secure employment, and in sending life, health and happiness into the homes of the poor in the tenement-houses.

The present system in the dispensaries is to charge ten cents for medicines; the effect of this system has been to reduce the attendance of the patients one-half. Only those who can afford to pay the ten cents now attend.

The system of fees does away with the usefulness of the dispensary system, making them mere money-getting institutions. The sick poor are now afraid to go to them on account of this fee sys-

tem, and the sick poor loses all the advice and counsel of the medical profession, who give their time

and knowledge without fee or reward.

In the name of humanity, therefore, this society desires to obtain for the sick poor of New York a free dispensary system, and they would respectfully request that the Board of Apportionment withdraw their usual appropriation from the dispensaries until they are again made free to all.
