

The City Council enacted Local Laws 79 and 80 of 2015 amending Section 20-672 of the New York City Administrative Code to require, among other things, that all gasoline stations that post road signs include on their signs the price of the lowest grade of gasoline offered for sale, and if the cash price is less than the price charged for other forms of payment, the price for each type of accepted payment. This rule amends 6 RCNY § 4-63(b) to implement the changes made to Section 20-672 of the Administrative Code.

The rule also removes certain requirements that were added to 6 RCNY 4-63(b) in 2013, but have not been enforced by the Department of Consumer Affairs because of difficulties faced by the industry in complying with them. For example, the rule eliminates the requirement that every sign have type size of at least 430 points and the requirement that gasoline stations must have a sign that can be seen from the road and is of a certain size. Removing these requirements will provide regulatory relief and make it easier to own and operate a gasoline station.

"Shall" and "must" denote mandatory requirements and may be used interchangeably in the rules of this department, unless otherwise specified or unless the context clearly indicates otherwise.

<u>Rule</u>

Subdivision (b) of Section 4-63 of Subchapter E of Chapter 4 of Title 6 of the Rules of the City of New York is amended to read as follows:

<u>§4-63 Signs.</u>

(b) [Required curb sign and other] <u>Petroleum product</u> signs <u>related to</u> <u>price</u>, not located on dispensing equipment.

[(1) Every location at which gasoline or diesel motor fuel is sold or offered for sale must maintain a sign, poster or placard clearly visible to drivers of approaching motor vehicles with dimensions not less than 60 inches in width by 36 inches in height.]

([2]<u>1</u>) [e]<u>Every sign</u>, poster or placard used to display<u>, advertise</u>, or refer to the price [per gallon or used to advertise] <u>of any</u> petroleum product[s], including gasoline and diesel motor fuel, other than that used on a dispensing device<u>, must clearly display</u>:

(i) [On the upper portion of the sign,] [t]The name, trade name, brand, mark or symbol, and grade or quality classification, <u>if any</u>, <u>and method of processing</u>, of [such] <u>any displayed</u>, <u>advertised</u>, <u>or referred to products</u>, or, if such products are sold without identification, such sign, placard or other display [shall]<u>must</u> refer clearly to such products as unbranded;

> (a) If a product displayed, advertised, or referred to is associated with the same brand as the petroleum station offering such product for sale, the name, trade name, brand, mark or symbol of such product may be placed either adjacent to or directly above

the grade or quality classification and the price(s) of such product, and all such information shall be deemed to be displayed on the same sign;

(b) If a product displayed, advertised, or referred to is unbranded or is associated with a different brand than the petroleum station offering such product for sale, the term "unbranded" or the name, trade name, brand, mark or symbol associated with such product must be displayed adjacent to the grade or quality classification and the price(s) of such product;

(ii) the [total selling] price<u>, including all applicable taxes</u>, per unit of measure at which such product is customarily sold at retail, which for gasoline or diesel motor fuel [shall]<u>must</u> be by gallon; [and]

(iii) [in close proximity to]<u>near</u> the [total selling] price, the legend "Includes All Taxes,"

(iv) if gasoline is offered for sale, the price of the lowest grade of gasoline offered for sale; and

 $([iv]\underline{v})$ [when] if the [total selling] price <u>charged for a</u> petroleum product displayed, advertised or referred to on the sign, poster or placard varies based on the form of payment, each price charged for that product along with language identifying the product and form or forms of payment associated with each price.

[of purchases made with cash is less than the total selling price for purchases made with credit card, debit card or other form of non-cash payment, the following words referring to method of payment listed in the following order from left to right: "Cash", "Debit," "Credit," "Other." Each grade of the petroleum product must be listed on a separate line. Following the grade name, from left to right, each line must list the applicable price per method of payment beneath the corresponding method of payment listed, "Cash," "Debit," "Credit" or "Other."

([3]2) The total number of signs, posters, and placards used to <u>display</u>, advertise ["savings," "discounts,"] or ["selling prices of gasoline or diesel motor fuel] <u>refer to the price of petroleum products</u> shall not exceed the number of vehicular traffic streets upon which the service station faces. For the purpose of this section, signs used on dispensing devices shall not be included in the number of signs permitted to be displayed and a sandwich or "A" sign, placard, or poster shall be considered one sign.

(ii) [Type size cannot be less than 430 points.] <u>All letters</u> <u>must be of a height, width, and thickness that is no greater</u> <u>than the size of the largest number on the sign, poster, or</u> <u>placard referring to price.</u>

(iii) Identification of the <u>petroleum product</u> [gasoline or diesel motor fuel] offered for sale and any non-numerical language distinguishing the <u>prices charged for different forms of</u> <u>payment</u> [total cash selling price from the total credit card, debit card or other form of non-cash payment selling price shall] <u>must</u> be in letters and numbers not less than one-half of the height, width and thickness of the numbers referring to price.

(iv) All letters and numbers shall be black on a white background or displayed on an illuminated light-emitting diode sign.

As of January 1, 2017, the Bio-Diesel Blender Tax Credit has been rescinded for \$1.00 per gallon on B100. Therefore, for deliveries after January 1, 2017, the contractor will no longer be deducting the tax credit as a separate line item on the invoice. Should the tax credit be extended, it will once again appear as deduction and line item on the invoice.

Federal excise taxes are imposed on taxable fuels, (i.e., gasoline, kerosene, and diesel), when removed from a taxable fuel terminal. This fuel excise tax does not include Leaking Underground Storage Tank (LUST) tax. LUST tax applies to motor fuels for both diesel and gasoline invoices. Going forward, LUST Tax will appear as an additional fee at the rate of \$0.001 per gallon, and will be shown as a separate line item on your invoice.

The National Oilheat Research Alliance (NORA) resumed operations in 2014. A related assessment of \$.002 per gallon has been added to the posted weekly fuel prices and will appear as a separate line item on invoices. This fee applies to heating oil only and since 2015 has included #4 heating oil. NORA has been authorized through February 2019. All other terms and conditions remain unchanged.
