

CAPITAL RESOURCE CORPORATION

■ PUBLIC HEARINGS

The New York City Capital Resource Corporation (the "Corporation") is a not-for-profit local development corporation organized under Sections 402 and 1411 of the Not-for-Profit Corporation Law of the State of New York. In accordance with the aforesaid law, and pursuant to its certificate of incorporation, the Corporation has the power to issue non-recourse revenue bonds and to make the proceeds of those bonds available for projects that promote community and economic development in The City of New York (the "City"), and to thereby create jobs in the non-profit and forprofit sectors of the City's economy. The Corporation has been requested to issue such bonds for the financings listed below in the approximate dollar amounts respectively indicated. As used herein, "bonds" are the bonds of the Corporation, the interest on which may be exempt from local and/or state and/or federal income taxes; and, with reference to the bond amounts provided herein below, "approximately" shall be deemed to mean up to such stated bond amount or a greater principal amount not to exceed 10% of such stated bond

Approximately \$2,000,000 triple tax-exempt qualified small issue bond transaction for the benefit of 118 Greenfield Equities LLC, or its assignee, on behalf of Diamond Concrete Inc., a concrete fabricator, in connection with the acquisition, renovation, construction, equipping and/or furnishing of an approximately 6,200 square foot facility located on an approximately 28,000 square foot parcel of land located at 118 Greenfield Avenue, Staten Island, New York 10304. The financial assistance proposed to be conferred by the Corporation will consist of such tax-exempt bond financing.

The Corporation will hold a public hearing on the proposed financings described hereinabove at the offices of the New York City Economic Development Corporation ("NYCEDC"), located at 110 William Street, 4th Floor, New York, New York 10038, commencing at 10:00 A.M. on Thursday, September 16, 2010. Interested members of the public are invited to attend. The Corporation will invite comments at such hearing on the proposed financings. In addition, at such hearing the Corporation will provide the public with an opportunity to review the financing application and the cost-benefit analysis for each of the proposed financings. For those members of the public desiring to review project applications and cost benefit analyses before the date of the hearing, copies of these materials will be made available, starting on or about noon on the Friday preceding the hearing. ARTICLE VII: ADMINISTRATION

Chapter 4

Special Permits by the City Planning Commission

74-743

Special provisions for bulk modification

- (a) For a #general large-scale development#, the City Planning Commission may permit:
- - (i) no distribution of #bulk# across the boundary of two districts shall be permitted for a #use# utilizing such #bulk# unless such #use# is permitted in both districts:
 - (ii) when a #general large-scale development# is located partially in a #Residence District# or in a C1, C2, C3 or C4-1 District and partially in other #Commercial# or #Manufacturing Districts#, no transfer of commercial #floor area# to a #Residence District# or to a C1, C2, C3 or C4-1 District from other districts shall be permitted;
- (2) location of #buildings# without regard for the applicable #yard#, #court#, distance between #buildings#, or height and setback regulations;
- (3) variation in the location of primary business entrances and #show windows# along frontages adjacent to #zoning lots# outside the #general large-scale development# without regard to regulations applicable near #Residence District# boundaries;
- (4) the maximum #floor area ratio# permitted pursuant to Section 23-142 (In R6, R7, R8 or R9 Districts) for the applicable district without regard for #height factor# or #open space ratio# requirements provided that the #general large-scale development# is located partially in a C6-1, C6-2 or C6-3 District within the boundaries of Community District 7 in Manhattan and that a minimum of 50 percent of the required #open space# is provided within the #general large-scale development#.

Required #open space# for the purposes of this paragraph, (a)(4), shall be calculated by utilizing the smallest #open space ratio# at the maximum #floor area ratio# pursuant to Section 23-142 for the applicable district;

- (5) in an #Inclusionary Housing designated area# in a C4-6 or C5 District:
 - (i) a portion of the #lot area# that contains a wholly #commercial building# to be excluded from the calculation of #floor area# for any other #buildings# on the remainder of the #zoning lot#; or
 - (ii) community facility #floor area# located above the ground floor to be excluded from the calculation of the amount of #affordable housing# required pursuant to Section 23-95; or
- (6) modification of the requirements of Section 23-86
 (Minimum Distance Between Legally Required
 Windows and Walls or Lot Lines) for
 #developments# or #enlargements#, where:
 - (i) the required minimum distance as set forth in Section 23-86 is provided between the #legally required window# in the new #development# or #enlargement# and a wall or #lot line # on an abutting property; and
 - (ii) the required minimum distance is provided by a light and air easement acceptable to the Department of City Planning and recorded in the County Clerk's office in the county in which such tracts of land are located.
- (7) modification of the definition of #outer court# in Section 12-10 (DEFINITIONS) and the provisions of Section 23-84 (Outer Court Regulations) to include any open area that is bounded on all sides but one by building walls and is not otherwise a #yard# or an #inner court#, provided that:
 - (i) such modifications are permitted only for #general large-scale developments# previously approved by the City Planning Commission in a C4-7 District within the boundaries of Manhattan Community District 7: and
 - (ii) the minimum distance between a #legally required window# facing onto such #outer court# and a building wall shall be 30 feet, measured in a horizontal plane at the sill level of, and perpendicular to such window for the full width of the rough window opening.
- (b) In order to grant a special permit pursuant to this Section for any #general large-scale development#, the Commission shall find that:
 - (1) the distribution of #floor area#, #open space#, #dwelling units#, #rooming units# and the location of #buildings#, primary business entrances and #show windows# will result in a better site plan and a better relationship among #buildings# and open areas to adjacent #streets#, surrounding #development#, adjacent open areas and shorelines than would be possible without such distribution and will thus benefit both the occupants of the #general large-scale development#, the neighborhood, and the City as a whole;
 - (2) the distribution of #floor area# and location of #buildings# will not unduly increase the #bulk# of #buildings# in any one #block# or unduly obstruct access of light and air to the detriment of the occupants or users of #buildings# in the #block# or nearby #blocks# or of people using the public #streets#;
 - (3) where a #zoning lot# of a #general largescale development# does not occupy a frontage on a mapped #street#, appropriate access to a mapped #street# is provided;
 - (4) considering the size of the proposed
 #general large-scale development#, the
 #streets# providing access to such
 #general large-scale development# will be
 adequate to handle traffic resulting
 therefrom:
 - (5) when the Commission has determined that the #general large-scale development# requires significant addition to existing public facilities serving the area, the applicant has submitted to the Commission a plan and timetable to provide such required additional facilities. Proposed facilities that are incorporated into the City's capital budget may be included as part of such plan and timetable;
 - (6) where the Commission permits the maximum #floor area ratio# in accordance with the provisions of paragraph (a)(4) of this Section, the #open space# provided is of sufficient size to serve the residents of new or #enlarged buildings#. Such #open space# shall be accessible to and usable by all residents of such new or #enlarged buildings#, have appropriate access, circulation, seating, lighting and paving,

and be substantially landscaped. Furthermore, the site plan of such #general large-scale development# shall include superior landscaping for #open space# of the new or #enlarged buildings#;

- (7) where the Commission permits the exclusion of #lot area# or #floor area# in accordance with the provisions of paragraph (a)(5) of this Section, such modification will facilitate a desirable mix of #uses# in the #general large-scale development# and a plan consistent with the objectives of the Inclusionary Housing program; and
- (8) a declaration with regard to ownership requirements in paragraph (b) of the #general large-scale development# definition in Section 12-10 (DEFINITIONS) has been filed with the Commission.

The Commission may prescribe additional conditions and safeguards to improve the quality of the #general large-scale development# and to minimize adverse effects on the character of the surrounding area.

For a phased construction program of a multibuilding complex, the Commission may, at the time of granting a special permit, require additional information, including but not limited to a proposed time schedule for carrying out the proposed #general large-scale development#, a phasing plan showing the distribution of #bulk# and #open space# and, in the case of a site plan providing for common #open space#, common open areas or common parking areas, a maintenance plan for such space or areas and surety for continued availability of such space or areas to the people they are intended to serve.

23-954 Additional requirements for compensated developments

- (a) Height and setback in #Inclusionary Housing designated areas#
 - In #Inclusionary Housing designated areas#, except within #Special Mixed Use Districts# and #general large-scale developments# in C4-7 Districts within the boundaries of Manhattan Community District 7, subject to the provisions of a restrictive declaration, the #compensated development# must comply with the height and setback regulations of Sections 23-633 (Street wall location and height and setback regulations in certain districts) or 35-24 (Special Street Wall Location and Height and Setback Regulations in Certain Districts), as applicable.
 - (2) In #Inclusionary Housing designated areas# within #Special Mixed Use Districts#, the #compensated development# must comply with the

provisions of paragraphs (a) or (b) of Section 123-662 (All buildings in Special Mixed Use Districts with R6, R7, R8, R9 and R10 District designations), as applicable. However, where the #Residence District# designation is an R6 District without a letter suffix, the #compensated development# must comply with the height and setback regulations of Section 23-633, regardless of whether the #building# is #developed# or #enlarged# pursuant to the Quality Housing Program.

- (b) Compensated development building permits
 - (1) #HPD# may issue a #permit notice# to the Department of Buildings at any time on or after the #regulatory agreement date#. The Department of Buildings may thereafter issue building permits to a #compensated development# that utilizes #floor area compensation# based on the #affordable housing# described in such #permit notice#.
 - (2)If #HPD# does not receive confirmation that the #regulatory agreement# has been recorded within 45 days after the later of the #regulatory agreement date# or the date upon which #HPD# authorizes the recording of the #regulatory agreement#, #HPD# shall suspend or revoke such #permit notice#, notify the Department of Buildings of such suspension or revocation and not reinstate such #permit notice# or issue any new #permit notice# until #HPD# receives confirmation that the #regulatory agreement# has been recorded. Upon receipt of notice from #HPD# that a #permit notice# has been suspended or revoked, the Department of Buildings shall suspend or revoke each building permit issued pursuant to such #permit notice# which is then in effect for any #compensated development#.
- (c) Compensated development certificates of occupancy
 - The Department of Buildings shall not (1) issue a temporary or permanent certificate of occupancy for any portion of the #compensated development# that utilizes #floor area compensation# until #HPD# has issued a #completion notice# with respect to the #affordable housing# that generates such #floor area compensation#. However, where any #story# of a #compensated development# contains one or more #affordable housing units#, the Department of Buildings may issue any temporary or permanent certificate of occupancy for such #story# if such temporary or permanent certificate of occupancy either includes each #affordable housing unit# located in such #story# or only includes #dwelling units# or #rooming units# that are #affordable housing units#. Nothing in the preceding sentence shall be deemed to prohibit the granting of a temporary or permanent certificate of occupancy for a #super's
 - (2) #HPD# shall not issue a #completion notice# with respect to any portion of any #generating site# unless:
 - (i) the Department of Buildings has issued temporary or permanent certificates of occupancy for all #affordable housing# described in such #completion notice# and such certificates of occupancy have not expired, been suspended or been revoked; or

Required #open space# for the purposes of this paragraph, (a)(4), shall be calculated by utilizing the smallest #open space ratio# at the maximum #floor area ratio# pursuant to Section 23-142 for the applicable district;
- (5) in an #Inclusionary Housing designated area# in a C4-6 or C5 District:
 - (i) a portion of the #lot area# that contains a wholly #commercial building# to be excluded from the calculation of #floor area# for any other #buildings# on the remainder of the #zoning lot#;

 - (2) the distribution of #floor area# and location of #buildings# will not unduly increase the #bulk# of #buildings# in any one #block# or unduly obstruct access of light and air to the detriment of the occupants or users of #buildings# in the #block# or nearby #blocks# or of people using the public #streets#;
 - (3) where a #zoning lot# of a #general largescale development# does not occupy a frontage on a mapped #street#, appropriate access to a mapped #street# is provided;

Such #open space# shall be accessible to and usable by all residents of such new or #enlarged buildings#, have appropriate access, circulation, seating, lighting and paving, Furthermore, the site plan of such #general large-scale development# shall include superior landscaping for #open space# of the new or #enlarged buildings#;
 - where the Commission permits the (7)exclusion of #lot area# or #floor area# in accordance with the provisions of paragraph (a)(5) of this Section or modification of the base and maximum #floor area ratios# or requirements regarding distribution of #affordable housing units# in accordance with paragraph (a)(8) of this Section, such modification will facilitate a desirable mix of #uses# in the #general large-scale development# and a plan consistent with the objectives of the Inclusionary Housing Program and those of Section 74-74 (General Large-Scale Development) with respect to better site planning; and
 - (8) a declaration with regard to ownership requirements in paragraph (b) of the #general large-scale development# definition in Section 12-10 (DEFINITIONS) has been filed with the Commission.

The Commission may prescribe additional

conditions and safeguards to improve the quality of the #general large-scale development# and to minimize adverse effects on the character of the surrounding area.


For a phased construction program of a multibuilding complex, the Commission may, at the time of granting a special permit, require additional information, including but not limited to a proposed time schedule for carrying out the proposed #general large-scale development#, a phasing plan showing the distribution of #bulk# and #open space# and, in the case of a site plan providing for common #open space#, common open areas or common parking areas, a maintenance plan for such space or areas and surety for continued availability of such space or areas to the people they are intended to serve.

Statement of Basis and Purpose

The Environmental Control Board is amending its

Department of Transportation (DOT) Penalty Schedule found in Section 3-124 of Subchapter G of Chapter 3 of Title 48 of the Rules of the City of New York.

Sections 1 and 2 of the rule propose to add six new charges to the Penalty Schedule. The first new charge is for the failure to obtain a permit for the storage of a commercial refuse container on the street. Carting companies must obtain permits because doing so provides a way for the DOT to track the locations of containers. This is necessary in order to help avoid conflicts with other street uses such as special events, moratoriums, and construction embargoes. In addition, knowing where commercial refuse containers are placed throughout the city will allow DOT to coordinate street opening work and other construction with contractors, utilities, DOT crews, and other city agencies. Knowing they might face a penalty for failing to get a permit provides an incentive to carting companies that otherwise might neglect to secure a permit.

The second new charge is for placing a commercial refuse container in a crosswalk or pedestrian ramp. The addition of this charge will help discourage contractors from placing containers in a manner that blocks the crosswalk, a pedestrian safety zone that is designed to give the public a safe way to cross from one side of the street to the other. Likewise, pedestrian ramps must remain unobstructed to allow members of the public who have mobility impairments to access sidewalks and streets safely.

The third new charge is for placing a commercial refuse container in a manner that causes an obstruction or interference. Ensuring commercial refuse containers do not cause obstructions or interfere with access points, bus stops, shelters and shut off valves is essential to public safety. The inaccessibility of these elements can cause a dangerous situation.

The fourth new charge is for a contractor's failure to have its business information on its container. This section applies to container owners. Placing contractor business information on refuse containers will enable the DOT to identify parties responsible for said containers and will be particularly useful if a container must be removed relatively quickly.

The fifth new charge would be issued when a commercial refuse container is not parallel to the curb or is extended more than nine (9) feet into the roadway. Containers that are not parallel to the curb or that extend out more than nine (9) feet impede the flow of traffic on the street.

The sixth new charge would be issued when a carting company has failed to use the proper street protection under a commercial refuse container. Heavy containers placed directly on the street for even short periods do considerable damage to the street surface. This charge will help discourage damage to roadways by imposing penalties against carting companies that fail to provide the necessary protection, such as $1\,\%$ inch pieces of wood under the wheels of refuse containers.

Section 3 of the proposed rule includes modifications to four existing entries in ECB's DOT penalty schedule. These modifications reflect where within the revised rules the cited codes will now appear. The penalties listed for these sections of law are unchanged.

Notice of Adoption of Amendment to Chapter 19 of Title 15 of the Rules of the City of New York Use of the Public Sewers

PURSUANT TO THE AUTHORITY VESTED IN THE Department of Environmental Protection by section 1043 and subdivision (a) of section 1403 of the New York City Charter and sections 24-308, 24-309, 24-310, 24-332, 24-334, 24-337, 24-342, and 24-346 of the Administrative Code of the City of New York, the Department of Environmental Protection amends rules governing and restricting the use of public sewers (15 RCNY 19-01 et seq.). PLEASE BE ADVISED THAT a prior version of this Rule was published in the City Record on July 16, 2010 and a public hearing was held on August 17, 2010.

Material being deleted is shown below in [brackets] and material being added is <u>underlined.</u>

Subdivision (b) of section 19-11 of chapter 19 of Title 15 of the Rules of the City of New York ("RCNY") is hereby amended to read as follows:

(b) All prefabricated grease interceptors shall be approved by the New York City Board of Standards & Appeals[,] prior to July 10, 1991, [or thereafter] approved by the New York City Department of Buildings Materials and Equipment Acceptance Division prior to July 1, 2008, or shall conform to PDI G101, ASME A112.14.3 or ASME A112.14.4 and shall be installed in accordance with the manufacturer's instructions.

Statement of Basis and Purpose

The New York City Department of Environmental Protection (DEP) promulgated "Use of the Public Sewers" (15 RCNY 19-01 *et seq.*) incorporating federal pretreatment standards and requirements, establishing sewer use limits and implementing the federal pretreatment program.

The amendment to 15 RCNY 19-11(b) is intended to reflect a change in the NYC Plumbing Code at Section 1003.3.4 effective on July 1, 2008. The new section reads, "Grease traps and grease interceptors. Grease traps and grease interceptors shall conform to PDI G101, ASME A112.14.3 or ASME A112.14.4 and shall be installed in accordance with the manufacturer's instructions." Furthermore the Materials and Equipment Acceptance Division no longer exists and has been absorbed by the Office of Technical Certification and Research (OTCR). The PDI G101 standard was developed by the Plumbing and Drainage Institute (PDI). The standards ASME A112.14.3 and ASME A112.14.4 were developed by the American Society of Mechanical Engineers (ASME). Both the PDI and ASME standards are widely accepted and followed in the plumbing industry. Grease interceptors conforming to said standards can be found at the following

websites: http://www.pdionline.org/members.htm#Licensees and http://pld.iapmo.org/

The amendment uses only the term "grease interceptors" even though the Plumbing Code refers to both "grease traps" and "grease interceptors" because although the Plumbing Code distinguishes between the two, 15 RCNY Chapter 19 does not, using only the term "grease interceptor" regardless of the rated flow. The Plumbing Code in Section 202 defines "grease interceptor" as "A passive interceptor whose rated flow exceeds 50 gpm (189 L/m)" and "grease trap" as "A passive interceptor whose rated flow is 50 gpm (189L/m) or less." 15 RCNY Chapter 19 makes no such distinction, and refers to all such devices as "grease interceptors" for the sake of simplicity. There is no practical reason to make the distinction from an enforcement standpoint. It is also in accordance with the trend in many municipalities to call all such devices "grease interceptors" rather than call the smaller devices "grease traps."

NOTICE OF ADOPTION OF FINAL RULES GOVERNING THE REMOVAL AND DISPOSAL OF DERELICT BICYCLES

NOTICE IS HEREBY GIVEN in accordance with the requirements of Section 1043 of the New York City Charter and pursuant to the authority vested in the Commissioner of the Department of Sanitation by section 753(a) and (b) of the New York City Charter and by sections 16-122 and 16-128 of the New York City Charter and by sections 16-122 and 16-128 of the New York City Administrative Code that the Department adopts the following rule governing the removal and disposal of derelict bicycles. This rule adds a new section 1-05.1 of Chapter 1 of Title 16 of the Rules of the City of New York. The Department published a Notice of Opportunity to Comment on the proposed rules in the City Record on June 18, 2010, and subsequently published an emended notice that 18, 2010, and subsequently published an amended notice that contained a different public hearing date and location on June 24, 2010. On August 10, 2010 the Department held a public hearing on the proposed rules. Existing provisions to be deleted are shown below in brackets and new provisions

Section 1. Chapter 1 of title 16 of the rules of the city of New York is amended by adding a new section 1-05.1 to read as

§ 1-05.1 Removal of derelict bicycles.

(a) Definitions. When used in this section,
(1) "Derelict bicycle" shall mean any bicycle, that is not a ghost bike, which is affixed to public property and also contains three or more of the following characteristics:
(i) the bicycle appears to be crushed or not usable; (ii) the bicycle appears to be crushed of not usable,
(iii) the bicycle is missing parts, other than the seat and
front wheel, including, but not limited to handlebars, pedal or
pedals, rear wheel and chain;
(iii) the bicycle has flat or missing tires;
(iv) the handlebars or pedals are damaged, or the existing
forks, frames or rims are bent; or

(v) sevents five percent or more of the bicycle, which

(v) seventy-five percent or more of the bicycle, which includes the handlebars, pedals and frames are rusted, along with any chain affixing such bicycle to public property.

(2) "Ghost bike" shall mean a bicycle that has been placed on public property and apparently intended as a memorial for someone who is deceased, and which may be painted white or have a sign posted on property or carrier or flowers or other memorials. have a sign posted on or near it, or flowers or other mementos

in the basket.

(3) "Public property" shall mean city property or property maintained by the city, or any public sidewalk or roadway, including, but not limited to any light pole, bus pole, parking meter, tree, tree pit, railing or similar structure. For purposes of this section, public property shall not include any bicycle rack installed by the department of transportation, any business improvement district or any private organization or entity authorized by the department of organization or entity authorized by the department of transportation.

(b) In the event that a derelict bicycle is affixed to public property, a notice shall be affixed to the derelict bicycle advising the owner that such derelict bicycle must be removed within seven days from the date of the notice. This notice shall also state that the failure to remove such derelict bicycle within the designated time period will result in the removal and disposal of the derelict bicycle by the <u>department of sanitation.</u>

(c) Nothing in this section shall preclude the immediate removal of any bicycle, including, but not limited to, a derelict bicycle or ghost bike, or the taking of any other action by any city agency if the presence of such bicycle which creates a dangerous condition by restricting vehicular or pedestrian traffic, or otherwise violates the law.

STATEMENT OF BASIS AND PURPOSE

The Commissioner of the New York City Department of Sanitation is authorized to adopt rules relating to street cleanliness pursuant to section 753(a) and (b) of the New York City Charter. Additionally, sections 16-122 and 16-128 of the New York City Administrative Code empower the Department to remove "movable property", also referred to as "encumbrances", from public property.

The Department has noticed an increase in the number of bicycles affixed to public property including, but not limited to, traffic signs and parking meters throughout the City. Some of these bicycles have missing parts, are rusted, contain flat tires, are crushed and/or appear to be unusable. These bicycles are an eyesore, a potential public safety hazard and a constant source of complaints from residents, community groups and elected officials.

In order to alleviate the concerns of interested parties, including residents, community groups and bicycle owners, the Department proposes to establish criteria that will enable it to classify certain bicycles that are affixed to public property as derelict, and allow for their removal and disposal. Under the proposed criteria, a bicycle, that is not a ghost bike, will be deemed derelict only if (1) it is affixed to public property, which for purposes of this rule only, does not include bicycle racks installed by the Department of Transportation ("DOT"), any business improvement district or any private organization or entity authorized by DOT; and (2) such bicycle meets three or more of the following criteria: (i) the bicycle appears to be crushed or not usable; (ii) the bicycle is missing parts, other than the seat and front wheel (which are typically removed by a bicycle owner to prevent theft), including, but not limited to handlebars, pedal or pedals, rear wheel and chain; (iii) the bicycle has flat or missing tires; (iv) the handlebars or pedals are damaged, or the existing forks, frames or rims are bent; or (v) seventy-five

percent or more of the bicycle, which includes the handlebars, pedals and frames are rusted, along with any chain affixing such bicycle to public property.

Once the Department makes the determination that a bicycle is derelict, a notice shall be affixed to the bicycle advising the owner that such bicycle must be removed within seven days from the date of the notice. DSNY decided to extend this time period from five days to seven days in order to give an owner more time to remove a derelict bicycle based on comments it received from the public. This notice shall also state that the failure to remove such bicycle within the designated time period will result in the removal and disposal of the derelict bicycle by the Department.

In response to comments DSNY received during the public comment period, DSNY has made several changes to the rule regarding "memorial bicycles," commonly referred to in the bicycling community as "Ghost Bikes." The rule defines "ghost bike" as a bicycle that has been placed on public property and apparently intended as a memorial for someone who is deceased, and which may be painted white or have a sign posted on or near it, or flowers or other mementos in the basket. Additionally, DSNY has exempted the inclusion of ghost bikes from the definition of derelict bicycles. As a result, under these rules ghost bikes will never be deemed to be derelict.

This rule does not authorize DSNY to remove for disposal from public property any ghost bikes or bicycles that do not meet the derelict bicycle criteria. Additionally, nothing in this rule shall be interpreted to preclude the immediate removal of any bicycle, including, but not limited to, a derelict bicycle or ghost bike, or the taking of any other action by any city agency if the presence of such bicycle creates a dangerous condition by restricting vehicular or pedestrian traffic or is otherwise in violation of the law.

Notice is hereby given in accordance with section 1043(e) of the Charter of the City of New York ("Charter") that the Taxi and Limousine Commission ("TLC") hereby promulgates amended rules governing the sale of taxicab medallions.

These rules are promulgated pursuant to sections 1043 and 2303 of the Charter and section 19-503 of the Administrative Code of the City of New York.

Public hearings on these rules were held by the TLC at its offices at 40 Rector Street, 5th Floor, New York, New York 10006 on December 5, 2008 at 2:30 P.M. and on July 8, 2010 at 10:00 A.M.

These rules will take effect on January 1, 2011.

Section 1. Title 35 of the Rules of the City of New York is hereby amended by adding a new chapter 15 thereto, to read as follows

Chapter 15 SALE OF TAXICAB MEDALLIONS

SUBCHAPTER A: SALE OF NEW MEDALLIONS

§15-01 Scope of this Subchapter

- (a) In accordance with Administrative Code §19-532, the Chairperson will issue and sell additional Taxicab Licenses up to the number authorized by state and local law.
- (b) This subchapter establishes the process for issuing and selling newly authorized Medallions.

§15-02 <u>Penalties</u>

Specific Penalties. If there are specific penalties for (a) violating a Rule, they will be shown at the end of the Rule. The penalty section will also state whether the violator must attend the Hearing.

(b) General Penalty.

- (1) Fines are due within 30 days of the day the violator is found guilty of the violation.
- (2)If fines are not paid by the close of business on the due date, the violator's <u>License</u> will be suspended until the fine is
- (3)If a Respondent has made a timely request for a copy of the Hearing recording (see §18-14(e) of these Rules), the time for payment of fines is extended to 21 days from the date the recording is issued.

§15-03 <u>Definitions Specific to this Subchapter</u>

- Bidder. An individual submitting a sealed bid for (a) one or more Lots of Taxicab Medallions or a Business Entity to which an individual Bidder assigns a bid.
- (b) \underline{Broker} or $\underline{Taxicab\ Broker}.$ For purposes of this subchapter, a Broker or Taxicab Broker will include any person or entity, and any person or entity which is an owner, shareholder, partner, member or employee of such person or entity, that represents <u>or advises any Bidder or potential Bidder in</u> connection with an actual or potential bid and meets either of the following criteria:

- (1) Provides advice regarding bid price or potential bid price; or
- (2)Obtains actual knowledge of the bid price submitted by any Bidder while providing representation or advice.
- (c) <u>Closing Deadline</u>. A Closing Deadline will be the date by which a winning Bidder must close on any Lot as established in §15-07(a).
- (d) Independent Medallion. A class of Medallion Taxicab License, the owner of which may only own one Medallion.
- (e) Lot. Medallions being sold in a single unit, which will be one Medallion in the case of an Independent Medallion and two or more Medallions in the case of Minifleet Medallions.
- Minifleet Medallion. A class of Medallion Taxicab (f) License, the owner of which must own at least two Minifleet Medallions.
- Reserve Status and Reserve Status Bids. The highest ten percent of the non-winning bids in each category hold Reserve Status, unless the Chairperson determines a greater number of nonwinning bids will receive Reserve Status and sets a higher qualifying percentage. A bid holding Reserve Status is a Reserve Status Bid and is converted to a winning bid when a winning Bidder fails to comply with the Closing Deadlines established in this Rule.

§15-04 General Provisions

- Sale by Sealed Bid. The public sale of newly issued (a) Taxicab Medallions will be done by Sealed Bid.
- (b) Classification of Medallions. Each Medallion will belong to only one of the following classifications and will permanently remain in that classification regardless of change in ownership of the Medallion
 - (1)<u>Independent Medallion</u>
 - (2)Minifleet Medallion
 - Accessible Independent Medallion (3)
 - Accessible Minifleet Medallion (4)
 - Alternative Fuel Independent Medallion (5)
 - Alternative Fuel Minifleet Medallion (6)
- (c) Sale in Lots. New Medallions will be sold in Lots.
- (d) Ratios of Medallion Classifications. The ratio of <u>Minifleet Medallions to Independent Medallions</u> $\underline{(whether\ Restricted\ or\ Unrestricted)\ will\ be}$ maintained in accordance with §19-504(i) of the <u>Administrative Code.</u>
- (e) Separate Public Sales. Separate sales may be conducted for each of Independent Medallions, <u>Minifleet Medallions, Accessible Independent</u> Medallions, Accessible Minifleet Medallions, Alternative Fuel Independent Medallions, and Alternative Fuel Minifleet Medallions.
- **§15-05** Commission Procedures for Holding a Sealed Bid
- Notice of the Sale. Sealed bid sales and any postponements of these sales will be publicized as
 - Publication of Sealed Bid Sale. The Chairperson will publicize each sealed bid sale by placing an announcement in the City Record for five consecutive days, beginning at least thirty days prior to the deadline for bidding. The announcement will include the following:
 - (i) The date and time on which bids
 - (ii) The number of Medallions to be
 - (iii) Whether those Medallions will be sold as Independent Medallions, Minifleet Medallions, Accessible Independent Medallions, Accessible Minifleet Medallions, <u>Alternative Fuel Independent</u> Medallions, or Alternative Fuel Minifleet Medallions;
 - (iv) The numbers of Minifleet and <u>Independent Medallions to be</u>
 - (v) The percentage of highest nonwinning bids that will determine the Reserve Status class for each type of Medallion to be sold; and
 - Other terms of sale. (vi)
 - (2)Publication of Postponements. The Chairperson has the ability to postpone the public sale. The Chairperson will place an announcement of the postponement in the City Record for five consecutive days, beginning at least ten days prior to the new deadline for bidding.

- (3) <u>Additional Notices. The Chairperson can</u> place additional notices in the City Record or other publications.
- (b) Pricing
 - (1) The Chairperson will set a minimum upset price for Medallions to be sold.
 - (2) The Chairperson will establish different upset prices for each type of Medallion sold.
 - (3) A minimum upset price will be published in the City Record at least ten days prior to the deadline for submission of bids.
 - (4) Any bid received that is less than that minimum will be rejected as non-responsive.
- (c) <u>Bid Opening</u>
 - (1) The Chairperson will set a date when the bids will be opened in public and the winning bids announced at the public sale.
 - (2) The winning bids will be the highest bids that are complete and responsive as established in §15-06.
 - (3) The winning Bidders will be notified promptly by certified mail.
 - (4) Tie bids will be decided with a drawing, which will be held at the bid opening.

 This process will also be used to determine tie bids that qualify for Reserve Status.
 - (5) Winning bids will be published in the City Record and posted at the Commission's office and on the Commission's website.
- (d) <u>Reserve Status Bids</u>
 - (1) The Chairperson will determine the number of the highest, non-winning bids that will be given Reserve Status for each type of Medallion sold. This number will not be less than ten percent of the total number of Medallions of that type being sold
 - (2) The holders of the highest non-winning bids that have been given Reserve Status will be notified of their Reserve Status.
 - (3) Reserve Status may be converted to a winning bid if a winning Bidder fails to comply with the Closing Deadlines established in this Rule.
 - (4) The Chairperson will notify the holder of a Reserve Status Bid when that status changes to a winning bid. The date of notification will be the date of the bid opening for purposes of calculating the holder's deadlines under this Subchapter.
 - (5) The Chairperson will hold a drawing at the bid opening to determine which bids will be given Reserve Status if there are more bids at the lowest bid price qualifying for Reserve Status than set by the Chairperson.
 - (6) A winning Bidder for any Lot that fails to comply with the Closing Deadline requirements will be disqualified from Reserve Status.
- (e) <u>Assignment of the Winning Bid</u>
 - (1) The rights of a winning Bidder can only be assigned prior to the close of sale by a winning Bidder who is a Business Entity Person to a Business Entity.
 - (2) The rights of a winning Bidder may not be assigned to any Business Entity if any Business Entity Person of that Business Entity did not comply with the Closing Deadline requirements associated with a winning bid on any higher priced Lot.

§15-06 Procedures for Bidding

- (a) <u>Submitting a Bid. Each Bidder must do the</u> following:
 - (1) Submit bid on the form determined by the Chairperson.
 - (2) Submit only one bid for one Lot per envelope.
 - (3) <u>Include with each bid the following:</u>
 - (i) For each Medallion for which a
 Bidder submits a bid, a deposit
 of \$2,000 in a certified check,
 bank check, money order, or a
 check issued by a Taxicab
 Broker or Agent licensed by the
 Commission pursuant to
 chapter 12 or chapter 13 of this
 title respectively, payable to the
 "New York City Taxi and
 Limousine Commission"; and
 - (ii) A letter of commitment for no less than eighty percent of the bid amount, issued by a bank or

- credit union licensed to do
 business in the State of New
 York or other lender licensed by
 the State of New York or the
 Federal Government.
- (4) Submit bid in a 9" x 12" sealed envelope with a cover form determined by the Chairperson on which the Bidder must indicate the following:
 - (i) The Bidder's name, address, phone number and date of sale; and
 - (ii) The type of Medallion Lot.
- (5) Submit each sealed bid by hand delivery at the time and place designated by the Chairperson.
- (6) Submit each bid between 9:00 a.m. and 12:00 noon on any of the four business days immediately prior to the deadline for bidding
- (b) Late Bids. Any bid presented to the Commission after the deadline in 15-06(a)(6) will not be accepted.
- (c) <u>Required Certifications</u>. As part of each bid form, the Bidder must certify the following:
 - (1) The Bidder has not relied on any statements or representations from the City of New York in determining the amount of the bid.
 - (2) The Bidder has not colluded, consulted, communicated, or agreed in any way with any other Bidder or prospective Bidder for the purpose of restricting competition or of inducing any other prospective Bidder to submit or not to submit a bid for the purpose of restricting competition.
 - (3) The Bidder has not disclosed any bid price, directly or indirectly, to any other Bidder for the purpose of restricting competition or of inducing any other prospective Bidder to submit or not to submit a bid for the purpose of restricting competition.
 - (4) The Bidder is not acting as a Taxicab
 Broker for any other Bidder and is not the
 owner, shareholder, partner, member, or
 employee of any person or entity acting as
 a Taxicab Broker for any other Bidder.
- (d) <u>Non-Responsive Bids. The following will be</u> considered "non-responsive" bids and will be rejected:
 - (1) <u>Bids not rounded to the nearest one-cent</u>
 - (2) Bids not using the proper form or the proper envelope.
 - (3) Bids where the form or envelope cover form is not properly completed, as determined by the Chairperson.
 - (4) <u>Bid packages that do not have the proper deposit.</u>
 - (5) Bid packages that do not contain a commitment letter meeting the requirements of this section.
 - (6) <u>Bid packages containing bids for more than one Lot per envelope.</u>
 - (7) <u>Bids that are non-responsive or non-conforming in any other respect.</u>
- (e) All Bids Final. All bids are considered final and no Bidder will be allowed to correct any bid after submission.

§15-07 Closing on the Purchase

- (a) <u>Closing Deadlines</u>
 - (1) Within thirty days after the bid opening, each winning Bidder must close on his or her Medallion(s). If the winning Bidder is unable to close within that period, Bidder must complete the following no later than thirty days after the bid opening:
 - (i) Deposit twenty-five thousand dollars (\$25,000) in a certified check for each Medallion covered by the winning bid; and
 - (ii) Provide the Chairperson with proof of purchase of a vehicle eligible for Hack-Up (see Chapter 17) in the form of a certificate of origin, a certificate of title, a bill of sale, or a signed sales contract.
 - (2) All purchases of Medallions must close by no later than sixty days after bid opening unless extended by the Chairperson for reasonable cause shown.
 - (3) All closing dates are subject to the approval of the Chairperson.
 - (4) No closing date can be scheduled until the winning Bidder has done the following:

- (i) Demonstrated compliance with all of the requirements for issuance and ownership of a Taxicab License; and
- (ii) Submitted proof of purchase of a vehicle eligible for Hack-Up in the form of a certificate of origin, a certificate of title, a bill of sale, or a signed sales contract.
- (5) A winning Bidder's failure to comply with the provisions in this subdivision will result in the disqualification of the winning bid.
- (b) Additional Pre-Closing Requirements. Each winning Bidder must complete the following prior to closing:
 - (1) Submit all documentation required by the Chairperson.
 - (2) <u>Clear outstanding fines and penalties.</u>
 - (3) Submit fingerprint records as directed by the Chairperson unless the Bidder has electronic fingerprints already on file with the Commission.
- (c) Post-Closing Requirement: Hack-Up each
 Medallion sold under this Subchapter no later than
 the fifth business day following the day of the
 closing on the sale of the Medallion, unless
 extended by the Chairperson for reasonable cause
 shown
- (d) Special Requirements for Winners of Independent
 Medallion. Each winning Bidder of an Independent
 Medallion must demonstrate the ability to comply
 with the "Owner-Must-Drive" service requirements
 set forth chapter 8 of this title. Winners may fulfill
 this requirement through the following:
 - (1) <u>By personally holding or obtaining a</u> <u>Taxicab Driver's License; or</u>
 - (2) If the Medallion has been assigned to a
 Business Entity, by identifying a
 Business Entity Person who holds such a
 License.
- (e) Payment. The winning Bidder will be responsible for payment of the following:
 - (1) The balance of the purchase price (the bid amount, minus any deposits);
 - (2) <u>Any applicable taxes;</u>
 - (3) Two years' worth of license and inspection fees (as provided in §8-07 of this title); and
 - (4) Any other fees due. No Medallion transfer tax will be collected for the initial Medallion issuance.
- $\underline{\textit{Disposition of Deposits}}$
 - (1) All deposits of winning Bidders will be credited toward the sale price.
 - (2) If the winning Bidder is not qualified to hold a license, the deposit will be refunded.
 - (3) A winning Bidder who does not attempt to meet the requirements of this subchapter, including a winning Bidder who fails to comply with the Closing Deadlines, will lose all deposits made under §15-06.
 - (4) <u>Deposits of non-winning and non-responsive Bidders will be returned by the Chairperson.</u>
 - (5) Deposits submitted with bids that achieve
 Reserve Status will be held until those
 bids are converted to winning bids or
 until the sales have closed for all Lots of
 Medallions of the type for which the bid
 was made
- $\underline{\textit{Disqualification}}$
 - (1) A winning Bidder's failure to meet the Closing Deadlines provided in this section will result in the disqualification of that Bidder as to that winning bid and the forfeiture of deposits made under §15-06 for that winning bid.
 - (2) A winning Bidder whose bid is disqualified due to Bidder's failure to meet the Closing Deadlines established here will also be disqualified and will have all deposits made under \$15-06 forfeited with respect to any Reserve Status Bids that Bidder may have.
 - (3) A winning Bidder who has more than one winning bid or Reserve Status Bid (including any bids assigned to a Business Entity in which that Bidder is a Business Entity Person) must close first on his or her highest winning bid and then in descending order of each next highest winning bid(s).
 - (4) A winning Bidder who has more than one winning bid or Reserve Status Bid (including any bids assigned to a Business Entity in which that Bidder is a Business

Entity Person) may not avoid closing on the higher winning bid(s) by failing to meet Closing Deadlines. In such a case, the winning Bidder will be disqualified first on the lowest of his or her winning bids and then in ascending order on each of the next lowest winning bids. The deposits made under §15-06 for the disqualified bids will be forfeited.

§15-08 Conflict of Interest Prohibitions

(a) A Bidder cannot collude, consult, communicate, or agree in any way with any other Bidder or prospective Bidder for the purpose of restricting competition or inducing any other prospective Bidder to submit or not submit a bid for the purpose of restricting competition. A Bidder cannot disclose any bid price, directly or indirectly, to any other Bidder for the purpose of restricting competition or inducing any other prospective Bidder to submit or not submit a bid for the purpose of restricting competition. In addition to any other penalties provided by law, violation of $\underline{this\ subdivision\ or\ submission\ of\ a\ false}$ certification under §15-06 of this Subchapter will result in the disqualification of all bids submitted by that Bidder.

§15-08(a) Penalty: \$10,000 fine and either disqualification of bid or, if sale has closed, revocation of Taxicab

Appearance REQUIRED

(b) A Taxicab Broker cannot submit a bid to purchase any Lot if that broker is acting as a Taxicab Broker for any Bidder. This prohibition also applies to any Business Entity Person or employee of a Taxicab Broker.

§15-08(b) Penalty: \$10,000 fine and either disqualification of bid or, if sale has closed, revocation of Taxicab

SUBCHAPTER B: SALE OF REISSUED MEDALLIONS

§15-11 Scope of this Subchapter

This Subchapter establishes the procedures for the Commission to reissue Taxicab Medallions that have been revoked where the owners of such revoked Medallions did not provide for the resale of the Medallions.

§15-12 Penalties

This Subchapter is informational in nature and does not contain any penalties.

§15-13 <u>Definitions Specific to this Subchapter</u>

Reissued Medallions are Medallions that meet the following

- (a) The original owner's Medallion Taxicab License has been revoked;
- (b) The original owner failed to sell or otherwise legally dispose of the Medallion; and
- (c) The Medallion was repossessed by the Commission and subsequently re-issued for sale to a new owner.

§15-14 General Provisions

- (a) Re-Issuing Medallions. Any Taxicab Medallion that has been revoked by the Commission and not sold by the Owner prior to revocation may be repossessed by the Commission and reissued and sold by the Commission.
- (b) <u>Sale by Public Auction</u>. The sale of reissued Medallions will be done by public auction.
- §15-15 Commission Requirements for Conducting the Public Auction
- (a) <u>Licensed Auctioneer.</u> The public auction will be conducted by a licensed auctioneer.
- (b) Notice. The auction sale will be advertised in the City Record for at least twenty days before the auction. At his or her discretion, the Chairperson can also advertise the auction in newspapers and
- (c) <u>Maintenance of Medallion Classification.</u> The classification of Medallions issued under this Subchapter will not change regardless of change in ownership of the Medallion after issuance.
- (d) Sale of Minifleet Medallions
 - (1) A Minifleet Medallion can be issued only to a corporation that owns at least one other Minifleet Medallion. The purchase at auction of two Minifleet Medallions will satisfy that requirement.
 - (2) If more than one Minifleet Medallion is being auctioned, the Medallions will be auctioned first as a pair and then separately. The final sale of the Medallions will be in the manner (as a pair or separately) that will bring the highest return to the City.
- \$15-16 Chairperson's Authority to Modify Auction Procedures
- (a) <u>Cancellation. The Chairperson can, at any time and</u> for any reason, postpone or cancel an auction.
- (b) <u>Modification</u>. The Chairperson may modify the bidding or closing procedures established below

provided that a public notice in the City Record is made in advance of the auction.

(c) <u>Delegation and Discretion.</u> The Chairperson may take further measures as may be appropriate to the sale of the medallions.

§15-17 <u>Bidding Requirements and Procedures</u>

- (a) Bidder Criteria. Any person can bid. However, the highest Bidder must satisfy all criteria for Taxicab License owners. The Chairperson will review the application for a license by the highest bidder to determine if that bidder satisfies the ownership criteria.
- (b) Application for Medallion License. The highest bidder must file an application for a Taxicab License with the Commission within three weeks from the auction date, unless the Chairperson extends the deadline for good cause.
- (c) <u>Denial of Application.</u>
 - (1) If the highest bidder's application for a license is denied for any reason, the second-highest bidder will be awarded the sale on condition that the second-highest bidder's application for a Taxicab License is approved by the Chairperson.
 - (2) If neither the highest bidder's nor the second-highest bidder's application for a license is approved, the auction will be nullified.

§15-18 Closing Requirements and Procedures

- (a) <u>Deposit.</u> Immediately after the close of bids, the highest Bidder must provide a deposit to the auctioneer covering a percentage of the high bid as set in advance by the Chairperson. The deposit must be in the form of a certified check, a money order, or such other form as set in advance by the Chairperson and published in the City Record.
- (b) Other Payments Due. In addition to the amount bid, the highest Bidder will be responsible on the transfer closing date for any sales tax, Medallion transfer tax, or other applicable taxes or fees.
- (c) <u>Stay of Closing.</u> The outcome of an auction remains conditional pending the resolution of any challenge to the Commission's legal authority to issue and auction the Medallion.

Statement of Basis and Purpose of Rules

These rules are promulgated pursuant to sections 1043 and 2303 of the Charter and section 19-503 of the Administrative Code of the City of New York. The rules are part of a project undertaken by the Taxi and Limousine Commission ("TLC") to revise its existing rule book. The first phase of this project consisted of reorganizing and redrafting TLC's rules, to enhance their clarity and accessibility without significant substantive change. Accordingly, these rules are not intended

to make any changes to TLC's current policies, procedures or operations.

During this first phase of the rules revision project, all of TLC's existing rules were redrafted, then posted on a chapter-by-chapter basis on the TLC Web site for review and discussion by interested members of the public. Each chapter was revised based on that discussion, then published for public comment and public hearing pursuant to the City Administrative Procedure Act (CAPA). Because this phase of the rules revision was intended to involve no substantive changes to the rules, and as announced at the Commission meeting held on August 7, 2008, public hearings were held separately from monthly stated Commission meetings.

When this process had been completed for all TLC rules, the complete set of rules was presented to the Commission for promulgation simultaneously with repeal of the current set of TLC rules. The revised rules will replace the existing rules compiled in chapter 35 of the Rules of the City of New York. Following promulgation of these rules, the rules will become effective and the repeal of the current rules will occur on January 1, 2011.

After the first phase of its rules revision is completed, TLC will move to the second phase, which will involve the assessment of its rules for more substantive changes.

The rules promulgated here are as follows:

Chapter 10, Rules Governing
Public Auction of Taxicab Licenses and Chapter 13, Rules Governing
Issuance and Public Sale of
Taxicab Licenses

New Rule Chapters
Chapter 15, Sale of

The rule as initially proposed made one substantive change. To fully incorporate the provisions of Local Law 16 of 2008, the penalty provisions were amended to reflect that fines are stayed for thirty days, and further pending decision of a timely-filed appeal.

Supplemental Statement

A public hearing on these rules was held on December 5, 2008. Following that hearing the TLC voted at a public meeting on February 12, 2009 to conditionally approve these rules, subject to a further vote of approval after all 19 revised rules chapters have been conditionally approved. All 19 chapters having been conditionally approved by the TLC, the 19 chapters were republished for additional public comment, another hearing and final approval by the TLC, which occurred on July 15, 2010.

After the conditional TLC approval of this rules chapter (and before final approval), the following additional substantive changes were made to this chapter as a result of public comment and testimony previously received and considered and staff comments:

The general penalty and fines section was amended to align payment of fines terms with those of other chapters. These changes were made as a result of staff comment based on further drafting refinements made by the consultant.

The Reimbursable Metering Program ("RMP") allows owners of unmetered properties, or properties with outdated or malfunctioning water meters, the opportunity to have meters installed/replaced by licensed master plumbers of their own choosing and to receive reimbursement from the Board. Reimbursement is in the form of a credit to the property's water/wastewater account with the New York City Department of Environmental Protection ("DEP"), which can be applied against current or future bills or may be refunded to those customers who are eligible and so request. The credit is equal to the scheduled amount or the actual amount paid to a plumber for each type and size of meter installed or replaced, whichever is less. The proposed changes include the

- 1. Extending the time period for licensed plumbers to return original completed meter permits to a DEP Bureau of Customer Services Borough Office from 72 hours to ten (10) business days;
- 2. Adjustments to the scheduled reimbursement amounts for various meter sizes and types; 3. Addition of "Enhanced Meter Reimbursement Amounts"
- (effective for two years only) for meters 3" and larger that were installed before 1995;
 4. Merging of reimbursements for replacement of compound,
- single-jet or electromagnetic meters with single-jet or electromagnetic meters;
 5. Requirement that requests for extensions of meter
- installation or replacement permits, which are valid for 30 days, must be received prior to the expiration of the 30-day
- 6. Elimination of reimbursement for telephone-based AMR equipment installations;
 7. Elimination of reimbursement for installing or replacing
- detector check valve assemblies; and
- 8. Minor updates and editorial changes to the RMP booklet.

Specific details, including the rules, guidelines, forms, and reimbursement schedule are provided in DEP's "Reimbursable Metering Program" booklet.
