Introduction

Access to opportunity and growth for New York City's minority- and women-owned businesses is a key priority for Mayor Michael R. Bloomberg and the Department of Small Business Services (SBS). Since the Mayor signed Local Law 129 just over a year ago, we have worked with the City Council, City agencies, community organizations, and our certified Minority- and Women-Owned Business Enterprises (M/WBEs), to move closer towards ensuring opportunity in City procurement and building the strongest M/WBE program the country.

This preliminary report, covering Local Law 129 data from the first two quarters of Fiscal Year 2007 (July 1-December 31, 2006) is submitted to Speaker Christine C. Quinn of the City Council. Pursuant to § 6-129(l)(1), the report is jointly submitted by the Director of the Mayor's Office of Contract Services (MOCS), as City Chief Procurement Officer, and by the Commissioner of SBS. This is the first report due under Local Law 129, and as such marks the first time utilization figures for City certified M/WBEs are being reported in the procurement, industry, gender and ethnicity categories defined by the Local Law.

By the end of the second quarter of Fiscal Year 2007, 1,029 companies had certified as New York City M/WBEs, up from 850 in 2003. Over the last five years, we have seen a consistent increase in the number of new companies entering the program and this year we expect to continue this trend.

We are also seeing an important and telling trend as the number of companies that are choosing to come back and recertify with the City also increases. This time last year, just over 25% of expiring companies chose to recertify as M/WBEs, but this year over 50% have recertified. With implementation of Local Law 129 six months into its three year ramp up period, business owners now recognize they have something to come back for.

The New Program

Simplify the certification process, without compromising standards.

To make the certification process more accessible, during the first half of Fiscal Year 2007, SBS introduced a user-friendly application that is easier to understand and to complete, provided 20 M/WBE certification classes for 305 attendees, and increased the certification period from 2 years to 5 years.

In December, SBS launched an upgraded version of the Online Directory of Certified Businesses. The upgrades were informed by feedback from buyers at City agencies, and make the Directory more functional for agencies and prime contractors who seek to identify certified companies to fulfill contracting and subcontracting goals. The Directory now features information on each business' contract experiences, City certifications, ethnicity and gender, and other information relevant to Local Law 129 compliance. Searches in the upgraded Directory can be downloaded into Microsoft Excel for ease of use. The Directory is located at www.nyc.gov/getcertified.

Foster business growth within our certified base.

SBS has created a case management system to customize assistance for every individual firm that becomes a New York City certified M/WBE. Procurement counselors reach out to certified companies

to get to know them and to get to know their business needs. This customized assistance has helped assessed companies win \$17 million in City contracts during the first half of this fiscal year.

To ensure companies have the knowledge they need to submit a competitive bid, SBS offers classes to our clients in financing, bonding, selling to government and procurement strategies. In the first half of the fiscal year, 298 people have attended these classes. The agency also provided 98 one-on-one technical assistance sessions to help companies prepare responses to bid and proposal solicitations, and is expanding these services by engaging experienced service providers this spring.

In the first six months of the fiscal year SBS designed the *Fundamentals in Construction Management* program, a certificate program to be offered exclusively to New York City-certified construction firms. Program development included a survey of 335 certified construction firms to identify subject areas for classes, finding an appropriate partner for classroom space, and identifying high-quality instructors with industry expertise and teaching experience. The program, which began in February, in partnership with CUNY's College of Technology, offers six multi-session courses taught by industry professionals in topics including cost estimating, project scheduling, and construction law.

Empower agencies and prime contractors with the tools and knowledge they need to increase the utilization of M/WBEs.

- SBS and MOCS have provided detailed instruction to hundreds of City purchasing personnel and some of the City's largest prime contractors on how to meet the requirements of Local Law 129. These sessions included a tutorial on the implementation of Local Law 129, using the upgraded M/WBE Online Directory as a tool for finding M/WBEs, information on the responsibilities of prime contractors, subcontractor utilization plans, and the methodology for setting subcontractor goals. In the first half of the fiscal year, SBS and MOCS have provided eight training sessions with over 170 attendees, bringing the total of trainees to over 400 since program implementation. The three types of training are as follows:
 - Training at the Procurement Technical Institute (PTI) – At the DCAS City-wide training center, where agency procurement staff receive professional credits for attended sessions.
 - Agency Specific Training – At the request of agencies, SBS and MOCS have provided tailored sessions with the Department of Design and Construction (DDC), the Department of Homeless Services (DHS) and the Department of Probation (DOP).
 - Prime Contractor Training – Detailed instruction for prime contractors with frequent subcontracting activity on how to meet the requirements of Local Law 129.

- SBS speaks at and attends events in every borough of the City to ensure that all communities are aware of the benefits of Local Law 129. SBS has joined organizations to cosponsor or participate in events aimed at serving M/WBEs. Some highlighted events of the first half of the fiscal year are:
 - US Department of Commerce Minority Business Development Agency (MBDA) – SBS cosponsored this event, inviting purchasing personnel of 5 City agencies (DOS, DDC, DCAS, DEP, and HPD) to discuss upcoming procurement opportunities with 500 attending companies.
 - NYS Federation of Hispanic Businesses – SBS presented procurement opportunities with the city to over 1000 companies. The event was also attended by staff from DCAS, DEP, Law, DSNY, and DOC.

- Black Churches Mean Business – SBS presented on a supplier diversity panel at the Brooklyn Museum to approximately 120 businesses.
 - 10th Anniversary Rainbow/Push Wall Street Project – SBS hosted this all day workshop and participated in a panel discussion on the City’s M/WBE Program.
- SBS also organizes networking events with City agencies that link M/WBEs with upcoming contracting opportunities – the Department of Homeless Services in November networking event alone yielded 34 contracts for our M/WBEs worth \$71,294, as of February.
- In the first six months of program implementation, many City agencies have gone above and beyond the requirements of Local Law 129. Among the highlights are:

The Department of Design and Construction (DDC):

- DDC includes on their website a list of all current and upcoming contracts with subcontracting goals and provides the details of the goals associated with these contracts and the work anticipated to fulfill these goals

The Departments of Sanitation and Environmental Protection (DOS and DEP):

- DOS and DEP now schedule one-on-one meetings with certified M/WBEs that they believe they could do business with, discussing upcoming contracting opportunities and what they are looking for to fulfill these opportunities.
- DOS also meets with unsuccessful certified M/WBE bidders to discuss what could have been stronger in their bids and what the agency was looking for.

Housing Preservation and Development (HPD)

- HPD has been working closely with SBS to provide discounted and no-cost certification classes on lead awareness and safe work practices to certified M/WBEs.
- HPD is working with SBS to help educate certified M/WBEs about the criteria and process to get these companies on HPD’s pre-qualified lists.

Law Department (Law)

- Law has implemented a policy requiring staff to solicit M/WBEs for most contracts and to inform the Agency Chief Contracting Officer (ACCO) of results when seeking approval for procurements. In order to comply, agency staff are instructed to identify M/WBE vendors by using the City’s Online Directory, as well as Law’s own list of resources, including MWBE directories from other jurisdictions and professional organizations.
- Law has made extensive outreach efforts by sending letters to bar associations, and other professional organizations and to recent contractors to notify them about the M/WBE program; publishing articles in the New York Law Journal and New York County Lawyers newsletter; and placing a notice in the church bulletin at Emmanuel Baptist church of 4200 congregants. Law has also urged law firms to become certified themselves if eligible, to encourage their clients to certify, and to consult the Online Directory to promote diversity in their own contracting activities.
- Law has become a public partner of the National Association of Minority and Women Owned Law Firms.

Outside the parameters of Local Law 129, in the first half of the fiscal year, certified companies have won 9 prime contracts over \$1 million awarded by DDC, DPR, DEP, DOP and FDNY. The three highest contract values were \$4.6 million, \$2.5 million, and \$2.3 million.

Many agencies have made significant efforts in awarding procurements under \$5,000, where they have more discretion. There has been notable performance in this area by the following agencies:

Build in accountability.

Local Law 129 mandates that agencies and prime contractors are held accountable for making good faith efforts to achieve goals. To this end, SBS and MOCS, in conjunction with the Law Department, created the tools to ensure accountability. Together we produced the templates for agency and subcontractor utilization plans, supplemental documents, standard contract language, and published the M/WBE program rules, promulgated in August 2006 under the City Charter’s process. All agencies required by the Local Law to submit utilization plans for Fiscal Year 2007 fulfilled this requirement.

To best serve certified companies, the City must be able to determine if they are winning contracts and subcontracts, therefore we are expanding the City’s ability to collect detailed utilization information. SBS and MOCS have partnered with the Financial Information Services Agency (FISA) to transform existing and incorporate new technologies into data collection. This effort is creating a system for centralized tracking, automated reporting, and agency accountability.

Spread the word.

The City has made every effort to ensure that current and prospective M/WBEs know about the opportunities available to them. In the first half of the fiscal year, SBS retained a certified M/WBE to document successful certified companies in a series of photographs. With these, SBS created a marketing campaign featuring real success stories launched in *La Voz Hispana*, *Amsterdam News*, and the *Dodge Construction Report*. In the spring, ads will appear in *Desi Talk* and *World Journal* to reach the Asian-owned business community. Some of the success stories can be seen in the new M/WBE program brochure rolled out last month. The brochure was designed by a certified M/WBE.

Additionally, SBS publishes a series of monthly columns in *Minority Commerce Weekly* and *La Voz Hispana*. In July, an article about the City's program appeared in *New York Construction Magazine*. These articles are part of a larger effort to increase small business awareness of the new M/WBE program. Topics include the value of certification and re-certification, M/WBE policy initiatives, upcoming workshops and seminars and tips on how to navigate City purchasing. SBS has also been joined by the City Council and community organizations in outreach efforts. In the first half of the fiscal year, SBS received official notification of M/WBE Leadership Association Program funding by the City Council. This began the planning stages of this program where community partners assist us in getting eligible companies certified and helping them understand how to do business with the City. Additionally, during this period, planning began for the workshops organized in partnership with City Council Members and the Economic Development Corporation. Since December, two successful workshops were launched. The first, with Council Member Melissa Mark-Viverito, and the other, cosponsored by Speaker Christine Quinn, Council Member Kendall Stewart, and the Caribbean American Chamber of Commerce and Industry (CACCI).

Prime Contracts

In the table below, we present preliminary data showing the City agencies' award of prime contracts during the first two quarters of Fiscal Year 2007. Because many of the training, outreach, and capacity-building activities detailed above are very recent, and have not yet borne fruit, the data does not yet reflect the levels of M/WBE participation the City is aiming to achieve.

Unlike prior compilations, such as those set forth in the disparity study sponsored by the City Council in support of Local Law 129, the tables below credit agencies with the utilization of *only certified* M/WBEs. Prior studies also included as "minority-owned" or "woman-owned" qualified companies that had not sought certification. In addition, the overwhelming majority of the prime contracts reflected in the data (*i.e.*, all except the professional services contracts) are required by New York State law to be procured via competitive sealed bid. While City agencies have thus established M/WBE participation goals for prime contracts, their efforts to achieve those goals are limited to such means as increased outreach and training, to encourage M/WBEs to bid successfully on various procurements. The basic award mechanism remains unchanged (sealed low bid).

Agency-by-agency tables for each of the above compilations are included in the appendix to this report. It should be noted, however, that because this preliminary report covers only a few months early in the Local Law 129 program implementation, it does not yet include a sufficient amount of data to permit conclusions to be drawn concerning individual agency trends.

Subcontracts

Most of the contracts registered during the first two quarters of Fiscal Year 2007 were solicited prior to the July 1, 2006 effective date of the Local Law 129 subcontractor participation goals. Two competitive sealed bid contracts were registered, with respect to the data required to be submitted under § 6-129(I)(1)(vii)(A)-(C). Both of these were Department of Parks and Recreation (DPR) contracts for construction services; both included participation goals pursuant to § 6-129(i) and neither was with a joint venture.

The first, registered on December 1, 2006, was a \$1,114,325 contract with William A. Gross Construction Associates, Inc. At the time of solicitation (August 31, 2006), DPR assigned a target

subcontracting percentage of 77%, and an M/WBE participation goal of 32% (of that subcontracting total). The vendor accepted the stated goal in its utilization plan, and initially identified two qualified subcontractors (both African-American) whose work would be credited against the approximate \$275,000 worth of required M/WBE subcontracting.

The second, registered on December 21, 2006, was a \$2,319,066 contract with A.R. Brothers Construction Co. At the time of solicitation (August 21, 2006), DPR assigned a target subcontracting percentage of 10%, and an M/WBE participation goal of 100% (of that subcontracting total). The vendor met that goal, identifying all of its subcontractors in its utilization plan, with five subcontracts for construction services: one to an Asian-American firm, for 5% of the required amount; three to African-American firms, for a total of 45% of the required amount; and one to a Hispanic-American firm, for 45% of the required amount.

With respect to § 6-129(l)(1)(vii)(D), there were 33 requests made for waivers of the target subcontracting percentages pursuant to § 6-129(i)(12), during the time period covered by this preliminary report.

Seven waivers were denied, and 26 were approved in full or in part. Since waivers are granted only to companies that demonstrate both the capacity and history (past practice) to do the work without subcontracting, many of the 26 waivers involved the same firms (*i.e.*, one firm seeking waivers for multiple bidding opportunities). Thus, the 26 waivers covered only 12 individual firms.

In addition, since waivers are decided during the pre-bid stage of the procurement, most of the recipients of the waivers do not ultimately win the contract award. *Only one* of the waivers was granted to a company that ultimately became the winning bidder.¹

Of the 26 waivers granted, nine involved full waiver requests (*i.e.*, with documentation seeking permission to do *no* subcontracting); four were granted in full and five were granted as partial waivers, allowing the firm to do less subcontracting than the agencies' targets. Similarly, while 17 of the 26 waiver requests sought partial waivers (*i.e.*, with documentation seeking permission to do *less* subcontracting than targeted), of which 14 were granted as requested, and three were granted at an adjusted, larger percentage. The determinations are detailed in the table below.

¹ Heavy Construction Co., Inc. was awarded the contract resulting from the 10/17/2006 bid opening noted above, but this contract was not registered until after the period covered by this report (*i.e.*, on 2/1/2007).

Complaints Received/Non-Compliance Findings

With respect to the data required by § 6-129(l)(1)(viii), SBS and MOCS received relatively few compliance-related complaints within the meaning of § 6-129(o)(1). In one instance in July 2006, JFD Sales, a certified Hispanic-owned MBE complained that the City was relying upon citywide requirements contracts, which bundle commodities purchases into larger categories, rather than allowing agencies to make individual purchases of the same or similar goods from MBEs listed on the State Office of General Services (OGS) contracts. MOCS responded by explaining the basis for approving the use of requirements contracts, including the fact that in the business area of the complaining firm (office furniture), several other M/WBEs had successfully competed to win such requirements contracting opportunities.

In another instance in December 2006, Technical Associates, Inc., a certified Hispanic-owned MBE complained that the Department of Correction (DOC) had advised the firm that, as a certified MBE, it did not have to submit a completed subcontractor utilization plan with its bid, but then had later found the firm non-responsive. MOCS intervened to require that DOC cancel the original bid and re-bid the job with correct information. This same vendor also complained in March 2007 about a sole source notice published in the City Record by the Parks Department for design services. MOCS responded by explaining that the procurement had resulted from the City's need to acquire work product and services from an architect previously retained by a private concessionaire, as part of the City's decision to take over construction of a park previously intended to be handled as part of a concession agreement.

With respect to the data required by § 6-129(l)(1)(ix), as very few covered contracts are yet underway, no City agency has yet had occasion to consider any non-compliance issues pursuant to § 6-129(o)(4).

Number of Firms Certified or Recertified

With respect to the data required by § 6-129(l)(1)(x), during the time period running from July 1-December 31, 2006, SBS certified 167 new M/WBEs and recertified 187 M/WBEs. On December 31, 2006, 1,029 companies were certified as New York City M/WBEs, up from 1,017 in July 2006.

Audits of Contracts with M/WBE Subcontracting Goals

With respect to the data required by § 6-129(l)(1)(xi), as very few covered contracts are yet underway, SBS not yet had occasion to audit any contracts pursuant to § 6-129(e)(10).

Efforts to Reduce or Eliminate Barriers to Competition

With respect to the data required by § 6-129(l)(1)(xii), during the time period running from July 1-December 31, 2006, SBS assisted 6 vendors in expediting their payment requests from prime contractors. SBS has conducted agency and prime contractor training highlighting all mechanisms that have been implemented in Local Law 129 to ensure timely payments of M/WBEs from prime contractors as well as from City agencies and the enforcement of such requirements. During the time period, SBS also provided workshops to educate M/WBE construction companies on how to obtain bonding. In addition, a dedicated staff member provides individualized bond packaging assistance and refers businesses to a network of sureties and surety agents where SBS has established relationships to seek bonding.

Large-Scale Procurements

With respect to the data required by § 6-129(1)(1)(xiii), during the time period running from May 1-December 31, 2006, agencies sought and received 39 approvals pursuant to § 6-129(h)(2)(vi) from the City Chief Procurement Officer, covering procurements valued at over \$10 million.² These 39 totaled approximately \$3.2 billion in estimated value. 72% were solicited via competitive sealed bid, and 28% via requests for proposals.

Of the 39 approvals, 21 – worth approximately 82% of the total dollar value – were granted on the ground that the goods or services purchased or the construction project solicited were indivisible in nature. Another four, worth 3% of the total dollar value, were human services contracts, for which the agencies anticipated making awards to not-for-profit providers. Four, worth approximately 2% of the total dollar value, were contracts involving services at multiple sites, but it was determined that breaking them into separate, smaller contracts would not enhance opportunities and/or would not be practical or advantageous in light of such factors as costs. In each case, the determination was based upon the unusual complexity of the services required. Three others, also worth approximately 2% of the total dollar value, were requirements contracts, but it was determined that breaking them into separate, smaller contracts would not enhance opportunities and/or would not be practical or advantageous in light of such factors as costs. For two of those three, the determination was based upon the fact that the procurement was structured to result in multiple awards, a format that has been found to enhance the opportunities of smaller firms, including M/WBEs, to compete successfully for awards. Lastly, seven of the approved procurements, worth approximately 11% of the total dollar value, were for unique or unusual goods, services or construction, as to which the determination was made that using separate, smaller contracts would not enhance opportunities and/or would not be practical or advantageous in light of such factors as costs.

These determinations are summarized in the tables below.

² This approval process occurs pre-solicitation. Procurements are included in the totals reported only to the extent that the procurement was eventually solicited. Approvals relating to procurements that have not yet been publicly solicited will be listed in the reporting period that occurs subsequent to such public solicitation. NOTE: the City Chief Procurement Officer began issuing these approvals as of May 1, 2006, in order to facilitate solicitations that were ultimately issued on or after 7/1/2006.
