Part 1: Summary of Overall Regulatory Agenda

The Mayor's Office of Media and Entertainment ("MOME") intends to propose a rule that would change the fees for permits issued pursuant to Chapter 9, Title 43, of the Rules of the City of New York ("Film Permits") and amend the insurance requirements for Film Permits to be consistent with insurance required for other City permits.

MOME also intends to propose two rules relating to licensing the "Made in NY" logo, a federally registered trademark used in connection with promoting production of film, television, and theatrical productions in the City of New York and for promoting economic development in the City of New York by providing marketing and workforce development programs, all in an effort to promote digital industries in the City of New York.

- The first rule would establish a formal program that would allow film and television production companies to use the "Made in NY" logo in the marketing and credits of films and television programs. This will promote NYC as a film and television production hub and denote that films and programs were made in New York City if they have qualified production costs of at least \$50,000 in New York City.
 The second rule would establish a formal program that would
- The second rule would establish a formal program that would allow digital game creators to use the "Made in NY" logo in the marketing and credits of digital games. This will promote NYC as a center for game developers and denote that video game products were made in New York City if they have qualified costs of at least \$10,000 in New York City.

The proposed regulations are consistent with the policy objectives of the Administration because they better reflect the City's administrative and personnel costs relating to Film Permits and because they promote the film/TV and digital gaming industries in NYC.

The proposed rules were not identified through the City's Retrospective Rules Review.

Details about the proposed rules appear below.

Mayor's Office of Media and Entertainment Regulatory Agenda FY2021

A. **FEE CHANGE**

1. Description:

The Mayor's Office of Media and Entertainment ("MOME") intends to propose a rule that would increase the fees for permits issued pursuant to Chapter 9, Title 43, of the Rules of the City of New York ("Film Permits") and amend the insurance requirements for Film Permits to be consistent with insurance required for other

City permits. MOME issues Film Permits for scouting, rigging, and filming-related activity on City property.

Reason:

MOME is considering this action because its current fees do not reflect all of MOME's current administrative costs relating to Film

Since 2010, MOME has charged an administrative fee of \$300 for a project account application, which reflected only MOME's costs of processing the application and did not include other fees incurred by MOME relating to Film Permits. Under the existing system, a Film Permittee receives an unlimited number of one-day Film Permits for a particular project such as an episodic television series or a feature film without a fee for the actual permits. Under the proposed rule, permittees will pay \$500 for an unlimited number of daily Film Permits for each two-week period. The fee change both captures MOME's costs that are not reflected in the project account application fee (for example, costs for field representatives to inspect film shoots) and reflects the increase in administrative costs relating to Film Permits in the past decade. OMB approved the fee increase.

3. Summary:

- The fee would change from \$300 for a project application (and unlimited Film Permits per project) to \$500 for a two-week period of unlimited Film Permits.
- Permittees would be given the option of covering the City of New York, including its officials and employees, as an "additional insured" with a coverage form that is at least as broad as Insurance Services Office ("ISO") Form CG 20 12 (Additional Insured – State or Governmental Agency or Subdivision or Political Subdivision - Permits or Authorizations) in lieu of coverage at least as broad as that provided by ISO Form CG 20 26.
- Permittees would be required to obtain a commercial general liability insurance policy that is at least as broad as the most recently issued version of ISO Form CG 00 01, which is a commonly issued insurance policy. Permittees may maintain commercial general liability insurance on a different insurance policy form as long as the policy is at least as protective as ISO Form CG 00 01.
- The phrase "Certificate of Insurance Broker or Agent" will be modified to reflect a change in the name of the form approved by the New York State Department of Financial Services in 2015.
- Requirements for the financial strength ratings of the insurance company will be modified to reflect standard citywide requirements necessary to decrease the risk that the permittee's insurance company will lack resources to pay a claim.

4. Objectives:

- Increase MOME's fees to capture all of MOME's costs relating to Film Permits and more closely reflect the increase in MOME's costs relating to Film Permits since 2010.
- Amend the insurance requirements for Film Permits to be consistent with insurance required for other City permits.

5. Legal Basis:

MOME has authority to issue permits for filming activity pursuant to New York City Charter section 1301(1)(r) and Chapter 9 of Title 43 of the Rules of the City of New York.

Relevant Laws:

Charter section 1301(1)(r), Administrative Code section 22-205, Chapter 9 of Title 43 of the RCNY are the relevant laws; none of these duplicate, overlap or conflict with the proposed rule.

7. Individuals and entities affected:

Film production companies, television production companies, advertising/commercial production companies, commercial photographers who shoot on City streets, student filmmakers.

Approximate Schedule:

We are monitoring developments relating to the COVID-19 emergency and their impact on filming in New York City. At present, we anticipate introducing the proposed rule in the fall, but we may delay it further depending on those developments.

What are we proposing? The Department of Citywide Administrative Services ("DCAS") is proposing to modify its rule concerning the waiver of application fees for civil service examination for veterans of the armed forces of the United States.

When and where is the Hearing? A public hearing on the proposed rule will be held remotely using Webex Event Center on July 13, 2020 at 10:00 a.m. Persons who wish to attend the hearing can do so by following these instructions:

What authorizes DCAS to make this rule? Sections 1043, 811 and 814 of the City Charter and Section 15, 20 and 50 of the New York Civil Service Law authorize DCAS to make this proposed rule. This proposed rule was not included in DCAS's regulatory agenda for this Fiscal Year because it was not contemplated when DCAS published the agenda.

Where can I find the DCAS rules? The DCAS rules are in title 55 of the Rules of the City of New York.

What laws govern the rulemaking process? DCAS must meet the requirements of Section 20 of the Civil Service Law and Section 1043 of the City Charter when creating or changing rules. This notice is made according to the requirements of Section 20 of the Civil Service Law and Section 1043 of the City Charter.

Pursuant to Section 1043(d)(4) of the City Charter, this proposed rule does not require certification by the Mayor's Office of Operations and the Law Department before publication of this notice because it involves only the modification of a fee.

Statement of Basis and Purpose of Proposed Rule

Pursuant to Section 15(4) of the New York Civil Service Law and Section 811 of the City Charter, the commissioner of Citywide Administrative Services has all of the powers of a municipal civil service commission set forth in the New York Civil Service Law. Section 50(1) of the Civil Service Law provides that the merit and fitness of applicants for positions which are classified in the competitive class shall be ascertained by such examinations as may be prescribed by the municipal civil service commission. Section 50(3) provides that a municipal commission shall require prospective

applicants for competitive class positions to file a formal application in which the applicant sets forth his or her background, experience and qualifications for the position sought, and merit and fitness for the public service. Section 50(5)(a) requires every such applicant to pay an application fee to the municipal commission in an amount prescribed by that section. Section 50(5)(b) authorizes a municipal civil service commission to waive application fees for specific classes of candidates.

The Department of Citywide Administrative Services has promulgated General Examination Regulations, codified at Title 55 of the Rules of the City of New York ("R.C.N.Y."), Chapter 11, for the administration of examinations for applicants for positions classified in the competitive class. Section 11-01(c)(1) sets forth the application fees required to be paid at the time of application. The rule further provides that the application fee of a veteran of the armed services of the United States shall be waived one time. 55 R.C.N.Y. § 11-01(c)(6).

This proposed rule would amend section 11-01(c)(6) to eliminate the "once only" waiver for veterans and provide that the application fee will be waived for every examination for which a veteran may apply. The City of New York has found that military veterans are especially well-prepared by experience, training, physical fitness and discipline to provide public service. It is also the unfortunate fact that veterans often encounter difficulty integrating themselves into the economic life of the country when they leave military service. Amending the rule to waive fees on every examination for which a veteran applies will expand the pool of highly prepared candidates available for service to the City while ensuring that candidates who have honorably served our country will be able to continue to provide public service.

DCAS's authority for these rules is found in sections 15, 20 and 50 of the New York Civil Service Law and sections 1043, 811, and 814 of the New York City Charter.

Pursuant to Section 1043(d)(4) of the New York City Charter, this proposed rule does not require certification by the Mayor's Office of Operations and the Law Department before publication of this notice because it involves only the modification of a fee.

Amendment of Rule Relating to Civil Service Examination Application Fees.

Section 1. Paragraph (6) of subdivision (c) of section 11-01 of title 55 of the Rules of the City of New York, relating to application fees for civil service examinations, is amended to read as follows:

- (6) Veteran Exam Fee Waiver.
- (i) An application fee for an open-competitive or promotion civil service examination will not be required of a Veteran for taking [one such] any examination, under the conditions detailed in this paragraph.

A "Veteran," for the purposes of this paragraph, shall mean an individual who, at the time of filing his or her application for a civil service examination, (i) is a citizen of the United States or an alien lawfully admitted for permanent residence, (ii) has received an honorable discharged or who has been released under honorable conditions from the Armed Forces of the United States, and (iii) has served on full-time active duty, other than active duty for training. The "Armed Forces of the United States" shall mean the United States Army, Navy, Marine Corps, Air Force, and Coast Guard, including all components thereof, and the National Guard when in the service of the United States pursuant to call as provided by Law.

The Veteran Exam Fee Waiver can be used [once] by a Veteran to waive the application fee for [an] <u>any</u> open-competitive or promotion civil service examination offered by the Department of Citywide Administrative Services or offered by any other agency or entity pursuant to a delegation from the Department.

(ii) Process for Requesting the Veteran Exam Fee Waiver. To request the Veteran Exam Fee Waiver, an applicant must submit a photocopy of his or her U.S. Armed Forces separation papers (DD214 long form) in the manner and at the time detailed on the Fee Waiver Request Form, available at Application Centers and at the website of the Department of Citywide Administrative Services at www.nyc.gov/dcas.
