BOARD OF REVISION AND CORRECTION OF ASSESSMENTS.

A meeting of the Board of Revision and Correction of Assessments was held at the Comptroller's office on Friday, July 29, 1887, at 2 o'clock P. M.
Present—Edward V. Loew, Comptroller; Morgan J. O'Brien, Counsel to the Corporation; Frederick Smyth, Recorder.

On motion, the reading of the minutes of meeting of July 19, 1887, was dispensed with.
The Comptroller presented petitions of Louis Seiferd, Henry Fischer, Bernard Hamberger, Henry Cramer and others, for the vacation of the assessments for paving the several parts of Fourth avenue, filed by John F. Kavanagh, attorney, on July 26, 1887.

The assessments for paving different parts of Fourth avenue, referred to in the act, chapter 511, Laws of 1887, presented at the last meeting of the Board, were taken up for further consideration.

The question of reducing the assessments, as provided by said act, was considered, and all the points involved were examined and the amount and proportion of reductions which should be made were decided upon.

The form of the certificate to be given to the Comptroller pursuant to the law, determining the "amount or proportion of the expenses incurred by the Mayor, Aldermen and Commonalty of the City of New York, for such paving, which should fairly and equitably have been assessed upon the persons and property that have been assessed therefor"—was decided upon, and the following certificate upon motion, was adopted, all the members of the Board voting therefor, and executing the same, to wit:

"CERTIFICATE.

The Board of Revision and Correction of Assessments, in pursuance of the provisions of chapter 511 of the Laws of 1887, entitled 'An act in relation to the expense of the paving of certain parts of Fourth avenue, in the City of New York,' have reconsidered, on the merits, the assessments heretofore imposed for the paving of Fourth avenue, from Seventy-second to Ninety-sixth streets, from One Hundred and Second to One Hundred and Sixteenth streets, from One Hundred and Sixteenth to One Hundred and Twenty-fourth streets, and from One Hundred and Twenty-fourth street to One Hundred and Thirty-third street, on the west side, and to One Hundred and Thirty-second street on the east side of said Fourth avenue, in the City of New York, and upon the proofs submitted, have determined what amount or proportion of the expenses incurred by the Mayor, Aldermen and Commonalty of said city, for such paving should fairly and equitably have been assessed upon the persons and property that have been assessed therefor, taking into consideration, for that purpose, the public uses of said Fourth avenue, the bisection or intersection thereof by cross streets, the grade of the avenue, the condition and slant of the pavement, the enhanced cost of the paving by reason of the concrete foundation thereunder, and all the facts and circumstances which in their judgment shall fairly and equitably be considered in determining what proportion of the expense of such work should be borne by such persons or property; and the Board of Revision and Correction of Assessments having so reconsidered and revised such assessments do hereby, this twenty-ninth day of July, 1887, certify to the Comptroller of the City of New York, as prescribed by said act, that we have determined and do hereby determine that the amount and proportion of the cost of said works, which should be the fair and equitable proportion thereof assessed upon such persons or property, is set forth in the following statement, showing the expense of each contract for said work and the reduced amounts which should fairly and equitably be borne by the persons and property therefor, to wit:

Paving Fourth avenue, from Seventy-second to Ninety-sixth street, with granite-block pavement and concrete foundation. Confirmed by operation of law on July 18, 1885, and title ordered to be entered in Bureau for Collection of Assessments, etc., January 14, 1887—

The Comptroller presented the following assessment lists received from the Board of Assessors under date of July 21, 1887, viz.:
Sewer and appurtenances in Westchester avenue, from Brook to St. Ann's avenue, with branches in St. Ann's avenue, between the Port Morris Branch Railroad and Carr street.
Sewer and appurtenances in One Hundred and Seventieth street, between North Third and Franklin avenues, with a branch in Fulton avenue, between One Hundred and Seventieth and One Hundred and Sixty-ninth streets.

The foregoing assessment lists being in proper form and no objection having been filed, on motion, the same were severally confirmed, all the members of the Board voting in the affirmative. At 2.35 o'clock P. M., on motion, the Board adjourned.

AQUEDUCT COMMISSION.

Minutes of Stated Meeting of the Aqueduct Commissioners, held at their office, No. 209 Stewart Building, on Wednesday, July 6, 1887, at 2 o'clock P. M.

Present—Commissioners Spencer, Dowd, the Commissioner of Public Works, and Commissioners Baldwin, Barnes, Ridgway, and Fish.

Also, Acting Chief Engineer Fteley, and Chief Engineer Birdsall of the Department of Public Works.

The minutes of the stated meeting of June 29th, and of the adjourned special meeting of July 5th, were read and approved.

The Committee of Finance and Audit reported their examination and audit of bills contained in Vouchers Nos. 2777 to 2789, inclusive; and on motion of Commissioner Dowd the same were approved and ordered certified to the Comptroller for payment.

Also recommended the adoption of the following resolution:

"Resolved, That the Committee of Finance and Audit are hereby authorized and empowered to audit and certify to the Comptroller, vouchers, estimates and pay-rolls during the adjournment of the Commissioners, and after the same have been certified to by a majority of the Commissioners, transmit the same to the Comptroller for payment."

Adopted.

Also, presented a communication from Alfred Craven, Division Engineer on the Third Division, asking for a buggy and single harness for use on that division, which was approved by the Chief Engineer, and in connection therewith Commissioner Dowd offered the following resolution:

"Resolved, That the Purveyor be directed to purchase a buggy for the use of Division Engineer Craven, on the Third Division, subject to the approval of the Committee of Finance and Audit."

Adopted.

The Committee on Construction, by its Chairman, Oliver W. Barnes, submitted the following report:

"The Committee on Construction respectfully recommend that when the Commissioners adjourn they adjourn to the first Wednesday in August next, at 1 o'clock P. M., unless sooner called together."

The report of the committee was adopted.

Also, submitted the following report:

"The Committee on Construction respectfully report that they have had under consideration a communication from the Secretary of the Civil Service Commission, referred to them by you on the 1st instant, certifying the names of eleven persons standing highest on their eligible list of Rodmen, from which selections may be made, and recommended that Edward A. Byrne be appointed Rodman; and with regard to the remainder of the eligible list, the Committee will report upon later."

The action of the committee was approved and the report adopted.

The Committee on Real Estate, by its Chairman, James C. Spencer, submitted the following report:

"Pursuant to your resolution of May 11, 1887, this committee has reached an adjustment with the Board of Supervisors of the town of Mount Pleasant for the taxes of 1885 and 1886, upon lands taken in fee for the New Aqueduct in said town; by which adjustment the valuation is reduced from \$350 per acre to \$100 per acre on lands at Shaft Sites Nos. 7 and 8, and to \$150 per acre for lands at Shaft Site No. 9, payment of taxes being accepted by said Board in full settlement at those rates without interest, and this committee have caused to be prepared vouchers for the payment of the same, which are now presented for your certification."

Adopted.

Commissioner Ridgway then moved that the Commissioners adjourn, which was lost by the following vote:

Affirmative—Commissioners Barnes, Ridgway and Fish—3.

Negative—Commissioners Spencer, Dowd, the Commissioner of Public Works, and Commissioner Baldwin—4.

Commissioner Baldwin then moved that the report of the Special Committee appointed on May 11th be taken up and considered.

Carried.

Commissioner Newton, from the said Special Committee, then presented the following report:

"NEW YORK, May 25, 1887."

"The Committee appointed by the following resolution:

"Whereas, The by-laws of this Commission provide for the office of Deputy Chief Engineer; therefore

"Resolved, That a committee of three be appointed by the President to take the matter into consideration, and report to the Commissioners the name of a suitable person or persons for appointment to the position of Deputy Chief Engineer; and said Committee shall also report to the Commission any facts or views pertaining to the subject matter that they may deem important in the premises; and said committee shall report at the meeting of the Commissioners on the 25th instant.

—have the honor to report, that a meeting was held at the office of the Commissioner of Public Works at 1 P. M. on the 19th instant; and, on motion of Mr. Dowd, it was

"Resolved, That the appointment of a Deputy Chief Engineer was necessary, and that the committee report the names of Captain Thomas W. Symons, Corps of Engineers, and of George S. Rice, Esq., C. E., to the Commissioners, as candidates for that office."

Commissioner Newton then moved that the Commissioners proceed to the election of a Deputy Chief Engineer by ballot.

Commissioner Fish moved to amend by making such selection by a viva voce vote of the Commissioners.

Carried.

Commissioner Ridgway opposed the appointment of a Deputy Chief Engineer, and said:

"I wish to say that I believe from looking into the facts and the progress of the work now being completed—there being ninety per cent. of the excavation finished—that this is the most outrageous piece of unnecessary expenditure that the Commission can be guilty of."

Commissioner Newton, in reply, said:

"I wish to say that it was a great misfortune that a Deputy Chief Engineer had not been appointed nine months ago. There is a difference of opinion in this Commission on very important matters, and I wish to say that it is necessary to strengthen our engineering force by having men of reputation upon it—men that can stand up to their opinions. As to the finished work, why only a little part of it has been done. We have almost all the lining to do; all the reservoirs to build. We have, from this time out, the interpretation of the contracts to go through, and those are matters on which we want the advice of practical men."

Commissioner Ridgway, replying to Commissioner Newton, said:

"The matter of excavation is over ninety per cent. completed. The matter of brick lining is certainly not one that requires a Deputy Chief Engineer. I would like to hear what Commissioner Barnes has to say on the subject."

Commissioner Barnes said:

"I have recently been over the line of the Aqueduct, and I believe it is not advisable at this time to appoint a Deputy Chief Engineer. The questions that General Newton has alluded to—with regard to the construction of the contracts, etc.—are, by the terms of the contracts, reposed with the Chief Engineer. The Deputy Chief Engineer cannot, under any circumstances, have anything to do with the decision of any question that may arise between the contractors and the Chief Engineer or the Commissioners. I think that the business of the Commission can very readily be carried on until next fall without the appointment of any additional officer."

Commissioner Newton, in reply, said:

"I would suppose that the matter of the interpretation of the contracts is one upon which the Chief Engineer would ask the advice of competent men if he had them around him. But I want you to understand that I don't dispute the Chief Engineer's own ability, but it is a narrow path that he has to walk on."

Commissioner Barnes said:

"We have now, in Mr. Fteley, a man fully competent to advise the Chief Engineer upon any subject that may arise."

Commissioner Newton then nominated George S. Rice, civil engineer, for the position of Deputy Chief Engineer, and moved that he be selected for such position; and the selection was made by the following vote:

Affirmative—Commissioners Spencer, Dowd, the Commissioner of Public Works and Commissioner Baldwin—4.

Negative—Commissioners Barnes, Ridgway and Fish—3.

Whereupon the President announced that George S. Rice was duly elected Deputy Chief Engineer of the Aqueduct Commissioners.

Commissioner Dowd then moved that the salary of Mr. Rice be fixed at \$7,000 per annum, and that in addition to the duties of Deputy Chief Engineer, he also perform the duties of Principal Assistant Engineer of the Southern District of the New Croton Aqueduct.

Commissioner Ridgway moved to amend by fixing the salary at \$5,000 per annum, which amendment was lost by the following vote:

Affirmative—Commissioners Barnes, Ridgway, and Fish—3.

Negative—Commissioners Spencer, Dowd, the Commissioner of Public Works, and Commissioner Baldwin—4.

Commissioner Barnes then moved, as a further amendment, that the salary be fixed at \$6,000 per annum, and the amendment was lost by the following vote:

Affirmative—Commissioners Barnes, Ridgway, and Fish—3.

Negative—Commissioners Spencer, Dowd, the Commissioner of Public Works, and Commissioner Baldwin—4.

The original motion was then carried by the following vote:

Affirmative—Commissioners Spencer, Dowd, the Commissioner of Public Works, and Commissioner Baldwin—4.

Negative—Commissioners Barnes, Ridgway, and Fish—3.

The Commissioners then adjourned.

The Chief Engineer, under date of July 20, 1887, reported that the soft ground found in the trial heading under the Harlem river, rendered it necessary to make thorough explorations with the diamond drill, both from within the heading and from the surface of the river, and also presented a certificate showing the necessity for doing said work.

The report and certificate were ordered filed and the action of the Chief Engineer approved.

A communication was received from A. A. Aguirre, asking for an extension of his leave of absence without pay until September 1st.

On motion of Commissioner Barnes, the leave of absence was granted.

The Commissioners then adjourned.

PUBLIC NOTICE AS TO WATER RATES.

PUBLIC NOTICE IS HEREBY GIVEN THAT in compliance with the provisions of chapter 559, Laws of 1887, amending sections 350 and 921 of the New York City Consolidation Act of 1882, passed June 9, 1887, the following changes are made in charging and collecting water rents:

1st. All extra charges for water incurred from and after June 9, 1887, shall be treated, collected and returned in arrears in the same manner as regular rents have heretofore been treated.

2d. In every building where a water meter or meters are now, or shall hereafter be in use, the charge for water by meter measurement shall be the only charge against such building, or such part thereof as is supplied through meter.

3d. The returns of arrears of water rents, including the year 1887, shall be made as heretofore on the confirmation of the tax levy by the Board of Aldermen, and shall include all charges and penalties of every nature.

4th. A penalty of five dollars (\$5) is hereby established, and will be imposed in each and every case where the rules and regulations of the Department prohibiting the use of water through hose, or in any other wasteful manner, are violated, and such penalties will be entered on the books of the Bureau against the respective buildings or property, and, if not collected, be returned in arrears in like manner as other charges for water.

5th. Charges for so-called extra water rents of every nature, imposed or incurred prior to June 9, 1887, will be canceled of record on the books of the Department.

NOTICE TO CROTON WATER CONSUMERS.

NUMEROUS APPLICATIONS HAVE BEEN made to this Department by citizens claiming reductions or rebates on bills for water supplied through meters, on the alleged ground of leakage caused by defective plumbing and worn-out service pipes, or by willful waste of water by tenants allowing the faucets to be turned on in full force in water-closets, sinks, etc., without the knowledge or consent of the owners of the premises.

The main object of the use of water-meters is to enable this Department to detect and check the useless and unwarrantable waste of an element so valuable and essential to the health and comfort of all the citizens, and this object can only be accomplished by enforcing payment for the water wasted.

Under the law all charges for water supplied through meters are a lien against the respective premises, and the law therefore holds the owner of the premises responsible for the amount of water used or wasted.

Notice is therefore given to all householders that, in all further applications for reduction of water rents, no allowance will be made on account of waste of water occurring through leaks, from defective service pipes or plumbing, or wasteful use of water by tenants or occupants of buildings, though such leakage or waste may have occurred without the knowledge or consent of the owners of the buildings.

House-owners are further notified that whenever their premises become vacant, and are likely to remain vacant, they must notify this Department in writing, and that unless this requirement is complied with no deductions in extra water rents will be allowed for any portion of one year.
