#### TOPOGRAPHICAL BUREAU.

##### Work Done by the Field Force.

Running accurate traverses in the villages of Whitestone, Corona, Jamaica and Rockaway to be used in the mapping of these sections, and burying sufficient monuments to define the lines for a permanent layout of the same.

Making a topographical survey with plane table, transit and level of the territory east of Hollis, between Queens and Springfield; of the territory between Floral Park and Creedmoor and of the territory in the vicinity of Douglaston.

Obtaining street levels in the vicinity of Jamaica, preparatory to fixing grades. Testing of benches, establishing new benches, running levels for various purposes, accurate chaining between triangulation stations, additional triangulation on which to base the plane-table work.

Establishing lines of streets and planting street monuments in accordance with and in the territory included by the maps showing street systems and grades as follows:

Maps of Second Ward approved by Board of Estimate and Apportionment November 13, 1903.

Maps of Second Ward approved by Board of Estimate and Apportionment December 29, 1905.

Maps of Second Ward approved by Board of Estimate and Apportionment March 31, 1905.

Map of the Fourth Ward approved by Board of Estimate and Apportionment December 15, 1905.

The above area is entirely monumented and the final traverses run for computing the block lengths and angles of a final map for these sections.

Monumenting the remainder of the Second Ward is well under way.

Re-establishing monument points in Long Island City.

Taking tide-gauge observations at Hook creek.

Making damage surveys in the First Ward, of Hallett, Howland and Goodrich streets; in the Second Ward, of Palmetto street, Garrison avenue, Decatur street, Summerfield street, Willow street, Center street, Stephen street, Norman street, George street, Nurge street and William street.

Inspecting streets for reports as to legal status and on improvement petitions.

#### Work Done by the Office Force.

Tracing 200-foot sheets for blue printing.

Preparing plane table sheets with range lines and traverse points for field work.

Miscellaneous draughting and tracing in connection with the general studies; indexing maps and field books.

Completing the map of the Second Ward by showing on two black prints the changes in grades and lines of such facts as had been previously adopted.

Making a new map of the portion of the Fourth Ward lying between Liberty avenue and Jamaica bay, west of Van Wyck avenue, showing a system of streets and grades.

Indexing the street names of the new map of the Second Ward.

Preparing three copies of each of nine final maps of the Maspeth section.

Making three copies of each of twenty-two assessment maps, with the accompanying assessment lists.

Filing and indexing the copies of maps made at the County Clerk's office at Jamaica.

Copying ninety filed maps at Jamaica.
