In the Islamic religion, Ramadan is a holy month of fasting, introspection and prayer. This year Ramadan starts on May 27<sup>th</sup> and ends on June 25<sup>th</sup>.

Fasting is one of the five fundamental principles of Islam. Each day during Ramadan, followers of Islam do not eat or drink from sunrise to sunset. Muslims break their daily fasts by sharing meals with family and friends.

The end of Ramadan is celebrated with a three-day

festival known as Id al-Fitr (The Feast of Fast-Breaking) which occurs on June 26<sup>th</sup>, 2017. #### **EXECUTIVE ORDER 21**



**Restrictions of Inquiries** Regarding Pay History

In an effort to promote pay equity, on November 4, 2016, Mayor DiBlasio signed Executive order 21. This order prohibits all NYC Agencies from

inquiring about a job applicant's salary history before extending a conditional offer of employment.

#### **EXECUTIVE ORDER 16**

Access to Single-Sex City Facilities Consistent with Gender Identity and Expression.

On March 7, 2016, Mayor Bill DiBlasio signed Executive Order 16, which ensures that transgender and gender non-conforming individuals can access single-sex facilities consistent with their gender identity and expression. Since this date the EEO Office at DEP has been diligently training supervisors and managers upstate and downstate. In the upcoming months we will be training our frontline employees.
